Roadshow on the Implementation of the Forests (Trained Wo

STA Training Sdn Bhd (STAT) in collaboration with SARAWAK FORESTRY Corporation Sdn Bhd (SFC) organised a series of roadshows on the "Implementation of the Forests (Trained Workmen) Rules, 2015" which were held as follows:

- 26 April 2017 at the Imperial Hotel, Miri
- 27 April 2017 at the Promenade Hotel, Bintulu
- 28 April 2017 at Tanahmas Hotel, Sibu

A total of 173 participants from the timber industry and forestry-related agencies attended this Roadshow.

Tuan Haji Zolkipli Mohd Aton, Acting General Manager, Strategic Planning and Special Project Division of SFC welcomed all participants to the briefing. According to him, the objectives of the briefing were to inform the timber industry on:

- The Forests (Trained Workmen) Rules, 2015 (The Rules) which came into force since 1 July 2015 is to regulate compliance with Section 51(1) of The Forest Ordinance, 2015 (Sarawak Cap 71), which requires all forestry companies (as employers) to hire only properly trained workmen to carry out forestry activities;
- Under The Rules, all workmen in the prescribed forestry activities namely; (i) Certificate in Tree Felling, (ii) Certificate in Log Extraction, (iii) Certificate in Log Loading, (iv) Certificate in Clear-fell Site Preparation and (v) Certificate in Mechanical Site Preparation are required to be trained and certified; and
- 3. The roles and responsibilities of STAT as a Training Provider and SFC as an Agent.

Dr Peter Kho, Manager of STAT gave a brief introduction on the background of skills training as well as the appointment of STAT as Training Provider. He further stressed that the roles and responsibilities as Training Provider is to provide training to all workmen in the prescribed forestry activities. In his presentation, he emphasised on the importance of skills training, training courses offered as well as how skills training and assessments are carried out. He further highlighted that the training coordinator plays an important role in ensuring training and assessing programmes are carried out effectively with minimal disruption to forestry operations.

Tuan Haji Zolkipli Mohd Aton gave a brief update on the requirement of The Rules, the responsibilities of the timber licensees or contractors as well as SFC's roles and responsibilities as an Agent. He also highlighted the consequences of non-compliance *(employer and workman)* under the Forest Ordinance, 2015 and The Rules, 2015. He then presented the standard operating procedures for the monitoring of compliance for both employers and workmen.

Participants of the Briefings are urged to fully understand and be aware of the requirements of Section 51(1) of The Forests Ordinance, 2015 and The Rules. For those

The Chairman of STA Forest Plantation Committee, Mr Peter Ling Kwong Hung convened the STA Forest Plantation Committee Meeting No 2/2017 on 21 April 2017 at Wisma STA, Kuching.

The Meeting discussed a few matters/issues; namely weight to volume conversion factor study of various planted species, *Ceratocystis* study on *Acacia mangium*, conventional drying study on *Acacia*, field visit to members' forest plantations and etc. The Meeting also deliberated on the proposal as well as the terms and conditions of the Memorandum of Understanding (MOU) of the newly approved *Falcataria moluccana* research project.

The Meeting was informed of a few decisions made by the Chief Minister of Sarawak during the courtesy call held on 9 March 2017, in which the Chief Minister of Sarawak strongly emphasised on strengthening the Research and Development (R&D) in forest plantation and has agreed to consider to waive the royalty and cess for trees harvested from forest plantations provided that the waived sum is used for R&D purposes.

The Meeting was also updated with the progress of the two (2) R&D projects funded by Sarawak Timber Association (STA), i.e. SNP Discovery Research by Universiti Malaysia Sarawak (UNIMAS) and Biofertiliser Formulation Research by Swinburne University of Technology Sarawak Campus (SUTS).

April 2017 at One World Hotel, Bandar Utama, Selangor. The Meeting was chaired by its President, Dato' Low Kian Chuan.

Eight (8) out of nine (9) EXCO members attended the meeting together with their supporting Secretariat staff. Members were updated on the current assets of MTA, membership fees and placement of fixed deposits.

Mr Tham Sing Khaw, Advisor/Coordinator - Timber Task Forces, Timber Industry Forum presented the Executive Summary on MTA Timber Workshop 2016 to the members of the Meeting. The Meeting resolved for the President of MTA to lead a delegation of its members to present the Executive Summary together with recommendations/way forward for the MTA Timber Workshop 2016 to the Minister of Plantation Industries and Commodities (MPIC), Datuk Seri Mah Siew Keong.

The Meeting has also tentatively fixed its Annual General Meeting to be held in Sabah on the 4th week of June 2017.

The Malaysia Marketing

In conjunction with its 25th anniversary celebration, the Malaysian Timber Council (MTC) organised the Marketing Seminar 2017 with the theme "Global Timber Market Outlook and Export Opportunities for Malaysian Timber Products and Furniture" on 18 April 2017 at Hotel InterContinental, Kuala Lumpur.

The opening speech by the Minister of the Ministry of Plantation Industries and Commodities (MPIC), Malaysia, which was read by Datuk Datu Nasrun Datu Mansur, the Deputy Minister of MPIC, highlighted that timber and timber products constitute the country's third most important commodity and commodity-based products exported, after palm oil and rubber. They accounted for 17.92% of the total export earnings of the commodity sector and 2.78% of the country's total export earnings.

The Minister urged members of the timber industry to increase their exports to cover the bilateral and regional Free Trade Agreement (FTA) markets which Malaysia has established, and leverage on prospective markets such as China, India and the ASEAN countries.

The Seminar gathered relevant industry speakers from China, Europe, India, South Africa, the Philippines and the United States to share their experiences as well as insights on global timber market outlook. One speaker from Singapore shared with the participants of the Seminar her knowledge on global economic scenarios. The Seminar also served as a platform for participants to network, share ideas and experiences in these markets.

About 170 participants attended the Seminar and majority of the participants were from the industry in Peninsular. Also present at the Seminar was Datuk Dr Abdul Rahim, MTC Chief Executive Officer, who chaired the plenary session together with seven (7) speakers.

After the one-day Seminar, clinic sessions were held at MTC office in

Meeting with KPA on Port Tariff on Timber Products

A meeting between Kuching Port Authority (KPA) headed by its General Manager, Mr Robert Lau and Sarawak Timber Association (STA) was held on 28 April 2017 at KPA Head Office, Kuching. Mr Nobel Pang, Managing Director of KPA Port Sdn Bhd, an associate company of KPA was also present in the Meeting.

During the Meeting, Mr Robert Lau explained that the port tariff has never been increased since 1984. The port tariff charge on timber products for Receiving, Sorting and Delivery (RS&D) is statutorily fixed at RM9.00 per tonne/cubic metre. However, the RS&D charge of RM1.00 per tonne/cubic metre was agreed after negotiation between KPA and STA back then.

Effective 1 April 2017, the RS&D charge on timber products shall be RM5.00 per tonne/cubic metre in view of the following value-added services provided by KPA Port Sdn Bhd:-

- · Receiving the timber products from the lorries
- Storing the timber products in an orderly manner in the warehouse at the port
- Loading the timber products onto ships for export at a later date

KPA Port Sdn Bhd ensures members of STA who are also shippers, they will enjoy the following benefits:-

- 1. Fixed port charges;
- Cost savings as the shippers no longer need to look for their own contractors for off-loading cargo from the lorries or stevedoring services at the port and bear the private contractors' charges which may vary from time to time;
- 3. Minimise damages to the timber products during handling;
- 4. Efficient loading of the timber products onto the ships/vessels resulting in shorter stay of the ships/vessels at the port;
- 5. Minimise the risk of incurring additional demurrage charges; and
- 6. Minimise the risk of the cargo being shipped to un-designated port.

The current RS&D charge of RM5.00 per tonne/cubic metre shall gradually increase to the statutory rate of RM9.00 per tonne/cubic metre. It was mutually agreed in the Meeting that there will be prior consultations before any future increment in the RS&D charge on timber be implemented.

刘先生在会议中解释自1984年起港口关税保持不变。木材产品的接收,分拣和配送(RS&D) 港口关税法定在每吨或每立方米为马币9令吉。 然而,RS&D收费每吨或每立方米马币1令吉是当时本会与KPA开会洽商后所达成共识。

自2017年4月1日起,木材产品的RS&D收费每吨或每立方米为马币5令 吉。这包含KPA 港口有限公司所提供的额外服务。

现有的RS&D收费将逐步提升至每吨或每立方米马币9令吉。双方在会议中也承诺未来在执行任何港口关税增加课题上,将会进行事先磋商。

Satu mesyuarat di antara Lembaga Pelabuhan Kuching (KPA) yang diketuai oleh Pengurus Besar, En Robert Lau dan Persatuan Kayu Kayan Sarawak (STA) telah diadakan pada 28 April 2017 di Ibu Pejabat KPA, Kuching.

En Robert Lau menjelaskan bahawa tarif pelabuhan tidak pernah dinaikkan sejak 1984. Caj tarif pelabuhan pada produk kayu untuk Menerima, Menyusun dan Pelaksanaan (RS&D) adalah mengikut undang-undang yang ditetapkan pada RM9.00 setiap tan/meter padu. Walau bagaimanapun, caj RS&D RM1.00 per tan/meter padu telah dipersetujui selepas rundingan antara KPA dan STA ketika itu.

Berkuat kuasa 1 April 2017, caj RS&D produk kayu ditetapkan pada RM5.00 per tan/meter padu memandangkan perkhidmatan nilai tambah yang disediakan oleh KPA Port Sdn Bhd.

Caj semasa RS&D RM5.00 per tan/meter padu akan meningkat secara beransur kepada kadar berkanun iaitu RM9.00 per tan/meter padu. Ia telah dipersetujui dalam Mesyuarat bahawa rundingan akan diadakan terlebih dahulu sebelum pelaksanaan apa-apa kenaikan tarif pelabuhan pada masa depan.

Verification of the Weight to Volume Conversion Constant of *Albizia falcataria*

A trip to verify the weight to volume conversion constant for *Albizia falcataria* was organised by Sarawak Forestry Corporation (SFC) and Sarawak Timber Association (STA) from 17 to 20 April 2017 and was conducted in LPF0017 Kejin Plantation near Miri and LPF0018 Seping Plantation near Bintulu.

This study was initiated upon receiving requests from members to validate the weight to volume conversion constant of *Albizia falcataria* as they found that the conversion constant calculated by them, varied significantly from the conversion constant [2 cubic meters:1 metric ton] that was approved by the Forest Department Sarawak (FDS) in 2012 through the DF Circular No 2/2012. This study involved the representatives from SFC, FDS and Shin Yang Forestry Sdn Bhd and STA.

The diameters, length and weight of thirty (30) *Albizia falcataria* planted logs felled at each sampling site were measured and recorded. Disc samples were collected at middle and both ends from the six (6) randomly selected logs and kept in plastic bags with proper labelling. The disc samples will be tested in Timber Technology Centre (TTC), Applied Forest Science and Industry Development Division (AFSID) of SFC to further verify the weight to volume ratio of *Albizia falcataria*.

State Task Force of Illegal Logging Meeting No 1/2017

The State Task Force of Illegal Logging Meeting No 1/2017 was held on 21 April 2017 at Wisma Sumber Alam, Kuching. The Meeting chaired by Datuk Amar Haji Awang Tengah Bin Ali Hasan, Minister of Resources Planning and Environment II (now the Ministry of Urban Development and Natural Resources) was attended by members of the Committee including the representatives from the timber industry.

In his opening remarks, Datuk Amar stressed on the importance of promoting the Sarawak Timber Legality Verification System (STLVS) and forest management

certification to buyers our timber and timber products. He urged the relevant forestry agencies and the timber industry to work together and to discuss and review the current policies in order for the timber industry to remain competitive in the market.

The Meeting then went through the minutes of the previous meeting and discussed on the arising matters. Three (3) presentations were also delivered at the Meeting as follows:



- by Tuan Haji Sapuan Ahmad, Director of Forests Sarawak

The speaker shared with the Meeting the statistics and activities of ground as well as river enforcements by Forest Department Sarawak.

2. Report on the Effectiveness of the One Stop Compliance Centre (OSCC)

 by Mr Wong Ting Chung, Chief Executive Officer, SARAWAK FORESTRY Corporation Sdn Bhd

The speaker informed the Meeting that 48 OSCCs have been established and are fully operational throughout the State. He shared with the Meeting the OSCC activities and the results on revenue collection, detection of noncompliance and campaign against illegal logging.

3. Briefing on the Timber Enforcement, Administrative and Management System (TEAMS) Project

 by Mr David Yeo, Sarawak Information Systems Sdn Bhd (SAINS)

The speaker spoke about the use of modern technology that can be used for combating illegal logging such as drone and introduced Radio-frequency identification (RFID) for forest asset tagging.

REDD+ National Strategy Workshop in

The Ministry of Natural Resources and Environment (NRE) organised a REDD+ National Strategy Workshop in Sarawak on 18 April 2017 at Hilton Hotel, Kuching. Approximately forty (40) participants from various State government agencies, civil society organizations (CSOs) and non-governmental organizations (NGOs) attended the Workshop aimed to identify action plans to be undertaken by the State as well as the role of NGO and CSO in REDD+ implementation and examples of benefit sharing system practiced in the State.

Dato' Sr Dr Azimuddin bin Bahari, Deputy Secretary-General (Environmental Management) of Ministry of NRE, in his opening speech urged various stakeholders to work together to outline actions that would help maintain Malaysia's pledge to the world which is to keep at least 50% of its land mass forested. Development of such strategy is deemed vital as it will not only enhance Malaysia's involvement in REDD+ but also provide resultbased payment for the country.

Five (5) presentations were delivered in the Workshop as follows:

1. (i) National Policy on Climate Change, and (ii) The Paris Agreement and Malaysia's INDC

- by Mr Yusmazy bin Mohd Yusup, Principal Assistant Secretary, Environmental Management and Climate Change Division, NRE

The speaker shared with the participants of the Workshop that the national policy is set up to mainstream climate change, integrate responses into national policies and strengthen the institutional and implementation capacity.

The speaker also mentioned that the Prime Minister announced in 2009 at COP15 Copenhagen that Malaysia has adopted a voluntary indicator to reduce its greenhouse gas (GHG) intensity of GDP by up to 40% by 2020 relative to emissions intensity of GDP in 2005, fully conditional upon receipt of climate finance, technology transfer and capacity building from developed countries. Building on this, the Prime Minister announced during the United Nations Climate Summit in 2014 that Malaysia was well on track to hit a 40% reduction on GHG by 2020.

He also informed the participants of the Workshop that the National Policy on Climate Change is one of the policies that formed the basis for the development of Malaysia's Intended Nationally Determined Contributions (INDCs), owing to the mutually supportive and balanced mitigation and adaptation initiatives stipulated in the Policy.

2. Draft of Sarawak's Forestry Policy

- by Mr Abang Ahmad Abang Morni, Assistant Director, Forest Management & Planning Division, Forest Department Sarawak

Participants of the Workshop were given to understand that the Department has formed a Task Force to review and re-evaluate the Statement of Forest Policy, 1954 as well as to propose a new forestry policy for the State. The review process for current forestry issues and development is still ongoing but delayed by the various policy changes introduced in the past couple of years.

3. National Biological Diversity Policy

- by Ms Chitra Subramaniam, Principal Assistant Secretary, Biodiversity Management and Forestry Division, NRE

The speaker gave a brief presentation on the National Biological Diversity Policy with an implementation period of ten (10) years; from 2016 to 2025. The policy, which is a revised version of the National Policy on Biological outlines five (5) key principles on Diversity 1998, biodiversity management namely heritage, precautionary, shared responsibility, participatory and good governance.

4. REDD+ Implementation in Malaysia

- by Dr Elizabeth Philip, Head of REDD Unit, Ministry of NRE

The speaker shared with participants of the Workshop that forestry sector contributed to the highest GHG reduction in the country. Therefore, state level efforts directed towards protecting and reducing carbon dioxide (CO2) emission will need to be gathered for the purpose of receiving incentives from developed countries. This is in line with the goal of transforming forest as a natural capital by 2030.

Participants of the Workshop were then divided into two (2) groups; State Government group and NGO/CSO group to discuss on the REDD+ action plans. In closing, the Secretariat informed participants of the Workshop that a draft REDD+ National Strategy, which takes into account all the inputs received from participants of Workshops conducted in the three (3) regions in Malaysia, will be circulated to all for comments. A final consultation will be held in the last week of May 2017 to produce Malaysia's REDD+ National Strategy which will be submitted to United Nations Framework Convention on Climate Change (UNFCCC) to obtain and receive results-based payments.

Bengkel bertujuan untuk mengenal pasti pelan tindakan yang akan dilaksanakan oleh Kerajaan Negeri serta peranan NGO dan CSO dalam pelaksanaan REDD+ dan contoh sistem perkongsian faedah yang diamalkan di negeri ini.

Dato' Sr Dr Azimuddin bin Bahari, Timbalan Ketua Setiausaha (Pengurusan Alam Sekitar) Kementerian NRE, dalam ucapan perasmian menggesa pelbagai pihak berkepentingan bekerjasama untuk menggariskan tindakan yang akan membantu mengekalkan ikrar Malaysia kepada dunia dalam mengekalkan sekurang-kurangnya 50% daripada tanahnya diliputi hutan. Pembangunan strategi itu adalah sangat penting kerana ia bukan sahaja akan meningkatkan penglibatan Malaysia dalam REDD+tetapi juga menyediakan pembayaran berasaskan pencapaian negara.

Technical Committee for Research on Ceratocystis in Acacia mangium

The Technical Committee Meeting for Research on *Ceratocystis* in *Acacia mangium* No 1/2017 was chaired by Tuan Haji Kamaruzaman Othman, Director of Forest Plantation, Malaysia Timber Industry Board (MTIB) on 12 April 2017 at Menara PGRM, Kuala Lumpur. The Meeting was attended by nineteen (19) representatives from relevant State and Federal forestry agencies, forest plantation companies, Timber Associations and support staff from MTIB.

The Meeting was briefed on details of the three (3) components of the 2-year study; (i) Management of Ceratocystis (ii) Genetic Research and (iii) Wood Properties Research. The study will focus on biological and ecological aspects and the impact of Ceratocystis in Acacia mangium to develop strategies for its control. Members present at the meeting were of the opinion that the proposed wood properties study on 7-year old infected Acacia mangium trees should be not be included as this project is aimed at eliminating / mitigating Ceratocystis in Acacia mangium.

Official Launch of the Conservation Internship Programme for Forest Management Certification

SARAWAK **FORESTRY** Corporation's (SFC's) Conservation Internship Programme (CIP) for Forest Management Certification which rides on the platform for Research for Intensified Management of Bio-rich Areas (RIMBA) Sarawak was launched by Mr Wong Chung, its Chief Executive Officer on 3 April 2017.

In his opening address to the fifteen (15) interns, Mr Wong said that the Programme's primary objective is to train

new graduates in forest conservation and social forestry who, upon completion of the programme, can take the lead to set up conservation department in Forest Management Unit (FMU) undergoing forest management certification. These trained personnel are also expected to assist FMUs to ensure all the forest operations meet the requirements in the areas of forest conservation and social forestry for sustainable forest management certification.

The 9-month intensive Programme covers two (2) months of theory, three (3) months of practical / field exposure and four (4) months of attachment with FMUs, who had either been certified and are undergoing certification.

Mr Wong also acknowledged the assistance of several agencies / organisations, in particular the timber industry, tertiary educational institutions and conservation nongovernmental organisations (NGOs) as well as the support rendered by the State Government, through the Ministry of Resource Planning and Environment (MRPE).

Workshop on the Outcome-Based Study on the Effectiveness of Training Incentive for SMEs

Ipsos Business Consulting, on behalf of the Human Resources Development Fund (HRDF) held a Workshop on the Outcome-Based Study on the Effectiveness of Training Incentive for SMEs on 20 April 2017 at the Pullman Hotel, Kuching. Approximately twenty (20) participants attended the Workshop.

The objectives of the Workshop are to discuss the employers' experience with training programmes attended by their employees and to gather employers' suggestions on how training programmes can be improved, especially from the perspective of Small and Medium Enterprises (SMEs). The Workshop also discussed measures that would encourage SMEs to send their employees for training and upskilling.

Mr Ganesan Periakarruppan, Consulting Manager of Ipsos Business Consulting informed participants of the Workshop that Pembangunan Sumber Manusia Berhad (PSMB) is currently conducting the outcome-based study on the effectiveness of training incentive for SMEs under the Tenth Malaysia Plan (10th MP). The training incentive for SMEs scheme was introduced under the 10th MP between 2011 and 2015, to assist employers of SMEs who have insufficient levy balance to continuously retrain and upgrade the skills of their employees. He said the information gathered in the survey will be used to help the Government to assess the effectiveness of the scheme and to contribute towards policy implementation in the future.

Breakout sessions were conducted in three (3) groups to discuss the measures of effectiveness from the different angles and types of return on investment that employers look for; and the barriers to sending employees for training and what all parties can do to improve training programmes and training incentives.

The Meeting was also informed that the study is on-going and the final report of the study shall be presented to HRDF in May 2017.

61st World of Wood

The International Wood Products Association (IWPA) organised its 61st World of Wood Annual Convention from 5 to 7 April 2017 at Hotel Nikko in San Francisco, California. This year's Convention had attracted over 300 participants from nearly thirty (30) countries, with nineteen (19) participants from Malaysia.

Mr Bronson Newburger, the President of IWPA highlighted in his opening speech that the shifting political winds could impact growth prospects for the global wood products market in 2017. IWPA members must keep abreast of market developments that will have a direct impact on profitability. He commented that "World of Wood is the one North American event that brings together leaders

from every segment of the global wood products supply chain. The information my staff and I take away each year

is critical to our business."

This year's Convention provided participants the opportunity to learn from and interact with speakers and panelists, their foremost expertise in regulatory compliance, market intelligence and corporate branding.

The highlights of the Convention included the keynote address delivered by Mr Marc Chandler, Brown Brothers Harriman Global Head of Currency Strategy on the latest currency trends and the impact on the global wood products market; a timely deep dive session on formaldehyde emissions for composite wood products; panel discussion on a new petition initiated with the International Trade Commission and Department of Commerce which could result in higher duties on plywood products imported from China; and a timber market forum which highlighted the global demand for wood products and the downtrend in the demand for tropical wood products.

During the deep dive session on formaldehyde emissions for composite wood products, Mr Erik Winchester of U.S. Environmental Protection Agency (EPA) informed the participants that the Formaldehyde Standards for Composite Wood Products Act was signed into law to become Toxic Substance Control Act (TSCA) Title VI

on 7 July 2010. TSCA Title VI establishes formaldehyde emission standards identical to the California Air Resources Board (CARB) limits, and it also directs the implementation of regulations to ensure compliance with formaldehyde emission standards. This regulation will take effect on 22 May 2017 and all regulated composite

> wood products must be labeled as TSCA compliant from 12 December 2017 onwards.

> TSCA Title VI requires the regulated composite wood products to be certified by an EPA-recognised third-party certifier (TPC), also called an EPA TSCA Title VI TPC. The regulated composite wood products covered under TSCA Title VI are (1) Hardwood Plywood; (2) Medium-Density Fiberboard (MDF), including thin-MDF; and (3) Particleboard and they must meet the following emission standards from 12 December 2017 onwards:

Product	Emission Standard (ppm of formaldehyde)
Hardwood Plywood – Veneer Core	0.05
Hardwood Plywood – Composite Core	0.05
Medium-Density Fiberboard (MDF)	0.11
Thin Medium-Density Fiberboard	0.13
Particleboard	0.09

This regulation also includes recordkeeping, reporting, and labeling requirements.

The Convention concluded with the passing the gavel reception and banquet.

MEF Industrial Relations Conference 20

The MEF Industrial Relations Conference 2017 was held from 26 to 27 April 2017 at the Holiday Villa, Johor Bahru. Approximately eighty (80) participants attended the Conference. The welcoming address was delivered by Mr Ramadass, the Vice President of the Malaysian Employers Federation (MEF) while Datuk Ismail bin Ibrahim, Chief Executive Officer of Iskandar Regional Development Authority delivered the keynote address and launched the latest MEF publication entitled "MEF Survey on Managing Employees During Economic Downturn".

There were five (5) papers presented and two (2) Panel Discussions in the Conference as follows:-

Paper 1: "Social Media - Use & Abuse"

 by Datuk Haji Shamsuddin Bardan, MEF Executive Director

The speaker spoke about employees incorporating social media into a wide range of activities while on the job in the current workplace. Despite some activities are explicitly professional or job-related, others are more personal in nature. He was of the view that it is high time for organisations to come up with effective networking policy and establish the expected behavioral norms in the use of social media as well as outline disciplinary measures for employees violating social media policy.

Paper 2: "Leveraging on Older Workforce"

- by Mr Edwin Lye, Director of Singapore National Employers Federation (SNEF)

The speaker shared with the participants of the Conference Singapore's experience on its re-employment model. The Singapore Government wishes to ensure that the continuous economic growth will translate into employment opportunities for people both young and old. Hence, a bill is to be passed where employers are required to offer re-employment to eligible employees turning 62 i.e. the statutory minimum retirement age in Singapore in the organisation. This law will come into force on 1 July 2017 if passed.

Panel Discussion: "Productivity Linked Wage System"

- a. Mr Chris Lee, Assistant Director and Consultant for Industrial Relation and Human Resource of SNEF
- b. Mr Sugumar Saminathan, Senior Manager, Productivity
 & Competitiveness Development Division of Malayan Productivity Corporation (MPC)
- c. Mr M Vivekanandan, former MEF Adviser Special Functions

All the three (3) speakers spoke generally about the Productivity Linked Wage System (PLWS) and the growing need to link a wage system to performance which will reflect the value of the job and wage increase to keep pace with productivity growth. A performance linked wage system should also take into account a company's profitability and an individual employee's performance with a variable component in the wage structure which gives

the employer the ability to respond to changing economic situations and business environment.

Paper 3: "Plugging Leakages"

- by Mr Gerard Sankar, Gerard & Associates and MEF Chairman of Southern Region Meetings

The speaker spoke about absenteeism and the cost of absenteeism to the company such as disruption or delay to work schedule, deterioration to quality of product, increase in cost of overtime, etc.

Paper 4: "Managing Poor Performance"

- by Mr Ramadass, MEF Vice-President

The speaker briefed the participants of the Conference on the importance of performance management, who can be considered as a non-performer and how to manage poor performance. He also spoke about the Industrial Court awards on poor performance and legal approach in dealing with poor performance for confirmed staff, probationers and senior management. He also reminded employers to be cautious in dealing with dismissal or termination due to poor performance as employee has a right to lodge a complaint with the Industrial Relations Department within 60 days of the dismissal for a claim of re-instatement due to unfair dismissal in both poor performance and misconduct cases.

Paper 5: "Attracting & Retaining Women Talent"

- by Datuk Haji Shamsuddin Bardan, MEF Executive Director Chairman

The speaker highlighted the statistics on female participation rate in the labour force, number of female employed by occupation and percentage of women in Board of Directors in companies registered with Companies Commission of Malaysia. He felt that women constitute an important part of addressing talent gap in Malaysia and suggested various initiatives to increase women participation. The speaker also spoke about the intention of Ministry of Human Resources (MoHR) to review the labour laws to prevent employers from discriminating pregnant women of which he felt that the existing laws were adequate to allow any party who has been discriminated to pursue a case against the employer.

Panel Discussion: "Aftermath of TPPA - Labour Legislation"

Mr K Kaesavan gave a brief background of Trans-Pacific Partnership Agreement (TPPA), the Labour Chapter Articles in TPPA and the ensuing law reform of 9 Labour

legislations currently enforced by MoHR. However, the newly elected President of the United States (US), Mr Donald Trump signed the executive order on 23 January 2017, pulling the US out of the TPPA. He informed the participants of the Conference that US is Malaysia's 3rd largest trading partner contributing 9% to our total trade in 2016 and the main objective of entering into TPPA is to see US market opening to Malaysian products.

All speakers concurred with each other that due to the requirement of TPPA for a minimum of six (6) countries which account for 85% of the combined Gross Domestic Products (GDP) of the twelve (12) members to ratify before TPPA can enter into force, it is highly unlikely for TPPA to enter into force without US participation as US accounts for about 60% of the combined GDP of the 12 members. Nonetheless, Mr K Kaesaven informed the participants of the Conference that the Malaysian Government's stance will only be known by May 2017 after the Asia-Pacific Economic Cooperation (APEC) meeting in Vietnam.

The 6th International Borneon Frog Race

SARAWAK FORESTRY Corporation (SFC) together with the Institute of Biodiversity and Environmental Conservation, Universiti Malaysia Sarawak (UNIMAS) with partial sponsorship by Sarawak Timber Association (STA), jointly organised the 6th International Borneon Frog Race from 28 to 29 April 2017 at Gunung Gading National Park in Lundu, Sarawak. The main objective of this event was to raise public awareness on the rich diversity of amphibian species found in Sarawak.

The Frog Race saw participants of the Event combing the wilds of Borneo to photograph as many species of amphibian as they can find within a given period of time. The winners were selected based on the most number of species photographed and the best photo.

The two-day event included a series of talks on frog conservation, puzzle and drawing competition, frog quiz as well as Junior Frog Watch involving students of primary and secondary schools around Lundu. Datu Ik Pahon Joyik, Permanent Secretary Ministry of Tourism, Arts and Culture Sarawak was the guest of honour to officiate this year's Frog Race on 29 April 2017. Approximately 100 registered local and overseas participants took part in this Event. Experts in frog biology; namely geologists, writers of natural history and wildlife photographers were in the panel of judges for the Frog Race and talks.

National Census on the Timber Industry

UKM Pakarunding Sdn Bhd has been appointed by the Malaysian Timber Industry Board (MTIB) to carry out a National Census on the Timber Industry. The project started in March 2017 and is expected to take nineteen (19) months. This Census will cover all wood-based mills that have registered with either Federal or State Government Agencies and Timber Associations in Malaysia.

In connection with this project, UKM Pakarunding Sdn Bhd called a workshop on 4 April 2017 at Menara PGRM, Kuala Lumpur to seek inputs and comments on the research instrument and methodology for carrying out the national census to ensure the success of the project. The project will cover four (4) broad areas (i) Labour (ii) Raw Material (iii) Technology and (iv) Production and Markets.

The Workshop started with three (3) presentations; (i) the background of the project, the methodology and questions to be asked in the Census by Professor Dr Sarani Zakaria, (ii) mapping of mills by Professor Mastura Mahmud and (iii) the grouping of data by Dr Mohd Aftar Abu Bakar. This was followed by discussions, comments and inputs from participants of the Workshop.
