Please fill in the Application Form clearly, with special attention to the followings:

1) CLASSIFICATION OF OFFICIAL MEMBERSHIP

Please tick one category which your business or operation is related to the classification. This must be your main/biggest business activity and should be the same as your STIDC registration category/activity. Please refer to (5) below for details of payment.

2) CATEGORY OF MEMBERSHIP WISH TO BE LISTED OTHER THAN THE OFFICIAL MEMBERSHIP

You can tick as many categories here as you wish. These categories should reflect other business activities you carry out, besides the main one as indicated in (1) above. For your information, STA Secretariat will send out information for any category by using the Official Category and "Listed Categories" registered by Members. For the Fees, it bases on 10% of the normal Annual Subscription Fees of the respective Official Membership Categories (please refer to (5) below for detail of payment.)

3) NAME OF REPRESENTATIVES

Please name two persons to represent your organization in the Association. One will be the Official Representative while the other one will be the Alternate Representative. According to STA Memorandum and Articles of the Association, the Alternate Representative can only exercise his/her voting right in any general meeting in the event of death, dismissal or resignation of the mentioned Official Representative.

4) NAME OF PROPOSER AND SECONDER

According to STA Memorandum and Articles of Association, every applicant must have a proposer and a seconder who must be a member of Association for at least a year at the time of application. Proposer and seconder shall not be the same person (whether as an individual or as a representative as the applicant). Please make sure the signatures are from official representatives of the companies in accordance to STA record.
