# **Honorary Wild Life Ranger** (Reappointment) Course

A meeting between Sarawak Forestry Corporation (SFC), Forest Department Sarawak (FDS) and STA was held on 12 August 2024 at Wisma STA Kuching to discuss on the Honorary Wild Life Ranger (HWR) reappointment training course.

Dr Melvin Gumal, the Deputy General Manager (Conservation) of SFC stated the importance of HWR in strengthening the conservation of wildlife in Sarawak and therefore agreed to collaborate with STA through its training arm, STA Training Sdn Bhd together with FDS in organising this training course in the near future.

The appointment of an HWR is made under Section 8(1) of the Wild Life Protection Ordinance, 1998 and will lapse after a period of three (3) years. They can be reappointed after completing a HWR reappointment training course, and cleared of any criminal records as well as physically able to perform work required as an HWR.

# Tree, Log and Timber **Identification Training Course**

Madam Runi Anak Sylvester Pungga, Senior Assistant Director of Forests from Research and Development Division of Forest Department Sarawak (FDS) and her officers met with STA Training Sdn Bhd (STAT) on 1 August 2024, to discuss on the conduct of Tree, Log and Timber Identification Training Course for their staff as part of skills and knowledge enhancement.

Both FDS and STAT agreed to jointly conduct the training course from 30 September 2024 to 4 October 2024 in Sarikei. The training, which will be conducted by STAT's trainers, Mr Sumbang Anak Rani and Mr Ginda Anak Uli, will provide basic skills and knowledge in tree identification through crown formation, leaf arrangement and shapes; log identification via outer and inner bark features, type of exudates and cross section of the log; and timber identification through anatomical features.

## **Biodiversity Observation for Land and Ecosystem Health (BOLEH)**

Biodiversity Observation for Land and Ecosystem Health (BOLEH) is a cost-effective and rapid method designed for monitoring carbon and biodiversity within forest management units. It provides a quantitative evaluation of ecosystem health, including biodiversity indices at the landscape level.

Developed by a team of researchers led by Prof. Emeritus Dr. Kanehiro Kitayama, BOLEH can be instrumental in gaining broader support through initiatives like the REDD+ and forest certification schemes.

STA and the Forest Department Sarawak (FDS) are inviting Prof. Kitayama and his team to conduct a technical workshop for STA members on BOLEH method in November 2024.

## Online Briefing on the BOLEH

On 26 August 2024, an online briefing was held to introduce the BOLEH method to STA members. The online briefing was hosted by STA and joined by Ms Bibian Diway, Executive Forester and Ms Ling Chea Yiing, Research Officer from Forest Department Sarawak (FDS), as well as the team of researchers led by Prof. Emeritus Dr. Kanehiro Kitayama.

During the briefing, Prof. Kitayama introduced the BOLEH's ability to generate accurate and actionable data that could play a critical role in supporting initiatives like REDD+ and forest certification schemes. He added that the application of BOLEH in Sarawak could enhance Sarawak's ability to meet its conservation goals while also contributing to global efforts to combat climate change.

Dr Yayoi Takeuchi, Senior Researcher at the National Institute of Environmental Studies also took the opportunity to share detailed information about the upcoming technical workshop which is tentatively scheduled for 21-24 November 2024. She urged foresters, managers and relevant stakeholders related to FMUs in Sarawak to attend the workshop.

In the discussion that followed suit, it was shared that unlike Permanent Sample Plots (PSPs),

the BOLEH method stands out as a faster, more cost-effective and time-saving while still providing extensive data. However, it is important to note that BOLEH plots are not intended to replace PSPs. Instead, they serve as a valuable complement, particularly by encompassing forest densities that are not represented in existing PSPs. This is due to BOLEH's strategic plot selection, guided by satellite imagery of forest density and intactness, which allows for projections across multiple forest classes.

Given BCX's strategic role in accelerating Malaysia's transition to a net-zero future, the engagement touched on the recent milestones achieved by BCX, including the successful inaugural Renewable Energy Certificates (RECs) auction, and the first Malaysian Nature-Based Carbon Credits auction. # Asia Pacific Regional Conference on Forest Landscape Restoration 2024

Forest Department Sarawak (FDS) and International Tropical Timber Organization (ITTO) jointly organised the Asia Pacific Regional Conference on Forest Landscape Restoration 2024 from 27 to 28 August 2024 at Riverside Majestic Hotel, Kuching. Under the theme "Forests as Climate Champions: Harnessing Restoration For Global Resilience", the conference aimed to identify and strengthen effective practices for forest landscape restoration (FLR) that are intended to deliver short, medium and long-term benefits to local communities, meet international forest commitments, and promote the management of forests to ensure their health and sustainability.

This conference provided a valuable platform for a diverse array of stakeholders, including public policymakers, civil society representatives, non-governmental organisations (NGOs), private sector agencies, forestry professionals, landuse practitioners, educational and research institutions, and ITTO member countries to share their knowledge, reflect on experiences and collaborate to shape the future of FLR in the Asia Pacific region.

In his welcoming address, Datu Haji Hamden Bin Haji Mohammad, Director of Forests Sarawak, emphasised the critical role of healthy forest landscapes in addressing the challenges posed by climate change in the Asia Pacific region. He highlighted that forest restoration is a potent solution to this pressing issue, and the conference is designed to connect restoration efforts with empowering forests as climate champions. He added that since March 2019, the Sarawak Government has made FLR a priority. This effort involves close collaboration with local communities, NGOs, international organisations and other stakeholders to restore and rehabilitate degraded forests, with a particular emphasis on high-value timber species.

The opening ceremony was honoured by the presence of Datuk Amar Haji Awang Tengah Ali Hasan, Deputy Premier of Sarawak, who represented Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari Bin Tun Datuk Abang Haji Openg, Premier of Sarawak. In his speech, Datuk Amar Awang Tengah highlighted Sarawak's remarkable achievements in environmental conservation and sustainable development. He showcased the Sarawak Government's dedication through various significant efforts, including its commitment to protecting rainforests and advancing green economy initiatives. Despite challenges, Sarawak remains resolute in its sustainable forest management practices, having successfully certified 26 Forest Management Units and 8 Forest Plantation Management Units, covering 2.38 million hectares and 122,800 hectares, respectively.

In addition to its forest management efforts, the Sarawak Government has mandated restoration activities for all forest license holders, focusing particularly on degraded areas. This proactive approach is designed to enhance the forest ecosystem, support the sustainability of flora and fauna, and encourage the development of alternative economic sectors, such as agroforestry, eco-tourism, and carbon trading.

Highlighting Sarawak's strong environmental stewardship, Datuk Amar Awang Tengah praised the state for exceeding its tree planting goal in the Greening Malaysia Campaign by planting 35 million trees ahead of schedule.

The sessions included (i) Governance of FLR & Policy Framework; (ii) FLR Success Stories & Lesson Learned; (iii) Community Empowerment & Uplifting Livelihood; (iv) Climate Change & Carbon Initiative; and (v) Research & Development and Technology Application on FLR. Besides that, the conference also featured a variety of poster presentations.

# Strategic Partnership Kayusar Sdn Bhd & Weng Meng Group

A significant milestone was reached in the strategic partnership programme between the Malaysian Wood Moulding & Joinery Council (MWMJC) and STA with the signing of a Memorandum of Understanding

(MOU) between Kayusar Sdn Bhd (Kayusar) and Jurusanwa Enterprises Sdn Bhd, a subsidiary of the Weng Meng Group (Weng Meng). The MOU signing ceremony was held at Kayusar's Kuching office on 1 August 2024.

The MOU is set to enhance the availability and distribution of high-quality fire doors across East Malaysia, addressing the growing safety and building regulation needs. With this agreement, Kayusar has been appointed as the distributor of Weng Meng's renowned fire doors in the region.

The MOU was signed by Mr George Yap, Managing Director of Weng Meng, and Mr Raphael Lee, General Manager of Kayusar. The signing was witnessed by Ms Annie Ting, CEO of STA, in the presence of distinguished guests including Mdm Noraihan Abdul Rahman, Chief Executive Officer (CEO) of



the Malaysian Timber Council (MTC), members of the Board of Trustees of MTC and officers from the Sarawak Timber Industry Development Corporation.

On 26 August 2024, STA paid a courtesy call to Yayasan Sarawak. The delegation from STA, led by Ms Annie Ting, Chief Executive Officer, was received warmly by Mr Watson Chunggat Leonard Doo, Acting Deputy Director (Education) of Yayasan Sarawak.

The discussions focused on the provision of financial assistance for students pursuing courses related to the forestry and timber industry. STA, through its subsidiary company STA Mutual Sdn Bhd, has been supporting students by providing scholarship for undergraduate and diploma courses in forestry and engineering at Universiti Malaysia Sarawak, Universiti Putra Malaysia, Swinburne University of Technology (Sarawak Campus) and Curtin University of Technology (Sarawak Campus).

Yayasan Sarawak also offers scholarships as well as loans to students studying at public higher education institutions in Malaysia and local private institutions in Sarawak. Students pursuing undergraduate programmes in forestry at public institutions can compete for one of the 200 scholarships available annually under the Yayasan Sarawak Tun Taib Scholarship. Additionally, students undertaking undergraduate and diploma programmes can apply for the interest-free Local Education Scholarship Loan, with the

possibility of receiving up to a 75% discount on their loans for outstanding academic performance.

The meeting underscored the mutual interest in enhancing educational opportunities and support for students in the field of forestry. Both parties agreed on the importance of developing human capital to manage the forests sustainably, ensuring ongoing support for the timber industry, and aligning with the Sarawak Government's green economy initiatives.

# **Permanent Forest Estate Awareness and Conservation Empowerment Programme**

The Forest Department Sarawak (FDS), through the Constitution and Conservation Division, organised the Permanent Forest Estate (PFE) Awareness and Conservation Empowerment Programme Series 1/24 on 29 August 2024 at the Waterfront Hotel, Kuching. The programme was attended by approximately 60 participants from both the public and private sectors, representing various agencies. The objective of the programme is to raise awareness about the importance of the PFE and conservation in maintaining our ecosystem.

In his welcoming speech, Haji Azahari Bin Omar, Assistant Director of Forests (Constitution and Conservation Division) outlined that since January 2020, FDS has prioritised PFEs, focusing on their gazettement, monitoring, and management. He noted that while 5.6 million hectares were once gazetted, only 3.9 million hectares remained due to

Sarawak's development needs and demands. He emphasised that PFEs are vital not only for timber but also crucial as habitats and ecological corridors linking Sarawak, Brunei, and Indonesia.

He acknowledged that despite the challenges of gazetting PFEs, including local objections and competing land uses, PFEs contribute significantly to Sarawak's revenue and provide socio-economic benefits such as job creation and infrastructure support. He expressed hope that the programme will foster a better understanding of PFEs' value and encourage proactive conservation efforts through collaboration among government agencies, the private sector, and the public.

During the event, four (4) presentations were delivered by officers from the FDS. The presenters provided an introduction to PFE, covering various categories such as Forest Reserves, Protected Forests, Communal Forests, License for Planted Forests, and Amenity Forests. The presentations also covered penalties for offences within PFE and Protected Forests, as well as the relevant legislation and enforcement related to PFE. Additionally, they discussed conservation activities within PFE, wildlife diversity, and the lengthy gazettement process.

Jabatan Hutan Sarawak telah mengadakan Program Kesedaran dan Pemerkasaan Pemuliharaan Estet Hutan Kekal (PFE) pada 29 Ogos 2024 di Kuching, yang dihadiri oleh 60 orang peserta. Acara itu menekankan kepentingan ekologi dan sosio-ekonomi PFE, menangani cabaran dalam pewartaan dan pemuliharaan, dan memupuk kerjasama dalam kalangan kerajaan, sektor swasta dan pihak berkepentingan awam.

## Sarawak's Export Day 2024

The Ministry of International Trade, Industry & Investment Sarawak (MINTRED) together with Malaysia External Trade Development Corporation (MATRADE), in collaboration with InvestSarawak, Affin Bank Berhad, Capital Markets Malaysia and Exim Bank Malaysia hosted the Sarawak's Export Day 2024 at Imperial Hotel, Kuching on 16 August 2024.

The event was launched by Datuk Amar Haji Awang Tengah Ali Hasan, Deputy Premier of Sarawak, cum Second Minister for Natural Resources and Urban Development and Minister for International Trade, Industry and Investment Sarawak. In his keynote speech, he reiterated Sarawak's commitment to embrace sustainability and highlighted the region's potential to produce low-carbon, green products to meet global demand. He also expressed hope that small and medium enterprises (SMEs) would benefit from the expert insights shared during the forum.

The Export Day featured four (4) sessions designed to equip SMEs with essential knowledge for international trade. These included strategies for export readiness and leveraging Free Trade Agreements, exploring trade financing options, adopting sustainable business practices, and identifying global market opportunities. Experts provided practical guidance on export guidelines, financing facilities, and the importance of integrating ESG practices, while introducing SMEs to various government assistance programmes and international market trends.

# **Seminar on Advancing Timber in Construction: Navigating Towards Sustainable Future**



Welcoming and Opening Speech by Prof Ir Dr Ahmad Kamil Arshad

A seminar on "Advancing Timber in Construction: Navigating Towards Sustainable Future", jointly organised by the Institute for Infrastructure Engineering and Sustainable Management (IIESM) of Universiti Teknologi Mara (UiTM) together with the Malaysian Timber Industry Board (MTIB) was held on 29 August 2024 at Hotel UiTM, Shah Alam Selangor. Prof Ir. Dr Ahmad Kamil Arshad, Director of IIESM in his welcoming and opening speech expressed hoped that the seminar would explore the vast potential of timber as a cornerstone of sustainable building practices. He also acknowledged innovations in timber products that enhance functionality and aesthetics, as well as their diverse applications.

The seminar started off with sharing of Human Resource Development Corporation (HRD Corp) rules and Occupational Safety and Health (OSH) application for construction industry in Malaysia by Associate Prof. Ir. Ts. Dr Rohana Hassan, a certified HRD Corp trainer who is also a principal researcher at IIESM. Dr Rohana highlighted four (4) scopes of HRD Corp rules for the timber manufacturing, namely sustainable harvesting; wood processing safety; waste management and quality standard. She also underscored four (4) safety requirements for timber and wood manufacturing, i.e. Personal Protective Equipment; Workplace Safety; Safe Operating Procedures; as well as Safety Signage and Training.

Mr Zulhelmi Mohd Ali, Assistant Director of Plantation Forest Division at MTIB presented an overview of the timber industry's export performance for 2023, along with updates on the Forest Plantation Development Programme (PPLH) 1.0 and 2.0. He noted that in 2021, three (3) new species - Paulownia, Rubber and Eucalyptus - were included into PPLH 2.0, marking a significant development in the programme.

Prof. Dr Zakiah Ahmad, Professor at the College of Engineering, UiTM addressed the fire safety concerns surrounding the use of wood or mass timber in high-rise buildings. She explained that the combustibility of timber is a primary reason why many building regulations and standards strongly restrict its use as a construction material. In addition to that, Mr Khairul Anwar, Director of Strategic Planning & Sustainability Division at the Malaysian Timber Council (MTC), provided insights into policy developments affecting key export markets. He highlighted issues such as fraudulent transshipment practices in Asia related to anti-dumping and countervailing duties, the European Union Deforestation-free Regulation (EUDR) and Australian Illegal Logging Prohibition Amendment Bill 2024. He also discussed MTC's efforts in addressing compliance with the EUDR.

Lastly, Ar. Azman Zainal Md Nor, Director and Founder of Arkitek Azman Zainal emphasised that timber is a natural and renewable resource that Malaysians should take pride, rather than feel guilt or shame, in utilising local timber. He highlighted common issues related to timber structures, such as termite attack (often called the "silent killer"), mould and fungi caused by factors such as poor ventilation as well as fire hazards, which are often misunderstood.

## Consultation Session with Stakeholders in Sarawak on Forced Labour and Child Labour Issues

The Human Rights Commission of Malaysia (SUHAKAM) held a consultation session on forced labour and child labour on 7 August 2024 at Pullman Miri Waterfront, Sarawak. This session was part of a series organised by SUHAKAM across Malaysia and was attended by members of STA, including representatives from Samling Group, Shin Yang Group, and Rimbunan Hijau Group.

In his welcoming remarks, SUHAKAM Chairman Dato' Seri Mohd Hishamudin Md Yunus highlighted that the 2022 Global Estimates reported approximately 28 million men, women and children are living under conditions of forced labour worldwide, spanning various economic sectors. He noted that the Malaysian Government has developed the National Action Plan on Forced Labour (NAPFL) 2021-2024, focusing on awareness, enforcement, labour migration, and access to remedy and support services, with the goal of eliminating forced labour in Malaysia by 2030. Additionally, the National Action Plan on Anti-Trafficking in Persons 2021–2025 (NAPTIP 3.0) was formulated to eradicate human trafficking. He emphasised that addressing these issues requires a concerted effort from all stakeholders, including the Government, civil society, and the private sector, with full compliance by industries and robust enforcement by relevant Government agencies to ensure that the rights and dignity of every person are respected and protected.

The session included five (5) presentations and two (2) discussion sessions. SUHAKAM Commissioner Dr. Chew Chee Ming chaired the discussion on issues related to the period prior to arrival in Malaysia, while Prof. Dato' Noor Aziah binti Mohd Awal led the discussion on matters concerning the period after arrival.

During the discussion, Ms Annie Ting, Chief Executive Officer of STA, emphasised the need to address the root cause of forced labour, particularly the significant debts incurred by workers due to agent fees in their home countries. She explained that these debts often compel workers to seek additional hours of work, beyond what the employers can offer under the law. The workers would resort to seek additional employment elsewhere to repay what they owe, which may lead to illegal activities. She also called for greater accountability from recruitment agents, who play a major role in the hiring of migrant workers.

Dalam ucapan alu-aluannya, Pengerusi SUHAKAM Dato' Seri Mohd Hishamudin Md Yunus menekankan bahawa usaha-usaha strategik Kerajaan Malaysia untuk menghapuskan buruh paksa dan membasmi pemerdagangan manusia di Malaysia seperti yang digariskan dalam Pelan Tindakan Kebangsaan Buruh Paksa (NAPFL) 2021-2024 dan Pelan Tindakan Kebangsaan Antipemerdagangan Orang 2021-2025 (NAPTIP 3.0). Cik Annie Ting, Ketua Pegawai Eksekutif STA menekankan keperluan untuk menangani punca kerja paksa, terutamanya hutang besar yang ditanggung oleh pekerja disebabkan oleh yuran ejen di negara asal mereka. Beliau menjelaskan bahawa hutang ini sering memaksa pekerja untuk mencari jam kerja tambahan, atau pekerjaan tambahan di tempat lain untuk membayar balik hutang mereka. Beliau menggesa SUHAKAM untuk menangani punca buruh paksa, termasuk hutang daripada yuran ejen dan akauntabiliti ejen pengambilan.

# Conference on Legal Pluralism and Indigeneity in Sarawak and Sabah: Issues and Challenges

The Centre of Legal Pluralism and Indigenous Law (CLPIL) of the Faculty of Law at Universiti Malaya (UM) and Institute of Borneo Studies, Universiti Malaysia Sarawak jointly organised a "Conference on Legal Pluralism and Indigeneity in Sarawak and Sabah: Issues and Challenges" on 7 August 2024 at Dayak Cultural Foundation Building, Kuching. The central theme of the conference revolved around the unique challenges and issues that arise in a legal system where multiple legal frameworks coexist, especially those involving indigenous customary laws and institutions.

The opening remarks by Dr Ramy Bulan, Director of CLPIL highlights the evolution of legal pluralism, emphasising the deep-rooted connection between legal pluralism and the collective identity of indigenous peoples. Reflecting on the Faculty of Law's mission since its inception in 1972, Dr. Ramy noted the importance of studying customary laws, a goal that has been gradually realised through the establishment of CLPIL.

She highlighted the need for a multidisciplinary and interdisciplinary approach to address the multifaceted issues surrounding indigenous rights and traditional knowledge.

In his welcoming address, Professor Dr Jason Chuah Chin Tik, Dean of the Faculty of Law at UM, underscored the inherent diversity of the legal systems, particularly in a multi-ethnic country like Malaysia. He pointed out that indigenous rights, which encompass both collective and individual aspects, are deeply intertwined with the values and belief systems of indigenous communities. According to Professor Chuah, an appreciation of these values is essential for crafting national strategies, policies, and laws that are not only equitable but also culturally sensitive.

The conference featured eleven (11) presentations that explore legal pluralism between pluriversality and everyday lived experience in coping with diverse systems. It brought together academics, judges, lawyers, community leaders, and civil

society practitioners to discuss and explore various aspects of legal diversity including the interaction of constitutional systems, legal systems and judicial institutions, and indigenous knowledge in addressing contemporary challenges such as governance of natural resources, environmental justice, and social issues.

Pusat Pluralisme Perundangan dan Undang-Undang Asli (CLPIL) Universiti Malaya dan Institut Kajian Borneo Universiti Malaysia Sarawak telah menganjurkan persidangan bertajuk "Pluralisme Undang-Undang dan Kewarganegaraan Asli di Sarawak dan Sabah: Isu dan Cabaran" di Bangunan Yayasan Budaya Dayak pada 7 Ogos 2024. Persidangan tersebut menjurus kepada kerumitan sistem perundangan di mana kewujudan pelbagai rangka kerja bersama, terutamanya yang melibatkan undang-undang orang asli.

Persidangan tersebut menampilkan 11 pembentangan yang meneroka persilangan di antara pluralisme undang-undang dan pengalaman harian, serta bagaimana sistem undang-undang yang pelbagai berinteraksi dengan rangka kerja perlembagaan, institusi kehakiman, dan pengetahuan orang asli. Peserta yang hadir membincangkan isu-isu berkaitan tadbir urus, pengurusan sumber asli, keadilan alam sekitar dan cabaran sosial dalam konteks kepelbagaian undangundang.

# Unlocking Market Potential: Sustainable Practices through Chain of Custody Certification

On 6 August 2024, the Malaysian Timber Certification Council (MTCC) hosted a webinar titled "Unlocking Market Potential: Sustainable Practices through Chain of Custody Certification", which drew approximately forty participants. The webinar aimed to highlight the importance of Chain of Custody (CoC) certification in leveraging market potential through sustainable practices. It sought to educate participants on how CoC certification can enhance market access, bolster sustainability credentials, and meet the increasing demand for responsibly sourced products.

Mr Akmal Saaran, Director of the Product Division at MTCC, provided an overview of the current landscape, revealing that 369 companies in Malaysia have obtained the MTCS-Programme for the Endorsement of Forest Certification (PEFC)

CoC certificate. The MTCC is working towards its goal of achieving 750 CoC holders by 2030, as outlined in the National Agricommodity Policy 2021-2030. He highlighted that there are 27 types of certified timber products from Malaysia, with the main categories being sawn timber, plywood, moulding and wood pellets. As of May 2024, the cumulative export of MTCS-PEFC certified timber products to 76 destinations reached 3.83 million cubic meters, with Europe and Asia being the primary markets, accounting for 66% and 24% of exports, respectively.

Despite these achievements, Mr Akmal noted that the uptake of MTCS-PEFC CoC certification remains relatively low in Malaysia. He encouraged companies to pursue CoC certification by outlining its numerous benefits,

including supporting sustainably managed forests, providing traceability solutions for wood-based materials, fulfilling procurement requirements from both private and public sectors, and utilising the PEFC label to communicate responsible practices to customers. Additionally, he highlighted that tax deduction incentives are available for MTCS-PEFC certificate holders to cover the costs of obtaining and maintaining the certification.

Mr Akmal explained the process of obtaining PEFC CoC certification and the associated auditing procedures. He then outlined the support MTCC offers to certificate holders, such as briefings and training, assistance with technical queries, regular updates on CoC certification, and access to potential PEFC CoC suppliers and buyers both locally and globally. He also advocated for the inclusion of PEFC standards in corporate forest products procurement policies to safeguard forests and enhance supply chain flexibility.

Pada 6 Ogos 2024, Majlis Pensijilan Kayu-Kayan Malaysia (MTCC) telah menganjurkan webinar bertajuk "Membuka Potensi Pasaran: Amalan Mampan melalui Pensijilan Rantaian Pengawasan". Webinar tersebut menekankan kepentingan pensijilan Rantaian Pengawasan (CoC) dalam meningkatkan potensi pasaran melalui amalan mampan. Sebanyak 369 syarikat di Malaysia telah memperolehi sijil Rantaian Pengawasan MTCS-PEFC, dengan matlamat mencapai 750 pemegang sijil CoC menjelang 2030 seperti yang digariskan dalam Dasar Agrikomoditi Negara 2021-2030. Webinar menonjolkan bagaimana pensijilan CoC menyokong pengurusan hutan yang mampan, menawarkan penyelesaian kebolehkesanan untuk bahan berasaskan kayu, memenuhi keperluan perolehan daripada sektor swasta dan awam, serta membantu menyampaikan amalan bertanggungjawab kepada pelanggan, selaras dengan permintaan yang semakin meningkat terhadap produk kayu yang diperolehi secara bertanggungjawab.

马来西亚木材认证理事会(MTCC)于2024年8月6日举办题为 "解锁市场潜力:通过产销监管链认证实现可持续实践" 线上研讨会。活动突显产销监管链(CoC)认证在通过可持续实践提升市场潜力方面的重要性。目前,马来西亚已有369家公司获得了MTCS-PEFC产销监管链(CoC)认证,而2021至2030国家农业商品政策中已阐明2030年前要达到750个CoC持证者的目标。该线上研讨会探讨CoC认证如何支持可持续管理森林,提供木材为本的材料可追溯解决方案,满足私人界和公共部的采购需求,并帮助向客户传达负责任的采购实践,以应对对负责任采购产品日益增长的需求。

## **ESG & Climate Action Workshops for SMEs**

Recognising the complexity of Environmental, Social and Governance (ESG) practices and lack of awareness on the impact of and the need for industries to adopt ESG, the Ministry of International Trade, Industry & Investment Sarawak in collaboration with InvestSarawak, Alliance Bank, United Nations Global Compact Network Malaysia & Brunei (UNGCMYB) and FAME International Training co-organised the "ESG & Climate Action Workshop for Small and Medium Enterprises (SMEs) on Building Competitive Business" on 15 August 2024 at Imperial Hotel Kuching.

Mr Timothy Ong, Chief Executive Officer of InvestSarawak, welcomed approximately 350 participants, emphasising that while ESG can be challenging, it presents significant opportunities for business growth and expansion. He assured that the government is facilitating SMEs in adopting sustainability practices.

Ms Shanta Helena Dwarkasing, Heads of Programmes at UNGCMYB introduced sustainability and ESG frameworks, outlining how SMEs can benefit from aligning with the UNGC's principles and integrating ESG practices into their strategies. She presented the SME Sustainability Action Guide and explained how adopting ESG practices can improve cost-effectiveness, employee motivation, competitiveness, and resilience. UNGCMYB also offers various tools and support, including accelerator programmes, workshops, peer learning sessions, and digital assessments.

Mr Roy Heong, Head Strategic Partnerships & Innovations at Alliance Bank Malaysia Berhad presented green financing and sustainability solutions, including various funding facilities designed to support SMEs in automation, technology upgrades, and green projects.

The workshop also covered key topics such as Greenhouse Gas (GHG) Protocols, GHG emissions, carbon footprint impacts, and sustainability action plans. Participants also took the opportunity to engage in an online survey for climate maturity assessment through PROGRESS, short for "Promoting Green Resilience & Sustainable SMEs".

## Simplified ESG Disclosure Guide (SEDG) Adopter Workshop

Capital Markets Malaysia (CM²) has taken a significant step forward in advancing Environmental, Social, and Governance (ESG) practices among Malaysian SMEs with the release of its Simplified ESG Disclosure Guide (SEDG) in October 2023. This initiative seeks to integrate ESG practices within Malaysian SMEs into a guide that streamlines and standardizes various global and local ESG frameworks into a cohesive set of guidelines tailored specifically for SMEs.

On 20 August 2024, CM<sup>2</sup> conducted the "Simplified ESG Disclosure Guide (SEDG) Adopter Workshop" on 20 August 2024 at Hilton, Kuching to promote the adoption of SEDG and equip SMEs with the knowledge and tools necessary for effective ESG implementation.

Ms Navina Balasingam, General Manager of CM² opened the workshop by highlighting the benefits of early ESG adoption. She noted that embracing ESG practices can provide SMEs with a competitive edge in the global market, address stakeholder expectations, and unlock various incentives linked to enhanced ESG disclosures. In addition to the SEDG, CM² has also introduced five (5) sector-specific guides in May 2024, covering Energy, Transport & Logistics, Construction & Real Estate, Agriculture and Manufacturing. These guides

offer targeted ESG disclosure guidelines for these crucial sectors in Malaysia's economy. She also expressed gratitude to the supporters of the workshop, including STA, for their role in promoting this event.

The workshop featured presentations from Ms Margie Ong and Ms Angelina John from Thoughts In Gear, as well as Mr Arkhilan V Manivannan from Lasaju Consulting Sdn Bhd. They provided detailed insights into the SEDG disclosures, focusing on environmental reporting and an in-depth exploration of the newly released SEDG Human Rights and Labour Practices Guide. The speakers introduced the 8-step Sustainability Adoption Methodology, designed to guide participants through assessing, planning, implementing, and reporting on their ESG journey.

# Timber Industry Stakeholders Seek Budget 2025 Support Amidst Raw Material and Sustainability Challenges

The Malaysian Timber Industry Board (MTIB), in collaboration with the Malaysian Timber Council (MTC) and the Malaysian Timber Certification Council (MTCC), hosted a discussion session with commodity stakeholders on 5 August 2024, at Menara PGRM, MTIB Cheras in Kuala Lumpur. The session was co-moderated by Mdm Farydatul Nazly, Deputy Director General of MTIB; Mdm Noraihan Abdul Rahman, Chief Executive Officer (CEO) of MTC; and Dr. Farrah Shameen Mohamad Ashray, CEO of MTCC.

The event, attended by representatives from the Ministry of Plantation and Commodities, MTIB, MTC, MTCC and trade associations including STA, aimed to address industry issues and focus on the Budget 2025 for the agri-commodity sector, in preparation for a follow-up discussion with the Ministry of Finance (MoF) on 13 August 2024. The session opened with Mr Mohd Nizam, Director of MTIB's Strategic Planning Division, giving an overview of Malaysia's timber industry, highlighting export and import trends since 2013.

Timber associations stressed ongoing challenges, including raw material shortages, a lack of skilled workers, and high operational costs. They urged the inclusion of provisions in Budget 2025 to address these issues and support environmental compliance. Additionally, the industry emphasised the need for written confirmation from the MoF regarding approval of applications to extend the carry-forward of unabsorbed losses up to 20 years on a case-by-case basis. Currently, the carry forward for unabsorbed business losses is allowed for 10 years. Extending it to 20 years would be more practical for the industrial forest plantation sector, offering greater flexibility for managing long-term investments and financial planning.

Lembaga Perindustrian Kayu Malaysia (MTIB), Majlis Kayu-Kayan Malaysia (MTC), dan Majlis Pensijilan Kayu Malaysia (MTCC) telah menganjurkan satu perbincangan pada 5 Ogos 2024 untuk menangani cabaran industri dan Bajet 2025 bagi sektor agri-komoditi. Isu-isu utama yang diketengahkan termasuk kekurangan bahan mentah, kos operasi yang tinggi dan pematuhan kemampanan. Pihak industri turut menekankan keperluan untuk mendapatkan pengesahan bertulis daripada Kementerian Kewangan mengenai kelulusan permohonan bagi melanjutkan tempoh kerugian yang tidak diserap sehingga 20 tahun berdasarkan kes demi kes.

# **Engagement Session with Sarawak Stakeholders on the Recent Reinstatement of Cabotage policy for Sarawak**

At the request of the Sarawak Government, the Federal Government has agreed to reinstate the cabotage policy in Sarawak to support the growth of domestic shipping. Consequently, the Ministry of Transport Sarawak (MOT) held an engagement session on 8 August 2024 at the Imperial Hotel Kuching to discuss this decision with the stakeholders in Sarawak.

In his opening remarks, Dato Sri Lee Kim Shin, Minister of Transport Sarawak addressed debates on the policy's effectiveness. A 2021 study by MOT found that liberalising the policy since June 2017 did not significantly reduce goods and services prices in Sabah and Sarawak, with shipping costs representing only a small portion. The reinstatement aims to protect the local shipping industry, enhance national maritime security, and foster a competitive local industry with job creation and economic growth. He urged local ship owners to offer competitive rates without overcharging.

Stakeholders, including representatives from chambers of commerce and the shipping industry, voiced concerns and

called for more studies on the policy's impact. Ms Annie Ting, Chief Executive Officer of STA, emphasised the need for a detailed analysis of freight costs as highlighted in STA's previous submission to the MOT on 28 April 2021. The Minister proposed forming a Task Force Committee to analyse the policy's implementation and provide a way forward.

Pada 8 Ogos 2024, Kementerian Pengangkutan Sarawak menganjurkan sesi libat urus di Hotel Imperial Kuching untuk membincangkan pewujudan semula dasar kabotaj di Sarawak. Dato Sri Lee Kim Shin, Menteri Pengangkutan Sarawak menekankan bahawa walaupun liberalisasi dasar itu tidak menurunkan harga dengan ketara, pewujudan semula bertujuan untuk melindungi industri perkapalan tempatan, meningkatkan keselamatan maritim, dan pertumbuhan ekonomi. Pihak berkepentingan menyuarakan kebimbangan dan pelaksanaan kajian lanjut mengenai impak dasar tersebut, dengan Jawatankuasa Bertindak dicadangkan untuk menganalisis pelaksanaannya dan menyediakan langkah susulan.

砂拉越交通部于2024年8月8日在古晋帝国酒店举办交流会,讨论在砂拉越重新实施沿海运输政策的事宜。砂拉越交通部长拿督斯里李景胜指出,尽管政策自由化未能显著降低价格,但重新实施此政策的目的是为了保护本地航运业、提升海洋安全并推动经济增长。利益相关者对政策表达了关切,呼吁进一步研究其影响,并建议成立一个工作小组委员会,以分析政策实施的实际效果并提出改进方案。

He also reported a decrease in forced labour cases, 12 cases in 2023 compared to 16 cases in 2022. The Convention also featured a series of impactful presentations that provided deep insights about the obligation to prevent and combat forced labour.

# Convention on Combating Worker Exploitation – Obligation to Prevent and Combat Forced Labour

A Convention on combating worker exploitation with the theme "Obligation to Prevent and Combat Forced Labour" was held at the Borneo Convention Centre Kuching on 25 August 2024. The Convention, which garnered more than 300 participants from the agencies, employers, human resource practitioners and others was officiated by Dato' Sri Haji Fadillah Bin Haji Yusof, Deputy Prime Minister of Malaysia and Minister of Energy Transition and Water Transformation.

Dato' Sri Haji Fadillah brought attention to Malaysia's improved standing in the Trafficking in Persons Report released by the United States (U.S.) Department of State, now on the Tier 2 Watch List. This advancement, contributed by significant progress such as increased investigations and prosecutions, awareness programmes, and better inter-agency cooperation, reflects the efforts of multiple agencies, including the National Strategic Office of the Council for Anti-Human Trafficking and Anti-Migrant Smuggling, the Ministry of Home Affairs, and the Ministry of Human Resources (KESUMA).

Key discussions included the 11 indicators of forced labour established by the International Labour Organization (ILO) and national laws, stressing the importance of employer transparency and adherence to legal standards. The convention also addressed Malaysia's efforts in managing its large migrant worker population and compliance with ILO conventions, including various inspections and legal actions taken against forced labour practices. Additionally, the event highlighted ongoing challenges, such as the need for improved prosecution and victim protection, while showcasing successful strategies from companies that have enhanced grievance mechanisms, worker conditions, and recruitment practices to combat forced labour effectively.

Konvensyen Membanteras Eksploitasi Pekerja, bertemakan "Kewajipan Mencegah dan Membanteras Buruh Paksa", telah diadakan pada 25 Ogos 2024 di Kuching, dirasmikan oleh Timbalan Perdana Menteri Dato' Sri Haji Fadillah Yusof. Dihadiri lebih 300 peserta, membincangkan kemajuan Malaysia dalam memerangi buruh paksa, termasuk penurunan kes, peningkatan kedudukan dalam Laporan Pemerdagangan Manusia yang dikeluarkan oleh Jabatan Negara Amerika Syarikat, dan amalan terbaik daripada majikan.

# Workforce Transformation Programme through Training, Productivity and Wages

On 29 August 2024, the Human Resource Development Corporation (HRD Corp), in collaboration with the National Wage Consultation Council (NWCC) and the Department of Trade Union Affairs (DTUA), held the "Workforce Transformation Programme through Training, Productivity and Wages 2024" at UCSI Hotel Kuching. The event focused on the implementation of the national wage policy and the development of training programmes as well as their importance to national productivity.

In his opening remarks, Haji Mohd Asri Bin Abdul Wahab, Director General of DTUA, emphasised the role of productivity in the context of the 12th Malaysia Plan. He noted the evolution of the minimum wage policy from its inception in 2012, which initially set different rates for Sabah, Sarawak and Peninsular Malaysia and has since transitioned to a unified rate of RM1,500 across all regions. He urged for continued efforts to ensure that workers' earnings meet the minimum wage requirements, highlighting that effective wage can bolster national productivity and global competitiveness.

Mr Ismail Bin Mohammad, Assistant Director of Sarawak's DTUA, highlighted the crucial role of trade unions in fostering harmonious industrial relations, collective bargaining, and employee representation. He added that trade unions are instrumental in organising lawful industrial actions. provide training, and manage welfare funds to enhance member benefits. Ms Umi Nadra Binti Kamaruddin, Assistant Secretary at the National Wage Consultative Council, discussed the financial implications of Malaysia's minimum wage policy. She clarified that while the minimum wage aims to surpass the poverty line, a living wage offers a decent standard of living and is voluntarily paid. Though Malaysia's minimum wage policy has improved earnings for lower-skilled workers, challenges like the tripartite system and low union membership affect collective bargaining, emphasizing the need for Progressive Wage Systems to reduce wage disparities.

Ms Siti Faeza Hamim Binti Ali Baba and Ms. Norfaezah Binti Ya'acob from HRD Corp Sarawak Region discussed human capital transformation and the National Training Index (NTI), which aims for 35% skilled workers. While Malaysia's human capital development score is 0.70, Sarawak's score of 0.61 indicates a need for further research to align training with workforce goals. Mr. Wahab Bin Haji Lias, Deputy General Manager (Production) at Kuching Water Board, shared challenges such as limited training options, resistance to new technologies, and varying employee skill levels. He suggested conducting Training Needs Analysis and implementing mentor-mentee programs to improve training effectiveness.

Dr. Nurhani Binti Aba Ibrahim, Senior Lecturer at Universiti Teknologi MARA Sarawak, reviewed the "Study on Minimum Wage Determination & Implementation of the Minimum Wage Order 2022". She emphasized the policy's goals of meeting basic needs, reducing reliance on unskilled foreign labor. Dr. Nurhani provided data on the poverty line income and wage levels in Sarawak, concluding that more in-depth studies are available at minimum wages website, accessible at https://minimumwages.mohr.gov.my/index.php/ms/.

Pada 29 Ogos 2024, Perbadanan Pembangunan Sumber Manusia (HRD Corp), dengan kerjasama Majlis Perundingan Gaji Kebangsaan dan Jabatan Hal Ehwal Kesatuan Sekerja telah menganjurkan "Program Transformasi Tenaga Kerja 2024" di Hotel UCSI Kuching, dengan memfokuskan pada dasar gaji dan program latihan. Haji Mohd Asri Bin Abdul Wahab menekankan kesan gaji minimum terhadap produktiviti dan menggesa usaha berterusan untuk memastikan pendapatan pekerja memenuhi keperluan gaji minimum. Perbincangan utama sepanjang acara itu termasuk peranan kesatuan sekerja, implikasi gaji minimum dan strategi modal insan HRD Corp, mengetengahkan cabaran dan keperluan untuk penyelidikan lanjut tentang dasar gaji dan keberkesanan latihan.

# Meeting of MEF East Malaysia Region Members No. 8/2024


The Malaysian Employers Federation (MEF) East Malaysia (Sarawak) Region convened its 8<sup>th</sup> meeting of the year on 23 August 2024, presided over by Ms Dayang Jamillah Tun Abang Muhd Salahuddin, Consultant-Industrial Relations of MEF Sarawak. The online session focused on "Managing Performance in the Present Era", presented by Ms Shalani Devi Madawan, MEF Senior Consultant-Industrial Relations.

Ms Shalani explained that while poor performance, defined as a significant gap between company expectations and actual employee output, is not classified as misconduct, it can lead to termination if well-documented. Employers are advised to follow proper procedures, including conducting a domestic inquiry (DI), implementing performance improvement plans, defining key result areas, and providing ongoing coaching and counseling. This approach is crucial to ensure that the company can defend its decision if the employee disputes their termination at the Labour Department or Industrial Court.

Under Section 14 of the Employment Act 1955, a DI and a show cause letter is necessary for poor performance involving misconduct. Proper human resource consultation is essential for managing these situations and adhering to legal requirements. Ms Shalani cited the case study "Andrew Chuah Khim Peik v HLG Capital Bhd" to emphasise best practices in managing poor performance and the importance of following legal guidelines.

Dalam pembentangannya, beliau menekankan bahawa walaupun prestasi lemah tidak dianggap sebagai salah laku, ianya boleh menyebabkan penamatan jika didokumenkan dengan betul. Sesi turut menekankan kepentingan mengikuti prosedur undang-undang, termasuk rancangan peningkatan prestasi dan pertanyaan domestik serta menekankan kepentingan untuk berunding dengan kakitangan HR bagi memastikan pematuhan Akta Kerja 1955.




















