STA Council Meeting No. 2/2025

The second STA Council Meeting of 2025 took place online on 28 August 2025. The meeting was chaired by Dato Henry Lau Lee Kong, Chairman of STA, and was attended by Mr David Tiong, Vice Chairman, Dato' Sri Patrick Wong, Honorary Secretary, Mr Philip Choo, Honorary Treasurer, and 21 Council members.

During the meeting, the Council reviewed reports from various Category Committees and Working Committees. Among the topics discussed, the Council took note of the progress made on research and development projects aimed at improving planting materials for forest plantations in Sarawak.

Concerns were raised regarding the practicality and cost implications of the enrichment planting programme. In response, Ms Annie Ting, Chief Executive Officer shared that STA has been actively engaging with the Forest Department Sarawak (FDS) on this matter, including a workshop held in Sibu on 26 August 2025. She also highlighted the Sarawak Government's shift toward forest conservation, as reflected in recent policy developments. The Council acknowledged that, if effectively implemented, enrichment planting could contribute positively to forest value.

The Council also noted that the Association will be meeting with the Immigration Labour Management Unit (ILMU) on 11 September 2025 to discuss challenges faced by members in transitioning from the Monitoring System on the Employment of Non-Sarawakians (MSEN), which ceased operations on 10 August 2025, to the Sarawak

Advanced Non-Sarawakians Online System (SANSOLS). Members reported challenges they have encountered while using the SANSOLS, including lengthy approval processing times, technical issues, and limited system clarity. Further concerns include poor customer support, high system costs, and rigid licensing policies of forfeiting fees paid at each stage of application, namely labour licence, elektronik Visa Dengan Rujukan (eVDR) and medical checkup should a worker is not accepted by the authorities for recruitment.

Several key activities were approved for the second half of the year. These include a roadshow in Miri and Sibu to inform and educate members on the Occupational Safety and Health (Amendment) Act 2022, and its implications for workplace safety and health. A followup technical workshop on Biodiversity Observation for Land and Ecosystem Health will also be held from 11 to 13 September 2025, building on the success of the Technical Workshop and Training in 2024. In addition, a brainstorming session will also be held to chart the roadmap and framework for the Task Force on Forestry-related Issues in October 2025. The Association is also collaborating with FDS to jointly organise the International Conference on Forest Plantation Research and Innovation 2025 from 17 to 19 November 2025 at the Pullman Hotel Kuching.

The meeting also covered administrative matters concerning the Association and its three subsidiary companies, STA Training Sdn Bhd, STA Mutual Sdn Bhd, and STA Enterprises Sdn Bhd.

Ahli turut membangkitkan cabaran serius dalam peralihan kepada SANSOLS dan aktiviti utama yang diluluskan dalam Mesyuarat Majlis termasuk siri jelajah Keselamatan dan Kesihatan Pekerjaan, sesi percambahan fikiran untuk Pasukan Isu Perhutanan serta Persidangan Penyelidikan dan Inovasi Ladang Hutan 2025.

Meetings of STA Subsidiary Companies

The Boards of Directors (BOD) of STA subsidiary companies convened via video conferencing in August 2025, chaired by Chairman, Dato Henry Lau Lee Kong. The BOD meeting of STA Enterprises Sdn Bhd (STAE) was held on 20 August 2025, followed by the Adjourned Meeting of STA Training Sdn Bhd (STAT) on 22 August 2025. The key highlights of both meetings are summarised below:



Adjourned Meeting of STA Training Sdn Bhd's Board of Directors' Meeting No. 2/2025

STAT

The Adjourned Meeting of STAT BOD Meeting No. 2/2025 deliberated and approved several financial and operational matters, including the appointment of KPMG PLT to convert the audited financial statements into XBRL format for submission to the Companies Commission of Malaysia through the Malaysian Business Reporting System 2.0, as well as matters related to the implementation of e-invoicing in the Company.

The Board was also briefed on the trainings conducted by the Company. Between 26 February 2025 and 31 July 2025, the Company conducted 19 skills trainings and successfully trained 118 forest workmen in various skill sets. For external programmes, the Company organised two (2) Environmental Compliance Audit (ECA) trainings, one (1) Environmental Quality Monitoring training, and one (1) Log Scaling training.

STAE

The STAE BOD Meeting No. 2/2025 endorsed several financial and administrative matters relating to building operations and maintenance, tenancy of Wisma STA, as well as amendments to the Company's human resource policies and procedures manual.

STA Constitution Committee Meeting No. 2/2025

The STA Council at its Meeting No. 3/2024 on 6 September 2024 has approved the strategic transformation to effectively address emerging challenges and seize new opportunities. The first step was to broaden the Association's objectives in line with the new direction.

Following that, the STA Constitution Committee met again on 27 August 2025 to deliberate on the restructuring exercise. The meeting was chaired by Dato Henry Lau, Chairman and attended by four (4) Committee members.

The Committee discussed key changes aimed at broadening STA's membership base to allow a wider range of organisations to join STA, fostering

greater collaboration and inclusivity. These include re-categorising the current nine membership types, introducing a two-tier membership system, and streamlining the voting process.

STA Training Sdn Bhd Gains Hands-on **Experience in FDPM Logfisher Training**

The Forestry Department of Peninsular Malaysia (FDPM) organised a Log Extraction Using Logfisher Training from 25 to 27 August 2025 at the Terengganu Forestry Training Centre (TFTC). The training was attended by a total of 20 participants from Peninsular Malaysia and Sarawak, including three (3) staff from STA Training Sdn Bhd (STAT), Mr Wong How Chu, Assistant Manager, and Trainers Mr Ginda Uli and Mr Sumbang Rani.

STAT participated in the programme to exchange technical knowledge, share operational experiences, and gain insights into log extraction using the Logfisher in Peninsular Malaysia, with the aim of developing a similar training programme under STAT for operators in Sarawak.

The three-day training was led by experienced trainers from TFTC, Mr Ahmad Azhar bin Mamat and Mr Mohd Anuar bin Abd Rahman. Training combined classroom lectures, practical demonstrations and field exercises covering Reduced Impact Logging (RIL) Guidelines for Peninsular Malaysia, Logfisher components and maintenance, safe operating procedures and practical log extraction techniques. Participants also gained exposure to real-world conditions such as manoeuvring machinery on difficult terrain and coordinating between operators and hookmen.

In his closing remark, Mr Mohd Tarmizi bin Ahmad, Principal of TFTC, highlighted that the training was designed to build capacity among Logfisher operators and their hookmen, particularly in the safe handling of heavy machinery used in log extraction operations. He stressed the importance of competency in alignment with the Malaysian Criteria and Indicators for Sustainable Forest Management (MC&I SFM) and RIL practices.

Mr Mohd Tarmizi added that the Logfisher training is part of the Forestry Worker Competency Programme under FDPM, which targets full participation of forest workers in certified training courses. This initiative, aligned with the DPM Strategic Plan 2026–2030, aims to strengthen skills and professionalism in the forestry sector. He expressed hope that participants would apply the skills and knowledge gained during training to daily operations, contributing to improved management of forests.

Jabatan Perhutanan Semenanjung Malaysia (JPSM) telah mengadakan Latihan Pengekstrakan Kayu Balak Menggunakan Logfisher pada 25-27 Ogos 2025 di Pusat Latihan Perhutanan Terengganu, dihadiri oleh 20 peserta termasuk tiga wakil daripada STAT, yang menyertainya untuk bertukar-tukar pengetahuan teknikal dan berkongsi pengalaman operasi dalam pengekstrakan balak menggunakan Logfisher, dengan tujuan untuk membangunkan program latihan serupa di bawah STAT untuk operator di Sarawak. Hand-Holding Programme on the **Expansion of the Scope of Service** Tax & Review of Sales Tax Rates

The Royal Malaysian Customs Department (RMCD) successfully conducted its Hand-Holding Programme on the Expansion of the Scope of Service Tax and Review of Sales Tax Rates on 13 and 14 August 2025 at the Imperial Hotel, Kuching.

The two-day initiative is part of RMCD's ongoing commitment to strengthen industry engagement and provide clear guidance on recent legislative changes impacting indirect taxation in Malaysia. The programme specifically targeted sectors most affected by these changes, attracting strong participation from industry leaders, tax professionals, and key stakeholders across Sarawak.

A major focus was the expanded scope of the Service Tax, which came into effect on 1 July 2025, and now includes additional sectors such as construction services, rental and leasing, healthcare, education, and financial services. At the same time, the review of Sales Tax rates covered a broader range of goods, affecting many businesses across various industries, including the timber industry. These tax reforms are aligned with the government's broader fiscal strategy to expand the tax base, enhance revenue collection, and promote long-term fiscal sustainability.

Participants received comprehensive briefings from RMCD officials, supported by interactive question and answer sessions that clarified compliance obligations, implementation timelines, and sector-specific concerns.

In addition to the main presentations, several SST clinics were set up outside the hall to provide personalised assistance and address individual queries.

Engagement with Ministry of Finance on **Expanded SST Scope**

On 1 July 2025, the Government expanded the scope of the Sales and Service Tax (SST), extending its coverage to a wider range of goods and services, including certain timber products which were previously exempt. This policy shift has understandably raised concerns across industries as businesses work to adapt to the new requirements.

To support members navigate these changes, the STA organised a oneday briefing in collaboration with the Royal Malaysian Customs Department (RMCD) on 3 July 2025 at Wisma STA, Kuching. The session drew strong participation from member companies and provided a valuable opportunity for industry players to seek clarification directly from Customs officers.

Building on feedback gathered during the briefing, STA consolidated members' issues and formally submitted them to the Ministry of Finance (MOF) on 17 July 2025. This led to an engagement session with MOF on 15 August 2025, chaired by Mr Mohd Fadzlee bin Malik, Head of the GST Section, together with officers from the Ministry. The STA group was led by Ms Annie Ting, Chief Executive Officer, and included Mr Koh Siok Kiat, STA Consultant, and Ms Yii Yien Yien, Assistant Manager.

The dialogue gave STA the chance to present industry-specific issues, particularly those affecting the timber sector, while MOF shared initial considerations and clarified general principles under the new SST framework. Key issues discussed included sales tax exemption for wastes, residues and by-products such as log ends, sawdust and woodchips, materials not purposely manufactured but generated incidentally in the course of the production process, and typically reused, recycled, or used for energy recovery. STA also raised the need to extend the sales tax exemption period for exports through third parties from six (6) months to twelve (12) months, as timber exporters often require more time to aggregate sufficient volumes before shipment.

In addition, STA requested the exclusion of material and goods costs used in construction from the imposition of service tax, and sought a business-to-business (B2B) exemption for professional services such as those provided by architects, engineers, and designers, both aimed at avoiding cascading tax effects.

Although many matters are still under review at policy level, STA's proactive engagement ensured that members' concerns were raised early and directly with the authorities. STA has also requested a written reply from MOF once decisions on the outstanding issues are finalised.

Through these efforts, STA reaffirms its commitment to representing members' interests and to ensuring that industry voices are heard in policy discussions that directly impact business operations.

Malaysian Timber Association (MTA) Executive Committee **Meeting No. 4/2025**

The Malaysian Timber Association (MTA) convened its Executive Committee Meeting No.4/2025 on 8 August 2025 at Menara PGRM, Kuala Lumpur, chaired by its president, Mr Tan Peng Juan. STA was represented by its Chief Executive Officer Ms Annie Ting, who also serves as the Honorary Treasurer of MTA.

During the meeting, Executive Committee members engaged in in-depth discussions and follow-ups on several pressing issues concerning the sustainability, regulatory compliance, and advancement of Malaysia's timber industry. Among the key topics addressed were the National Industrial Tree Plantation programme; the European Union Deforestation-free Regulation Coalition, United States tariffs, and enhancement of the Timber Legality Assurance System.

The Committee endorsed the establishment of eleven (11) sub-committees and working groups to strengthen the industry's collective response in addressing specific challenges such as market technical requirements, forest plantation development and utilisation, standards, among others. The meeting also resolved administrative matters including the appointment of authorised bank signatories to enhance and improve efficiency.

Persatuan Perkayuan Malaysia (MTA) telah mengadakan Mesyuarat Jawatankuasa Eksekutif Bil. 4/2025 pada 8 Ogos di Kuala Lumpur, dipengerusikan oleh Presiden Encik Tan Peng Juan. Ketua Pegawai Eksekutif STA, Cik Annie Ting yang juga Bendahari Kehormat MTA, turut mengambil bahagian dalam mesyuarat tersebut yang membincangkan perkara seperti kelestarian industri, Gabungan Peraturan Bebas-Penyahutanan Kesatuan Eropah dan penambahbaikan Sistem Jaminan Kesahihan Kayu. Sebelas jawatankuasa kecil juga telah dibentuk untuk menangani cabaran industri utama dan mengukuhkan kerjasama.

International Conference on Advanced Applied Sciences & Sustainability 2025

University of Technology Sarawak (UTS), Sarawak Timber Industry Development Corporation (STIDC) and Universiti Teknologi MARA (UiTM) Sarawak organised the "International Conference on Advanced Applied Sciences and Sustainability (ICAAS) 2025" on 6 August 2025 at Raia Hotel & Convention Centre, Kuching.

In his opening remarks, Haji Zainal Abidin bin Abdullah, General Manager of STIDC highlighted the importance of pursuing sustainable development in Sarawak, a region blessed with rich natural resources. He reiterated Sarawak's commitment to the Post COVID-19 Development Strategy 2030, which seeks to achieve balanced growth across economic, social, and environmental dimensions. He further stressed the need for innovation and global responsibility in addressing the challenges of climate change, underscoring the role of ICAAS as a vital platform for collaboration and knowledge exchange. With 75 presentations and more than 100 participants including representatives from STA, the conference served as a catalyst for practical innovations in Sarawak's resource-based industries. He concluded his address by calling for continued collective efforts to ensure Sarawak's development remains progressive, sustainable, and competitive on the global stage.

ICAAS 2025 was officially launched by Prof. Datuk Dr. Khairuddin Ab. Hamid, Vice-Chancellor of UTS. In his address, Prof. Khairuddin drew attention to the conference theme, "Innovations in Applied Sciences for a Sustainable Future," describing it as both timely and inspiring. He underscored the need to reimagine the role of science in shaping a resilient, inclusive, and green future, while emphasising the importance of applied research in delivering tangible and lasting benefits to communities and the environment. He also commended the efforts of the Centre of Excellence in Wood Engineered Products (CeWEP) at UTS for strengthening the link between industry innovation and sustainable development. In particular, he highlighted its contributions in advancing engineered wood products, promoting biomass valorisation, and optimising the use of tropical wood resources, all of which are initiatives that align closely with Sarawak's long term sustainability goals.

The conference featured two (2) keynote presentations. The first was delivered by Prof. Ir. Ts. Dr. Julie Juliewatty binti Mohamed of Universiti Malaysia Kelantan, who explored how modern engineering techniques can be applied to better understand and preserve traditional Mambong pottery. Her presentation highlighted the rich intersection of heritage craftsmanship and scientific innovation, demonstrating how technology can play a role in safeguarding cultural traditions.

The second keynote was presented by Datu Haji Hashim bin Haji Bojet, Advisor to STIDC, who shared an overview of the current

status and future prospects of Sarawak's timber industry. He drew attention to pressing challenges such as the significant decline in log production, which has led to increased reliance on imported logs for downstream processing. Despite the sector's high installed milling capacity, utilisation remains low at around 50%, while exports of timber and timber products continue to decline. Labour shortages and skills gaps further compound these issues. In response, the Sarawak government, through STIDC, is implementing strategic initiatives, including allowing mills to operate within forest areas to reduce costs and improve recovery rates to over 80%, with the goal of boosting productivity and strengthening sustainability.

The conference featured four (4) parallel sessions covering a wide spectrum of topics, including wood and forest products, food and agricultural technologies, agroforestry, micro and nano sciences, various engineering fields, and renewable energy. These sessions fostered

interdisciplinary collaboration and facilitated knowledge sharing across applied sciences and sustainability-focused research.

In addition to the presentations, the conference also featured a Memorandum of Understanding exchange between UTS and STIDC, as well as poster presentations, exhibitions, and an awards ceremony. These activities celebrated the contributions of researchers whose outstanding and innovative projects are expected to bring meaningful benefits for both the industry and local communities.

FDS Briefing on Areas to be Inundated by the Baleh Hydroelectric Project

The Forest Department Sarawak (FDS) held a briefing on the Salvage Logging Guidelines for areas to be inundated by the Baleh Hydroelectric Project (HEP) on 14 August 2025 at Kingwood Hotel, Sibu. The session was attended by representatives from the Ministry of Natural Resources and Urban Development, FDS, Natural Resources and Environment Board, Sarawak River Board, Sarawak Energy Berhad, Sarawak Timber Industry Development Corporation, affected forest timber licence holders/contractors, and STA.

FDS presented on the Salvage Logging Guidelines for areas to be inundated by the Baleh HEP to all the affected licensee and contractors. It was stressed that all licensees and contractors must adhere strictly to the guidelines and all work must be completed by September 2026, a year ahead of the scheduled reservoir impoundment in September 2027. This timeline is crucial to ensure proper reservoir preparation, protect the environment, and safeguard downstream communities.

All affected licensees were requested to notify FDS in writing within one week of the briefing, stating whether or not they intend to participate in salvage logging.

Enrichment Planting Implementation Workshop

The Forest Department Sarawak (FDS) gathered officers from its Headquarters and Regional Forest Offices, STA members and STA Secretariat at the Enrichment Planting (EP) Implementation Workshop to review the current EP Guidelines, identify challenges faced by licensees, and explore practical solutions through collaborative discussions. The workshop, facilitated by Mr Arifin bin Awang Zulkifli, Head of the Licensing Division at FDS, was held at Kingwood Hotel, Sibu on 26 August 2025.

In the lead-up to the workshop, STA convened several meetings with members to review the Guidelines and consolidate challenges encountered during on-the-ground implementation. EP was formally mandated in 2019 through two (2) DF Circulars: (i) DF Circular 2/2019, requiring all Forest Timber Licence holders to carry out EP within licensed areas using indigenous species, with the number of trees planted equivalent to those harvested; and (ii) DF Circular 1/2025, stipulating that compliance with the Guidelines is a prerequisite for licence renewal and new PEC applications, with an EP report required for renewal.

During the workshop, participants were divided into three (3) focused groups to discuss various aspects of the EP Guidelines. Each group examined different sections of the EP Guidelines, highlighted areas that posed practical challenges to implementation, and proposed adjustments based on their operational experiences. Justifications were also provided to explain the rationale behind each proposed amendment to the EP Guidelines. These discussions underscored the need for a more practical and coordinated approach to enhance both compliance and the overall effectiveness of EP in licensed areas.

The outcomes of these discussions were presented in a plenary session, where Ms. Annie Ting, Chief Executive Officer of STA, joined three senior FDS officers as panel members. Through this process, the EP Guidelines will be refined to better integrate practical industry inputs with FDS clarifications, ensuring that implementation in licensed areas is both achievable for licence holders and effective in contributing to forest restoration objectives. Some of the proposed refinements include limiting seedling

planting to the edges of log landings, abandoned royalty marking sites, and temporary camps due to soil compaction, with edge planting also helping to reduce erosion. A checklist was also developed to guide the selection of suitable indigenous species, with additional species such as Kelampayan, sawih, and terbulan included. For monitoring purposes, FDS has agreed to GPS waypoints at key points along skid trails or baselines, each marked with a pole and tape, were also proposed.

The FDS also agreed to maintain continuous engagement with STA and the timber industry on EP matters, including conducting field testing and site visits to support successful implementation on the ground. This commitment underscored the importance of ongoing collaboration between the authority and license holders to strengthen compliance and achieve restoration objectives.

Cadangan utama termasuk integrasi digital melalui Portal Pelesen Hutan dan FDS turut komited untuk terus berinteraksi dengan STA serta industri melalui ujian lapangan dan lawatan tapak.

Visit to Samling's Tissue Culture Laboratory, Nursery and *Eucalyptus* Clonal Plantations

On 14 August 2025, the STA Secretariat visited Samling's tissue culture laboratory, nursery, and *Eucalyptus* clonal plantations in Bintulu to gain deeper insights into the company's advancements in *Eucalyptus* tree improvement and sustainable industrial forest plantation.

The visit began with a courtesy meeting with Mr Yap Fui Fook, Chief Operating Officer of the Samling Group of Companies, and his team at Samling Plywood Bintulu Sdn Bhd. During the session, the Secretariat was briefed on Samling's tree improvement programme for *Eucalyptus* species, which has seen significant investment in developing high-quality clonal planting materials through tissue culture techniques. The discussion also explored opportunities for future collaboration in research and development to further strengthen progress in *Eucalyptus* cultivation.

The delegation then toured Samling's tissue culture laboratory before proceeding to Samling's planted forest area in Segan. There, they observed nursery operations and visited *Eucalyptus* clonal research plots, witnessing the company's efforts to enhance productivity and sustainability in industrial forest plantation.

Rewilding Association of Sarawak Holds Inaugural TreeTalk

The Rewilding Association of Sarawak (RAS) hosted its first TreeTalk titled "Rewilding a City, One Tree at a Time" on 15 August 2025 at Hotel Telang Usan, Kuching. The inaugural event was attended by nature enthusiasts, as well as representatives from non-governmental organisations and community associations, including STA.

As a new platform dedicated to advancing ecological restoration through rewilding initiatives across Sarawak, RAS aims to reconnect people with nature, restore degraded ecosystems, and foster coexistence between human settlements and native biodiversity.

Welcoming the participants, Mr Philip Yong, RAS Chairman and Founder, emphasised that working together and sharing knowledge openly is key to avoiding duplication and ensuring meaningful impact. He noted the very different challenges between rewilding in cities and in rural landscapes, particularly in choosing suitable species for degraded areas. Breaking down silos, he said, will allow collective efforts to flourish and ecosystems to heal.

The speaker, Dr Anthony Shadbolt, a seasoned practitioner in rewilding and biodiversity restoration from Christchurch, New Zealand, drew on decades of practice to share his insights. He recounted how oncedegraded spaces in Christchurch were turned into thriving ecological corridors, offering valuable insights that could be adapted to Sarawak's unique environment.

In responding to questions from the participants, Dr Shadbolt stressed the need to strike a blance between tree planting and long-term maintenance, cautioning that without proper care, restoration efforts may falter. He also emphasised the importance of selecting species suited to urban environments and stressed that rewilding cannot succeed without strong public awareness and support, nurtured through sustained education and engagement.

MEF East Malaysia (Sarawak) Regional Meeting No. 8/2025

The Malaysian Employers Federation (MEF) East Malaysia (Sarawak Region) convened its eight meeting on 28 August 2025 in a session facilitated by Ms Dayang Jamillah binti Tun Abang Muhd Salahuddin, Consultant of Industrial Relations at MEF Sarawak.

Two (2) insightful presentations were featured during the meeting, namely "Mental Health Awareness in Workplace" by Ms Chiew Pei Ching, Head of Psychology Counselling Unit of Kuching Health Division Office and "Forced Resignation – Lessons for Employers" by Ms Dayang Jamilah.

Ms Chiew kicked off her presentation by engaging attention of participants by asking them "how are you today?" a simple yet powerful way to draw attention to the importance of mental health. She emphasised the importance of emotional self-awareness and the ability to recognise, validate, and manage one's feelings before stress becomes overwhelming. These skills, she noted, are essential for maintaining mental wellbeing, especially in the workplace.

Ms Chiew then introduced the Whooley and General Anxiety Disorder 2 (GAD-2), widely used screening tools for mental health assessment. The questions prompt individuals to reflect on whether, in the past one (1) month, they had felt down, depressed, hopeless, or experienced little interest or pleasure in doing things. These prompts, though simple, are effective in encouraging early recognition of mental health issues and seeking support when needed.

She urged employers to prioritise their employees' emotional wellbeing by cultivating a supportive, empathetic and non-judgmental work environment with fairness and respect.

In the second presentation, Ms Dayang Jamilah provided key insights into the handling of forced

resignations, stressing the importances of avoiding ultimatums such as "resign or be dismissed", ensuring Performance Indicator Plans (PIPs) are fair, genuine and properly documented, provide adequate time and support for improvement are among others.

She cited a recent Industrial Court case, Thevendran A/L S. Sivanatham v Fuji Xerox Asia Pacific Pte Ltd, where the Court ruled that the employee had effectively been forced to resign, having been given no real choice. The case highlighted that such actions are legally considered dismissals, and if done without just cause or excuse, could result in serious legal consequences for the employer.

She emphasised the need for employers to manage such situations carefully and fairly to minimise legal risks and safeguard the employers' reputation. Among the practical steps shared were maintaining objective performance records, using PIPs as developmental tools, not punitive measures, offering necessary training and support,

avoiding coercive and exploring redeployment options before considering termination.

Ms Dayang Jamilah concluded by underscoring that adherence to proper procedures and employment laws is essential to ensure fair and consistent decisions. This not only protects the employers but also fosters a respectful and harmonious workplace while reducing the likelihood of disputes or complaints.

IWPA Trade Policy Update

STA, as a member of the International Wood Products Association (IWPA), attended a Trade Policy Update webinar organised by the Association on 27 August 2025. The session, led by Ms Ashley Amidon, IWPA Executive Director; Mr Joseph O'Donnell, Director of Government and Public Affairs; and Mr Ben Finnestad, Policy & Marketing Coordinator, provided members with a comprehensive update on United States (US) trade policy developments affecting the wood products industry.

Key topics included the ongoing Section 232 investigation under the Trade Expansion Act of 1962, International Emergency Economic Powers Act-based tariffs, enforcement actions under Section 301 of the Trade Act of 1974, updates on Anti-Dumping and Countervailing Duties (AD/CVD), as well as other relevant issues such as the European Union Deforestation-Free Regulation. The speakers also outlined the current US political landscape and explained how potential shifts in government policy may influence trade, particularly timber imports.

Participants were informed that the US Department of Commerce is assessing whether certain imports pose risks to national security under Section 232 of the Trade Act of 1974, while Section 301 continues to serve as a key enforcement tool to address unfair foreign trade practices. The discussion also highlighted the implications of AD/CVD measures on timber imports, underscoring the need for industry stakeholders to stay vigilant.

Ms Amidon acknowledged the prevailing uncertainties in global trade but assured members that IWPA remains committed to providing timely updates on ongoing investigations, tariffs, and duties that may impact the timber sector.

MEESty's Public-Industry Engagement Day and Launching Ceremony of the Sarawak Energy **Transition Policy**

Ministry of Energy Environmental Sustainability (MEESty) gathered more than 500 representatives from government, industry, academia, and civil society at the Borneo Convention Centre Kuching on 11 August 2025 for its Public-Industry Engagement Day. The event provided a platform for dialogue on partnership opportunities to accelerate Sarawak's clean energy transition and marked the official launch of the Sarawak Energy Transition Policy (SET-P), a strategic framework to position the energy sector as a key driver of the Sarawak's future development.

The programme began with a briefing by appointed consultants on three (3) key government policies charting Sarawak's pathway towards sustainability and energy innovation, namely the Sarawak Sustainability Blueprint (SSB) 2030 and the Sarawak Hydrogen Economy Roadmap (SHER), both launched in May 2025 as well as the SET-P, which was launched later that day.

The SSB 2030 sets a comprehensive roadmap towards a low-carbon, inclusive and sustainable economy through 10 Strategic Thrusts. Forestry plays a central role under Strategic Thrust 7: Sustainable Stewardship of Natural Assets, with key targets including maintaining 56% forest cover, designating one million hectares as Totally Protected Areas by 2025, certifying three million hectares of long-term forest timber license areas and constituting 50,000 hectares of permanent forest this year. Other commitment include restoring up to 10% of forest ecosystems, planting 5,000 non-timber forest product species

annually and establishing 10,000 hectares of bamboo plantations by 2030.

Complementing this, the SHER positions Sarawak as a future leader in the global hydrogen economy, recognising hydrogen's role in decarbonisation and its diverse industrial applications.

Following the briefing, Sarawak State Secretary Datuk Amar Haji Mohammad Abu Bakar bin Marzuki delivered his welcoming remarks, highlighting the importance of cross-sector collaboration, efficient regulatory coordination and digital adoption to ensure development benefits reach all Sarawakians, including rural communities. He stressed that the SET-P complements the SSB 2030 and SHER under the Post COVID-19 Development Strategy 2030 and called on the Sarawak Civil Service to actively engage stakeholders and embrace innovative approaches.

Premier of Sarawak, Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari bin Tun Datuk Abang Haji Openg, then delivered his address and officially launched the SET-P. In his speech, the Premier outlined Sarawak's strong competitive edge in driving energy transition, noting that Sarawak ranks first in Malaysia for low-carbon energy potential, natural gas production, and reserves, accounting for more than 60% of the national total. He further pointed to Sarawak's abundant land and water resources for industrial development and utilities, as well as its strategic position at the heart of the South China Sea, a major maritime corridor carrying one-third of global sea trade.

Anchored on seven (7) strategic pillars and supported by five (5) key enablers, the SET-P is expected to generate investments of RM580-700 billion by 2050, create 80,000 high-paying jobs by 2050 and channel over 75% of benefits to middleand lower-income households. Forestry will play a significant role in this green economy shift through carbon capture, utilisation and storage initiatives, positioning forests as nature-based carbon sinks, and through bioenergy, leveraging wood residues as a biomass resource.

The launch ceremony also witnessed the signing of seven Memoranda of Understanding between the Sarawak Government and leading industry players in various renewable energy sectors, reinforcing Sarawak's position as a regional clean energy hub.

Kementerian Tenaga dan Kelestarian Alam Sekitar melancarkan Dasar Peralihan Tenaga Sarawak (SET-P) semasa Hari Penglibatan Awam-Industri pada 11 Ogos 2025. Turut diperkenalkan semasa acara itu ialah Pelan Induk Kelestarian Sarawak (SSB) 2030 dan Pelan Hala Tuju Ekonomi Hidrogen Sarawak (SHER). Dasar-dasar ini merangka halatuju Sarawak ke arah ekonomi rendah karbon melalui tenaga bersih, pemuliharaan hutan dan inovasi hidrogen. Sektor perhutanan memainkan peranan penting, dengan komitmen untuk mengekalkan 56% litupan hutan, memperluas kawasan perlindungan, memulihkan ekosistem yang terdegradasi, dan menyokong pasaran karbon dan bioenergi. Secara keseluruhannya, dasar ini bertujuan untuk menarik pelaburan sebanyak RM580-700 bilion dan mewujudkan 80,000 pekerjaan menjelang 2050.

HRD Corp Open Day 2025

In conjunction with the "HRD Corp Open Day – National Day Edition" on 21 August 2025, the HRD Corp Kuching Branch hosted a series of interactive sessions for its stakeholders at its office. STA participated in one of the sharing sessions delivered by Mr Phang Pin, Senior Assistant Director of the Labour Department Sarawak, who spoke on the Amendments to the Labour Ordinance of Sarawak (Sarawak Cap. 76) and the Minimum Wage Order 2024.

Mr Phang informed participants that a total of 75 amendments to the Labour Ordinance of Sarawak (Sarawak Cap. 76) were made in 2025, of which he highlighted 18 key areas. These included revisions to the definition of "employee", rest days, public holidays, working hours, maternity and sick leave, payment of wages, and prohibition of forced labour, among others. He also noted that special provisions under Part IVA of the Ordinance, relating to minimum standards for employee housing, accommodations, and amenities, have been approved but are not yet enforced.

On the subject of wages, Mr Phang outlined the role and functions of the National Minimum Wages Council. He clarified that under the Minimum Wage Order 2024, effective 1 August 2025, the minimum wage, whether calculated monthly, piece rate, tonnage, or other methods, must not fall below RM1,700 per month.

Beyond the sharing sessions, the HRD Corp Open Day also featured a free consultation clinic offering personalised guidance on HRD Corp services, including levy matters, claims processes, and available training programmes.





The ECA training course aims to provide a thorough understanding and practical application of the ECA process to meet the requirements of the Natural Resources and Environment (Audit) Rules, 2008, and the associated guidelines as well as to promote self-regulation within the industry players. This training will enable qualified personnel to be registered as Environmental Auditor with NREB and to conduct internal audits, migrating from the existing Environmental Monitoring Reports (EMR) submission.



With effect from 1 July 2024, it is mandatory for the forestry sector in Sarawak to implement the Environmental Compliance Audit (ECA) while for agriculture (oil palm plantation), quarry, and mining sectors; it will come into effect on 1 January 2027.








EXPORT VALUE OF MEDIUM DENSITY FIBREBOARD BY **DESTINATION FROM** SARAWAK






EXPORT VALUE OF DOORSKIN BY **DESTINATION FROM** SARAWAK






EXPORT VALUE OF DOOR PANELS & FRAME BY **DESTINATION FROM** SARAWAK








EXPORT VALUE OF CHARCOAL & BRIQUETTE BY DESTINATION FROM SARAWAK





EXPORT VALUE OF WOOD PELLETS BY DESTINATION



SKILL TRAINING FOR TRAINED WORKMEN

Skills training in forestry activities have been designed to provide forest workmen with basic knowledge and practical skills required to work safely in the forests. It helps to create awareness on the environment, sustainable forest management as well as occupational safety and health.

STA Training Sdn Bhd (STAT), a subsidiary company of STA, offers training to workmen in the forestry and timber industry. Presently, there are twelve (12) skills sets offered by STAT.

LOG LOADING - FRONT END LOADER (NATURAL FOREST)

A Certificate in Log Loading - Front End Loader (Natural Forest) is awarded to an operator who has demonstrated competence in operating a log loader to handle logs for loading onto a logging truck and unloading logs from a logging truck safely.



SCOPE OF TRAINING COVERS SKILLS & KNOWLEDGE IN:

- Safety and health
- Basic maintenance of log loader
- Pre-start check
- Shut down procedure
- Moving logs from stack and position logs securely on a logging truck

MEET THE TRAINERS KUTOK BAYANG Trainer/Assessor Range Sang Sanjan Trainer/Assessor

Under Section 51 of the Forests Ordinance 2015, forest workmen are required to receive training from a training provider and demonstrate their competence through assessment. STA Training Sdn Bhd (STAT) is the appointed training provider by Forest Department Sarawak to provide skills training for the five (5) prescribed forestry activities (PFAs) as listed in Schedule 1 The Forests (Trained Workmen) Rules, 2015.
