Sharing Session on the Trainings in 5 PFAs for the Year 2024

The officers from the Forest Department Sarawak (FDS) and STA Training Sdn Bhd (STAT) gathered at Wisma STA Kuching on 18 December 2024 to share insights on the trainings in 5 Prescribed Forestry Activities (PFAs) and the verification of trained workmen conducted for the year 2024, as well aschallenges and opportunities in enhancing the compliance of the Forests (Trained Workmen) Rules, 2015 within the timber industry.

Ms Annie Ting, Manager of STAT, in her remarks thanked FDS for participating in the sharing session to share their findings and observations when conducting ground verification the trained workmen. She highlighted that the feedback is important for continuous enhancement of training conducted by STAT. Mdm Judy George Wan, Head of the Corporate & Service Modernisation Unit of FDS, was also present during the sharing session.

In the sharing session, Mr Wong How Chu, Assistant Manager of STAT, presented that in 2024, STAT trainers conducted 17 PFAs trainings at various logging camps, with 61 of them trained and assessed to be competent, bringing the total number of trained workmen to 4,055 since it was first started in 2004. He also shared on the challenges and opportunities when conducting training, such as the absence of nominated workmen, on-site new nomination, and cancellation or postponement of confirmed

training, which will impact training arrangements, costs and others.

Mr Simon Ricky anak Dunstan Udam, Assistant Forest Officer of FDS, shared that in 2024, his team had conducted inspections at 9 logging camps and 3 monitoring sites, in addition to reminding the company to register their forest workers in the forest licensee portal. He highlighted that the Department had also instructed the company to send their forest workmen in the 5 PFAs for training, as required under Section 51(1) of the Forests Ordinance 2015. Failure to comply would result in the non-issuance of a Permit to Enter Coupe (PEC) and licence renewal which is stated in the DF Circular 1/2024 – The Directive on Trained Workmen (Licence Renewal & Permit to Enter Coupe Approval).


STA Downstream Committees' Study Trip to Peninsular Malaysia

The Sarawak Government's Post COVID-19 Development Strategy 2030 (PCDS 2030) aims to promote Sarawak as the preferred investment destination for high-value downstream activities of resource based industry and to increase export earnings from timber & non-wood forest products to RM8 billion by 2030. As part of the efforts to support the PCDS 2030, STA downstream committees comprising Timber Products Marketing, Moulding and Sawmilling jointly conducted a study trip to Selangor from 9 to 10 December 2024 to explore collaboration opportunities and to gain insights into the downstream timber sector.

The main objectives of the trip were to engage with key industry players and explore collaboration opportunities with the Institute for Infrastructure Engineering & Sustainable Management (IIESM), Universiti Teknologi Mara (UiTM) Shah Alam and the Forest Research Institute of Malaysia (FRIM). Discussions focused on strengthening the development of engineered wood products (EWP) for construction, advancing research on biomass products, and refining timber standards for better marketability. Additionally, the delegation explored potential training and engagement initiatives between STA, UiTM, and FRIM.

During the visit, the delegation toured the Weng Meng Group, a leading manufacturer of doorsets and cable reels in the region, where they learned about the company's innovative use of oil palm trunk and new product development. The group also met with researchers from FRIM's Forest Products Division, who shared their latest advancements in timber-related research.

On the second day, the STA delegation visited IIESM at UiTM, where they were briefed on projects such as glulam timber railway sleepers and the promotion of EWP in the construction sector. Both parties agreed to organise an awareness programme to highlight the sustainability of timber as a building material for manufacturers, end users, and policymakers.

The delegation also visited Hup Chong Furniture Sdn Bhd, which specialises in bedroom sets and timber houses using glulam. This provided valuable insights into the performance of glulam and other timber products over time, particularly in real-world applications.

The study trip concluded with a networking dinner, where the delegation had the opportunity to engage with Datuk Larry Sng, Chairman of the Malaysian Timber Industry Board (MTIB), fostering stronger industry ties.

Development of STIDC's Blueprint for SMEs in Sarawak Furniture Manufacturing Industry

On 4 December 2024, the Sarawak Timber Industry Development Corporation (STIDC) hosted an engagement session at the Borneo Convention Centre Kuching, to develop a blueprint for growing Sarawak's furniture manufacturing industry, with a particular focus on Small and Medium Enterprises (SMEs). The event gathered input from government officials, industry players, and experts to craft a sustainable strategy.

In his opening remarks, STIDC General Manager Haji Zainal Abidin bin Haji Abdullah highlighted that the blueprint, aligned with Sarawak's Post COVID-19 Development Strategy (PCDS) 2030, aimed to enhance SMEs' competitiveness locally and internationally while addressing industry challenges and fostering innovation. He stressed the importance of collaboration among stakeholders to ensure the plan's success and relevance.

As part of PCDS 2030, Sarawak targeted RM8 billion in export revenue by 2030, with RM4 billion expected from furniture. This engagement session, the third of its kind organised by STIDC, facilitated discussions on raw material shortages, human capital, logistics challenges, technological transformation, financial support and policy frameworks to strengthen the sector's competitiveness. STA Downstream members and its Secretariat actively participated in these discussions.

Working Dinner with Deputy Minister of Plantation and Commodities

On 18 December 2024, Ms Annie Ting, Malaysian Timber Association (MTA) Honorary Treasurer and STA Chief Executive Officer, attended a working dinner with Datuk Chan Foong Hin, Deputy Minister of Plantation and Commodities (MPC), at Bangsar South, Kuala Lumpur. The dinner, organised under the platform of MTA and hosted by its President Mr George Yap, was also attended by key figures from the timber industry, including Mr George Yap, MTA President; Mr Ng Kay Yip, President of the Malaysian Wood Industries Association (MWIA) and MTA Honorary Secretary; Mr Chua Song Fong, President of the Timber Exporters' Association of Malaysia (TEAM); Mr Rahman Khan, Deputy President of the Sabah Timber Industries Association (STIA); and Mr Yong Teng Koon, Consultant for MTA and Chairman of the Coalition on Sustainable Timber.

During the dinner, Deputy Minister Datuk Chan highlighted the importance of industrial tree planting and urged MTA to explore this area. He also praised the Coalition on Sustainable Timber, an initiative led by MTA in response to the European Union's Regulation on Deforestation-Free products. The Deputy Minister congratulated MTA for its continued leadership, as Malaysia was re-elected as the Chairman of the Coalition on Sustainable Timber for another term, which shall expire in December 2025.

Minimum Wage Order 2024

The Minimum Wage Order (MWO) 2024 (P.U.(A) 376/2024) was gazetted on 4 December 2024. The Order stipulates a minimum wage of RM1,700 per month throughout the country, with implementation timeline as follows:

(a) Effective 1 February 2025:

- (i) Employers who employ five or more employees; and
- (ii) Employers who carry out activities classified as professional activities under the Malaysia Standard Classification of Occupations (MASCO), regardless of the number of employees.

(b) Effective 1 August 2025:

(i) Employers who employ less than five employees and do not carry out professional activities classified under MASCO 2020. The minimum wage rate remains at RM1,500 per month from 1 February 2025 to 31 July 2025, after which it will increase to RM1,700 per month.

MTIB's Study on Data Generation Towards Expanding the Wood Product Certification Scheme – Roundtable Session

The Malaysian Timber Industry Board (MTIB) has engaged the Institute of Tropical Forestry and Forest Product (INTROP) of Universiti Putra Malaysia (UPM) to carry out a study on data generation to expand MTIB's Wood Product Certification Scheme. This study is part of the Government's efforts to explore opportunities to expand the certification scheme to include products that align with current needs and meet the demands of the global market.

In this connection, a roundtable session with stakeholders was held on 19 December 2024 at Bangi Resort Hotel. The session aimed to exchange ideas and discuss issues related to requirements, impacts, challenges, opportunities and relevance of certification in advancing the country's Sustainable Development Goals. The roundtable was attended by representatives from timber industry associations as well as Government agencies.

During the group discussion, the industry representatives were assigned with identifying wood-based products that are most crucial for certification based on marketability, trends and sustainability. This was to determine which products, beyond the current certifications for plywood and formaldehyde emissions of panel products for domestic markets, should be prioritised under MTIB's certification scheme.

The Industry Group recognised the value of product certification as a means of promoting and acknowledging the quality and standards of products. However,

they suggested that Government should analyse import data to identify which products should be prioritised for certification. Other key recommendations from the discussion include offering incentives to companies that demonstrate strong commitment to improving product quality, implementing cost-sharing measures to ease the financial burden on businesses; ensuring government recognition of certified products; enhancing market access for certified products; strengthening collaboration and synergy among various Government agencies.

Wakilwakil daripada persatuan industri perkayuan serta agensi Kerajaan menekankan keperluan untuk mengutamakan produk kayu utama untuk pensijilan, insentif, perkongsian kos dan kerjasama antara agensi.

Enrichment Planting Reporting for the Year 2024

The Forest Department Sarawak (FDS) held a meeting on "Enrichment Planting Reporting for the Year 2024" on 16 December 2024 at Wisma Baitul Makmur II, Petra Jaya. The meeting was chaired by Mr Semilan Anak Ripot, the Deputy Director of Forests (Forest Management), and was attended by FDS staff from both the Headquarters and Regional Forest Offices, along with the staff from STA Secretariat.

In his opening remarks, Mr Semilan emphasised the critical role of enrichment planting in forest restoration efforts. He highlighted that all holders of forest timber licences are required to carry out enrichment planting within their licensed areas, in accordance with DF Circular No. 2/2019 issued by the Director of Forests on 15 January 2019. Furthermore, he stressed the importance of establishing nursery within the licensed areas to produce indigenous species for use in these restoration activities.

A key point of Mr Semilan's address was the potential consequences for non-compliance with the circular, including the non-renewal of licences for those failing to meet the stipulated requirements. The meeting featured presentations from all Regional Forest Offices, which provided updates on the progress of enrichment planting in relation to the allocated planting quotas. The reports also included an overview of nursery performance and findings from on-the-ground audits of licenced areas. Additionally, challenges faced by both FDS staff and licence holders were discussed, and proposed solutions were presented to address these issues.

HRD Corp Briefing on Enhancement of Terms and Conditions of Allowable Cost Matrix

The HRD Corp Sarawak Region conducted a *Briefing on the Enhancement of Terms and Conditions of the Allowable Cost Matrix (ACM)* on 3 December 2024 at Lot 10 Boutique Hotel, Kuching. The objective of the session is to update registered employers and training providers in Kuching on the recent enhancements to the HRD Corp ACM, which took effect on 1 November 2024. The session also aimed to clarify the changes, provide guidance on submitting error-free grant applications, and address any issues related to the process.

Mdm Josephine anak Bujang, Head of Account Management Unit in her welcoming remarks, highlighted that the revisions to the ACM were made to support employers in effectively utilising their levies to train and upskill their workforce. The revised ACM provides a higher ceiling for claimable course fees and the flexibility to claim hourly-based training, providing employers with more options to access HRDF training.

Ms Norsita binti Ali, Associate of the Account Management Unit, provided an overview of the enhancements, noting that HRD Corp had reviewed the ACM to ensure it was relevant and effective for all registered employers. These changes were designed to simplify the grant application process, making it easier

and more flexible for employers to submit their claims, ultimately allowing more employees to benefit from training programmes.

Ms Norsita also shared valuable guidance on submitting error-free grant applications. She reminded all employers the importance of choosing the correct scheme types and course name and providing all necessary details when submitting grant applications to avoid delays or rejections.

Seminar on Fire Safety Organisation

The Human Resource Development Corporation and Fire and Rescue Department jointly organised a "Seminar on Fire Safety Organisation" on 2 December 2024 at Imperial Hotel, Kuching.

The Seminar, which drew approximately 800 participants, including STA Enterprises Sdn Bhd was officiated by Datuk Michael Tiang Ming Tee, Deputy Minister of Public Health, Housing and Local Government. It served as a platform for representatives from the government and the Fire and Rescue Department to network with professionals, private organisations and industry players, while providing insights into the laws and procedures governing fire safety.

Key discussions during the Seminar focused on the proposed amendments to the Fire Services Act 1988. These amendments would require premises owners to establish a Fire Safety Organisation for their properties. The Seminar also outlined the proposed responsibilities of the Fire Safety Manager and Fire Safety Officers within these organisations. These responsibilities include attending mandatory training courses, developing fire emergency response plans and submitting comprehensive fire safety reports. Compliance with these requirements is essential for obtaining the Fire Certificate, which is necessary for premises to operate legally.

The Seminar also highlighted the penalties for non-compliance under the amended Act. Premises owners found guilty of offences may face fines of up to RM50,000 or imprisonment for up to five (5) years, or both.

The proposed amendments and requirements are scheduled to take effect in 2027, pending the gazettement of the Act.

Seminar menekankan cadangan pindaan kepada Akta Perkhidmatan Bomba 1988 yang akan berkuatkuasa pada 2027. Pindaan termasuk keperluan untuk pemilik premis membentuk Organisasi Keselamatan Kebakaran, melaksanakan pelan kecemasan, dan lain-lain, bagi mendapatkan Sijil Kebakaran. Collaborative Efforts under MTA – Advancing ESG and Strategic Directions for the Timber Industry

Several MTA Executive Committee members, represented by timber associations from Peninsular Malaysia, Sabah and Sarawak, including STA, met with Ms Nat Tan, the editor in charge of environmental, social and governance (ESG) at The Edge Malaysia on 20 December 2024. The meeting, held at Menara PGRM Kuala Lumpur, focused on gathering feedback and perspectives from the timber industry across the three regions for a series of articles on ESG topic to be published in the Edge.

Both Mr George Yap, MTA President and Mr Ng Kay Yip, MTA Honorary Secretary proposed a series of stories to reshape public perception of the sustainable timber industry and its alignment with ESG principles. Ms Annie Ting, MTA Honorary Treasurer cum STA Chief Executive Officer proposed introducing MTA's ESG framework for timber industry to the public, highlighting operational enhancement from adopting the ESG framework. The discussion concluded with several proposed article titles to guide the series.

In a separate session, Mr Yap, together with representatives from the associations tasked with reviewing and updating MTA's Malaysian Timber Industry Roadmap (MTIR), namely Sabah Timber Industries Association, Timber Association of Sabah, Malaysian Wood Industries Association and STA convened a meeting.

The meeting also decided to focus on developing a document detailing the strategic directions for industrial tree planting across the three regions, Peninsular Malaysia, Sabah and Sarawak. This decision was made following discussion with the Deputy Minister of Plantation and Commodities, Datuk Chan Foong Hin, held two (2) days prior to the meeting.

The group agreed on the framework for the document, which will be supported by data and practical recommendations for the industry. The framework will be further deliberated at the forthcoming MTA Executive Committee Meeting scheduled for January 2025.

Interim Report Presentation for the Study on IRBM Plan for Batang Rajang and Batang Saribas, Sarawak

The Department of Irrigation and Drainage, Malaysia (DID Malaysia) convened meetings on 4 and 5 December 2024 to facilitate the presentation of interim reports for the Integrated River Basin Management (IRBM) plans for Batang Saribas and Batang Rajang, respectively.

The IRBM study for Batang Saribas is being undertaken by O.B.E Consulting Sdn Bhd, while the study for Batang Rajang is led by KTA (Sarawak) Sdn Bhd. These interim reports mark a critical milestone in the development of comprehensive plans aimed at sustainable management and conservation of these vital river basins.

The meetings provided a platform for the consultants to present their findings and proposed strategies to stakeholders, while enabling discussions and feedback sessions to refine the IRBM plans further. The final reports will guide future efforts in addressing issues such as water resource management, flood mitigation, and ecosystem protection within these river basins. This initiative reflects DID Malaysia's commitment

Malaysia's commitment to fostering an integrated approach to river basin management that balances environmental preservation with socioeconomic development.

Project on 'Promoting Sustainable Wood Use for Domestic Market in Malaysia' – Inception Workshop

The Malaysian Timber Certification Council (MTCC) organised the Inception Workshop for the *'Promoting Sustainable Wood Use for the Domestic Market in Malaysia'* (SWU) project on 18 December 2024, held in Putrajaya, Kuala Lumpur, and via Zoom. The workshop was attended by policymakers, research institutions, timber associations, and industry players to discuss and provide inputs on the project inception report. It also fostered collaboration and cooperation among all participants, paving the way for the effective implementation of the project.

In his opening remarks, Mr Akmal Saarani, Director (Chain of Custody) at MTCC, shared that the SWU project, funded by the International Tropical Timber Organization, is an initiative aimed at enhancing and diversifying domestic consumption while promoting local markets for sustainable wood and wood products in Malaysia. With MTCC appointed by the Ministry of Plantation and Commodities as as the executing agency, this 18-month project has the ambitious goal of increasing domestic consumption, improving supply chains, and reinforcing government policies related to the use of sustainable wood products.

The workshop featured a series of informative presentations, including an overview of the Sustainable Wood for a Sustainable World initiative, a detailed briefing on the project's background, scope, methodologies, and expected outcomes, as well as a presentation on Malaysia's Government Green Procurement initiative. Participants actively engaged during the focus group discussions.

60th Session of the International Tropical Timber Council

The Sixtieth session of the International Tropical Timber Council (ITTC-60) took place from 2 to 6 December 2024 at Pacifico Yokohama, Japan. This year, approximately 180 delegates and observers attended the session.

ITTC-60 commenced with the opening of the Council plenary, during which the Chair, Ms Anna Tyler from New Zealand, urged ITTO members to present a united front.

She emphasised the critical importance of sustainably managed tropical forests and the pivotal role the ITTO can play in safeguarding the long-term health and sustainability of tropical ecosystems.

Five (5) invited guest speakers at the opening are:

- 1. Datuk Haji Len Talif Salleh, Deputy Minister for Urban Planning, Land Administration and Environment, Ministry of Natural Resources and Urban Development, Malaysia
- 2. Mr Hirofumi Takinami, State Minister of Agriculture, Forestry and Fisheries, Japan
- 3. Mr Takeharu Yamanaka, Mayor, City of Yokohama, Japan
- 4. Mr Jorge Rodriguez Zuniga, Vice-Minister of the Environment, Costa Rica
- 5. His Excellency Mr Roberto Seminario Portocarrero, Ambassador of Peru to Japan.

Datuk Haji Len emphasised the central role of timber production in Sarawak's economy. He highlighted the successful implementation of twenty (20) ITTO projects in Sarawak since 1989, valued at over USD 16 million.

He also elaborated on Sarawak's commitment to achieving carbon neutrality, outlining how this ambitious goal will be realised through a combination of sustainable forestry practices, comprehensive conservation efforts, landscape restoration, and the rewilding and rehabilitation of degraded areas.

In addition, the Sarawak Government signed two (2) new projects with the ITTO during the ITTC-60, namely

- Management of Sungai Menyang Conservation Area for Orangutan Protection and Uplifting Community Livelihood, and
- · Critical Upliftment of Local Livelihoods: Urgent Actions for Community-based Conservation and Development in Upper Baram

These projects, focusing on forest conservation and enhancing local livelihoods, aim to empower local communities through conservation efforts, sustainable practices, and infrastructure development, further solidifying Sarawak's commitment to environmental stewardship.



Annual Market Discussion

The Annual Market Discussion for this year was held on 3 December 2024, with the theme "Production and Trade - Rising Costs and Weakening Demand". The discussion focused on timber market conditions and challenges in Brazil, Gabon, Mexico, and Vietnam.

One presentation highlighted how wood properties vary depending on where trees are grown, emphasising the advantages of plantation-grown wood in terms of uniformity and fast growth rates. It also stressed the importance of effective plantation management and noted that ITTO can play a key role in informing species selection for plantations and fostering greater market acceptance of plantation-grown trees.

The final presentation provided an overview of the Global Green Supply Chain (GGSC), China, the Global Timber Index (GTI), and the Global Legal and Sustainable Timber Forum (GLSTF), which is co-hosted by GGSC and ITTO.

The Monthly GTI Report is based on a survey of timber sector enterprises in ten pilot countries, including Malaysia, and reflects trends in timber market sentiment in these countries.

The GLSTF is an annual forum that strengthens connections and cooperation among timber producers, buyers, processors, and market participants. It promotes sustainable forest management, supports the development of a legal and sustainable supply chain for forest products, and encourages the legal and sustainable trade of timber and wood products. The forum aims to foster a stable, transparent business environment while promoting sustainable development and addressing climate change.

The Trade Statement 2024 was presented at the conclusion of the discussion and is shared in the following pages.

Decisions of the ITTC

 Extend the mandate of the Preparatory Working Group (PWG) until the 61st session of the Council to prepare for the negotiation of a new International Tropical Timber Agreement (ITTA).

This group will work on negotiating a new ITTA to replace the current agreement, which expires on 6 December 2029. The PWG is open to all ITTO members, allowing anyone to participate. It will be co-chaired by Mr Daniel Carl (USA) and Ms. Veneska Bethancourt (Panama).

2. Endorse the process for ITTO to obtain observer status at the United Nations General Assembly.

This status will provide ITTO with greater access to high-level international meetings, advancing its mandate to strengthen engagement with external bodies and funding mechanisms.

3. Extend the term of ITTO Executive Director, Ms Sheam Satkuru by two years, until 31 January 2028, in recognition of her leadership.

ITTO's Integrated Fire Management

Another important role of ITTO is supporting Member Producers in developing governance and institutional capacities in Integrated Fire Management (IFM), including the involvement of civil society. This support involves promoting efficient techniques and best practices for preventing and managing fires in tropical regions.

Two ITTO-funded projects on forest fire management have been successfully executed in Indonesia and Peru. The findings and recommendations from these projects will be considered in ITTO's ongoing work in forest fire management, including field-level guidelines.

The ITTO Fire Management for Tropical Forests policy guidelines were first developed in 1997.

TRADE STATEMENT 2024 by the Trade Advisory Group

Chair person Ladies and Gentlemen

The TAG welcomes the proposal from the European Commission to delay the EUDR application date by 12 months to 30 December 2025 which will allow more preparation time for the timber industry to comply. However, the industry is concerned over the uncertainty of the delay as well as new 11th hour amendments, which are problematic for multiple reasons.

While we acknowledge that ITTO is not able to impact either the delay or the regulation, we would be remiss if we did not highlight this issue, given the seismic impacts the EUDR has and will have on the global forestry policy and trade. We urge the Commission to work with both Consumers and Producers to ensure a smooth implementation of the EUDR.

The tropical timber markets are very unsteady at present and there are a lot of unknowns ahead. The World Bank's latest Global Economic Prospects report highlighted the struggles and slow recovery of global trade in 2023 marking one of the weakest performances in 50 years outside of global recessions.

Today, wood product manufacturers everywhere are reeling from skyrocketing shipping costs and irregular shipping schedules due to, firstly, the drought in Panama severely curtailing ship passages through the Canal; and secondly, the ongoing conflicts in the Red Sea region. The complaints about the logistics in exporting timber products are loudest from Vietnam, China, Indonesia, Brazil, and Malaysia.

Exporters in many producer countries are not happy that shipping companies are using the continuing fallout from the Covid pandemic and geo-political conflicts as reasons to increase marine freight and other logistics costs. Prior to these recent increases, freight charges from Southeast Asia to the US or EU were around US\$ 2,000 per 40 foot container.

In the post-Covid pandemic, freight charges soared between US\$ 18,000 - 20,000, and now, because of the war in Ukraine and the Red Sea chaos, freight charges are varying between US\$ 8,000 - 10,000 to the US and EU markets. Ultimately, these costs will not only depress trade but be passed along to the consumer, at a time when price consciousness is an increasing barrier to the use of wood.

So, in the midst of all these global uncertainties, what can ITTO do to help the timber industry?

The Global Legal and Sustainable Timber Forum (GLSTF) was created in 2023 by ITTO and Macao's Commerce and Investment Promotion Institute, and the inaugural Forum was convened in 2023. In September 2024, the GLSTF launched the Action Framework for Promoting Legal and Sustainable Timber Supply Chains to strengthen international collaboration among stakeholders in timber supply chains, promote the sustainable development of the timber industry, contribute to the Sustainable Development Goals, and combat climate change.

In her opening address at GLSTF 2024, ITTO Executive Director Sheam Satkuru asserted that the GLSTF is a collaborative platform of timber industry stakeholders designed to strengthen networking and business exchanges among timber industry stakeholders to facilitate sustainable forest management and the legal and sustainable use and trade of timber and wood products.

During that GLSTF meeting in Macau and subsequent discussions among TAG members globally it was established that the buyers of tropical timber in our traditional markets are not receiving information about the progress tropical timber producers have made and are continuing to make towards SFM. There is a need for a mechanism to communicate, educate, promote, market, and publicise the tremendous progress tropical timber producers have made and are continuing to make since the Rio Earth Summit in 1992 on traceability, legality, and sustainability.

It seems a natural fit now for ITTO and GLSTF to work together on addressing the negative perceptions in the market. Firstly, a Working Group of stakeholders could be formed to define what and how to communicate to the buyers of our products. The information of what the producers have been doing towards SFM could be collated to be used in a campaign to address consumer negative perceptions.

TAG proposes that resources and finances could be set aside to employ a dedicated person to handle this important task. There is a desperate need for a person, working without distractions, to undertake the task with help from all ITTO Members.

This 100% focus on rebuilding demand for tropical timber trade is what TAG seeks from ITTC today. Together, we can create a narrative that demonstrates what we all know – that wood is sustainable, that trade benefits forests, and that together, we can protect tropical forests for the future.

Webinar on Hornbill Habitats in Borneo

The recent webinar on Hornbill Habitats in Borneo brought together over 100 participants, showcasing insights from three (3) expert speakers on the conservation and protection of these iconic birds. The event, moderated by Dr Jessica Lee from Mandai Nature on 10 December 2024, emphasised the urgent need for collaborative action to safeguard hornbill populations and their habitats in the face of mounting threats such as habitat loss, climate change, and poaching.

Dr Anuj Jain from Birdlife International highlighted the need to prioritise resources for hornbill conservation, introducing the concept of Important Hornbill Landscapes (IHLs). This framework uses four (4) criteria to identify critical habitats for hornbills. He shared that through rapid assessments across Sarawak; over 1,500 records were collected, covering 119 sites. Of these, eight (8) sites met the IHL criteria, with an additional five (5) identified as potential IHLs, making a total of

13 priority conservation areas. As seen with the Lanjak Entimau Wildlife Sanctuary, an identified IHL, collaboration is critical to effectively implement site protection and prioritise conservation actions.

Dr Salwa Khalid from the Universiti Brunei Darussalam presented her ongoing research on hornbill distribution in Brunei, where knowledge gaps persist due to limited studies, with the last major publication on Helmeted Hornbills dates back to 2005. She underscored the importance of mixed dipterocarp forests for hornbill habitats, while noting the critical endangerment of the Helmeted Hornbill due to poaching and habitat loss.

Dr Chloe Hatten from the University of Hong Kong discussed the impacts of climate change on hornbill habitats, emphasising that rising temperatures and habitat destruction are forcing species to adapt by shifting to higher altitudes. However, Borneo's island boundaries limit such migrations, highlighting the urgent need for habitat protection beyond current protected areas.

The webinar concluded with a resounding call for awareness, collaboration, and action. The plight of Borneo's hornbills is a shared responsibility, requiring concerted efforts from governments, researchers, non-governmental organisations, and local communities.

STA Manpower Working Group – Discussion on Foreign Workers Transformation Approach

An online discussion with the STA Manpower Working Group was on 23 December 2024. The crucial item discussed in the session was the Foreign Workers Transformation Approach (FWTA) system.

The FWTA system, which is poised to bring some changes to the management of foreign workers, has sparked concerns and there are requests for greater clarities particularly on several key issues, including the associated fees, how it will integrate with existing systems, and the specifics of certain features such as the Foreign Worker ID. Industry representatives, particularly from the timber sector, urged the need for additional consultation and engagement prior to the system's full implementation in January 2025.

The session also addressed the Sarawak Labour Ordinance (SLO) 2024, which was recently passed in the Parliament on 12 December 2024.

The ordinance is currently awaiting the royal assent, after which it will be officially gazetted by the Minister For Human Resources. A key issue raised during the session was the modification of the Employees' Minimum Standards of Housing, Accommodations and Amenities (Act) (Act 446) under the SLO 2024 to better suit the needs of Sarawak.

Additionally, the session covered the Minimum Wage Order 2024, which was gazetted on 4 December 2024. This order introduces a revised nationwide minimum wage rate, increasing it from RM1,500 to RM1,700 per month. The new rate will be implemented in stages: (i) starting 1 February 2025 for employers with five (5) or more employees and employers engaged in activities under the Malaysia Standard Classification of Occupations (MASCO), and (ii) starting 1 August 2025 for employers with less than five (5) employees who do not engage in MASCO-related activities.

The discussion concluded that, while these developments mark important strides in improving manpower conditions nationwide and regionally, members also highlight the need for a balanced approach that takes into account the concerns of both employers and workers. Ongoing dialogue and clarity will be crucial as these systems and regulations come into effect.






EXPORT VALUE OF LAMINATED BOARD / FLOORING BY DESTINATION FROM SARAWAK










EXPORT VALUE OF DOOR PANELS & FRAME BY DESTINATION FROM SARAWAK








