The newly formed STA Carbon Committee held its inaugural meeting on 7 January 2025 at Wisma STA. The meeting was also attended by invited guests, Mr Rahman Khan, Chief Executive Officer (CEO) of Jawala Plantation Industries Sdn Bhd and Ms Brenda Wong from Sabah Timber Industry Association. Mr Joseph Lau, Chairman of the STA Forest Plantation Committee also attended as an observer, having previously expressed his committee's interest in exploring the feasibility of carbon projects in forest plantations.

Ms Annie Ting, CEO of STA in her welcoming remark, highlighted that the STA Carbon Committee was formed in recognition of the critical role the forestry sector plays in addressing climate change and aims to ensure that STA members are well-prepared to navigate the anticipated introduction of carbon-related regulations.

Mr Zion Kong from SaraCarbon Sdn Bhd led the sharing session by providing insights into the challenges, strategies, and key considerations in securing a carbon licence for a conservation and restoration project in Sarawak. He explained the factors influencing project selection, particularly the carbon market value of credits generated from different forest types. The discussion also touched

on the financial implications, including the impact of government-imposed royalties on project feasibility.

Mr Rahman Khan emphasised the company's commitment to integrating Task Force on Climate-related Financial Disclosures for sustainable forest management, required for its Singapore Exchange listing. A carbon stock study revealed that converting natural forests to plantations significantly reduces carbon stock. At a sequestration rate of 7 tons/hectare/year, potential revenue is RM300-RM350/hectare/year, but economic viability is questionable after RM260 is allocated for royalty payments.

Ms Freda Emmanuel from the STA Secretariat provided an overview of the steps involved and fees imposed in applying for carbon licence in Sarawak, as guided by the Forests (Forest Carbon Activity) Rules, 2022. Mr Ling Tiing Tchin, STA Carbon Committee member who is the official representative for STA in the Technical Working Group formed by Malaysia Forest Fund (MFF) to support the development of guidelines on Forest Carbon Offset, also briefed on the works of the TWG. He then led the Committee through the subsidiary guidelines, capturing inputs for onward submission to the MFF.

The meeting also discussed the substantial costs associated with developing a carbon project at length. Concerns regarding the financial burden, compliance with strict requirements, monitoring, certification, and royalty collection led the committee to unanimously agree to outline the costs at each stage of the development process to the Forest Department Sarawak for further discussion.

Engagement Session on Sarawak's 13th Malaysia Plan

The Sarawak Economic Planning Unit (EPU) is currently conducting a study to review and evaluate the implementation of 12th Malaysia Plan in Sarawak and to formulate the macroeconomic framework, develop policies, strategies, and key initiatives with measurable outcomes for the 13th Malaysia Plan (13MP), in alignment with its Post-COVID Development Strategy 2030 (PCDS 2030).

On 17 January 2025, the Sarawak EPU organised an "Engagement Session with the Forest and Natural Assets Sector" at the Borneo Cultures Museum to gather stakeholder feedback on the 13MP. During the session, key targets under PCDS 2030 for the forestry sector were shared, including:

- Increasing timber and non-timber wood forest products export earnings to an annual export value of RM8 billion by 2030;
- Establishing 50 community-based ecotourism and conservation Totally Protected Areas; and
- Certifying 4.5 million hectares of long-term forest license areas and 178,000 hectares of forest plantations under the Malaysian Timber Certification Scheme.

Participants, including STA, discussed the challenges faced by the timber industry. Ms. Annie Ting, Chief Executive Officer of STA, highlighted that the targets are difficult to achieve, given declining production and exports. She also underscored that market prices are failing to match the rising operational costs, particularly for certified timber. Additionally, she shared that

the State Sales Tax (SST), ranging from 1% to 2.5%, was implemented on 1 June 2023, affecting selected timber products exported from Sarawak, including sawn timber, veneer, wood chips, fibreboard, particleboard, and plywood. This new tax has increased production costs, decreased competitiveness and market share, reduced investment, and led to the downsizing of the downstream timber industry. She also emphasised Sarawak's highly regulated operating environment and the substantial additional cost under the Foreign Worker Transformation Approach System, amounting to RM1,854 per foreign worker.

Other concerns raised included the high operational costs, insufficient raw materials—especially for small and medium enterprises—and inadequate infrastructure, such as deep-sea ports which are crucial for improving export logistics.

Sesi libat urus dengan pihak berkepentingan dari sektor perhutanan dan sumber asli pada 17 Januari 2025 mengetengahkan sasaran sektor perhutanan, termasuk eksport bernilai RM8 bilion dan peningkatan pensijilan. Pihak berkepentingan, termasuk STA membangkitkan kebimbangan mengenai pengurangan pengeluaran, kos tinggi, kekurangan bahan mentah dan infrastruktur terhad.

砂拉越经济规划单位正在进行一项研究,检讨砂拉越第十二大马计划,并根据2030年后新冠肺炎疫情发展战略制定第十三大马计划(13MP)。于2025年1月17日举办与森林和自然资源领域利益相关者的交流会议中,重点讨论林业的目标,包括马币80亿令吉的出口额和增加认证。与会的利益相关者包括本会对产量下降、高成本、原材料短缺以及基础设施不足等问题表示担忧。

Engagement Session on Technical Barriers to Trade (TBT) with the Sarawak Industry

The Department of Standards Malaysia (DSM) hosted an "Engagement Session on Technical Barriers to Trade (TBT) with the Sarawak industry sector" on 21 January 2025 at the Hilton Hotel in Kuching.

The session was officiated by Mdm Nor Latifah Hussin, Director of Strategic Planning at DSM. In her remarks, she emphasised the primary aim of the session, which is to raise awareness about DSM's role and the critical importance of standards and compliance in addressing issues related to TBT. She also encouraged open dialogue among participants, urging them to share their challenges and identify potential areas where DSM's support could make a meaningful difference.

The session featured a series of presentations from DSM officers and experts from the Standards and Industrial Research Institute of Malaysia (SIRIM) Academy. Key topics discussed included the critical role of National Quality Infrastructure (NQI) in ensuring industry standards for quality, safety and competitiveness. The significance of Malaysian Standards and their impact on industries was also highlighted. The speakers further outlined the benefits of accreditation, such as eligibility for tax incentives, and provided an in-depth overview of the World Trade Organization (WTO) TBT Agreement. Emphasis was placed on the role of Malaysia's National Enquiry Point and Notification Authority, managed by SIRIM Academy.

A highlight of the session was DSM's instruction of its Standards Compliance Stewardship Programme for Enterprises (ESCAPE), an initiative designed to assist businesses in achieving full standards compliance. The session concluded with a hands-on demonstration of the ePing platform, an innovative tool offering real-time alerts on regulatory changes, tracking Sanitary and Phytosanitary (SPS) and TBT measures, and providing a platform for officials to discuss and comment on upcoming regulatory revisions.

STA Manpower Working Group Meeting No. 1/2025 & Meeting with the Immigration and Labour Management Unit

The STA Manpower Working Group Meeting No. 1/2025 led by Ms Annie Ting, Chief Executive Officer of STA was held on 21 January 2025 at Wisma STA Kuching.

A key agenda discussed was the Foreign Workers Transformation Approach (FWTA) system. The Working Group reviewed its implementation, which seeks to streamline the management of foreign workers and enhance compliance with regulatory frameworks. The effectiveness of the system and its potential long-term impact on the industry were central to the discussions.

Another significant issue addressed was the rising costs faced by labour-intensive industries. Specifically, the additional financial burden of RM1,854 per foreign worker, arising from recent regulatory changes, was a major concern. This added cost presents challenges for businesses that rely heavily on foreign labour, potentially affecting their profitability and operational sustainability. The Working Group explored strategies for managing these increased expenses while maintaining productivity and competitiveness.

The meeting also underscored the importance of continued collaboration among industry and policymakers to address these challenges effectively. Through open dialogue and the exchange of insights, the Working Group aimed

to identify practical solutions that would support the growth and resilience of businesses within the evolving ecosystem.

Following the meeting, STA, led by Ms Ting, held a session with representatives from the Immigration and Labour Management Unit (ILMU), led by Mr Richard Lon, Director of ILMU to discuss the financial aspects of the FWTA system. The meeting focused on evaluating the current cost structure of the FWTA system, exploring potential cost-saving measures, and ensuring the system's long-term financial sustainability.

The discussion also addressed opportunities to optimise the system for greater efficiency, ease of use, and better integration with other governmental and private sector processes. The ILMU shared insights on streamlining administrative procedures, reducing bottlenecks, and improving the user experience for employers and foreign workers alike.

As a result of these discussions, STA proposed several key recommendations for ILMU to put forward at its upcoming steering committee meeting. These are;

 Reduce the RM1,854 charge to establish a more affordable fee structure that industries can absorb without compromising their competitiveness in the region,

- ii. Launch a second-phase pilot project that includes a broader range of industries to allow businesses to better understand the system's functionalities and resolve any issues before full implementation, and
- iii. Introduce a grace period to provide businesses with sufficient time to adjust to the FWTA system without facing undue financial burden, ensuring a smooth transition for industries growth.

Mesyuarat Kumpulan Kerja Tenaga Kerja STA telah diadakan pada 21 Januari 2025, diikuti dengan sesi bersama Unit Pengurusan Imigresen dan Buruh (ILMU), memfokuskan kepada sistem Pendekatan Transformasi Pekerja Asing (FWTA). Perbincangan utama termasuk menilai struktur kos sistem, kesannya terhadap perniagaan dan meneroka langkah penjimatan kos. Cadangan daripada STA termasuk mengurangkan caj, melancarkan projek perintis fasa kedua dan memperkenalkan tempoh tangguh untuk menyokong penyesuaian dan daya saing industri.

本会人力资源工作小组于2025年1月21日召开会议,并随后与移民及劳工管理单位(ILMU)会面,重点讨论外籍员工转型方法(FWTA)系统。会议的主要议题包括评估该系统的成本结构、分析其对企业的影响以及探索节约成本的措施。本会提出的建议包括降低费用、启动第二阶段试点项目,并引入宽限期,以支持工业适应和提升竞争力。

Meeting with Datu Buckland Bangik

On 3 January 2025, Ms Annie Ting, Chief Executive Officer of STA, attended a meeting with Datu Buckland Bangik, Deputy State Secretary, at the invitation of the Foreign Worker Liaison Task Force under the Sarawak Business Federation at the Deputy State Secretary (Administration) Office, Wisma Bapa Malaysia.

Ms Ting raised about the financial burden imposed by the new fee of RM1,854 per foreign worker under the new Foreign Worker Transformation Approach system, which is set to take effect on 15 January 2025. She emphasised that this fee could strain businesses, particularly those reliant on foreign workers.

Datu Buckland clarified that the fee was intended to be a cost-saving measure, not an additional burden and agreed to organise regional briefings with Immigration and Labour Management Unit (ILMU) and SBF after the Chinese New Year 2025 break to address the issue and acknowledged a request to delay implementation until after these briefings. STA plans to work with ILMU to review industry costs and gather feedback from its members.

Pada 3 Januari 2025, Cik Annie Ting, Ketua Pegawai Eksekutif STA telah bertemu dengan Datu Buckland Bangik untuk membincangkan kos RM1,854 bagi setiap pekerja asing di bawah sistem Pendekatan Transformasi Pekerja Asing (FWTA). Datu Buckland menjelaskan bahawa ianya merupakan langkah penjimatan kos dan bersetuju untuk mengadakan taklimat serta kemungkinan penangguhan. STA akan bekerjasama dengan ILMU bagi mendapatkan maklum balas daripada industri.

2025年1月3日,本会首席执行员陈燕贞小姐与拿督巴克兰会面,讨论外籍员工转型方法系统下每名外籍员工马币1,854令吉的费用。拿督巴克兰澄清这是一个节省成本的措施,同时也同意举行简报会并可能推迟实施。本会将与移民及劳工管理单位(ILMU)合作收集工业反馈。

Briefings on Foreign Workers Transformation Approach System

The Sarawak Government, through the Immigration and Labour Management Unit (ILMU), is implementing the Foreign Workers Transformation Approach (FWTA) system to improve and streamline the recruitment process for foreign workers in Sarawak. Officially launched on 15 January 2025, the FWTA system aims to simplify the approval and processing procedures across key agencies such as Social Security Organisation, Labour Department, ILMU, Immigration Department, and the State Health Department.

A series of briefings were held at Kingwood Hotel Sibu, Promenade Hotel Bintulu, and Penview Convention Centre Demak Kuching on 15, 17, and 22 January 2025, respectively, with another session scheduled for February in Miri. These sessions provided updates on the system and discussed efforts to strengthen Sarawak's autonomy in managing the entry of non-resident workers into Sarawak.

In Kuching, Datuk Gerawat Gala, the Deputy Minister in the Premier's Department, addressed the audience, explaining that the RM1,854 fee under the FWTA system, developed under the public-private partnership model, covers a range of services, including infrastructure development, digitalisation, permit issuance, Foreign Worker Identity Cards (FWIDs) and other employer services. He reminded employers to apply for foreign workers only when necessary and assured them that Sarawak would maintain transparency in quota approvals. He added that the government aims to leverage the FWTA system not only to streamline processes for employers but also to enhance enforcement and combat illegal employment.

Mr Carolineson Nosin, Principal Assistant Director of the ILMU Development Division, explained that the FWTA system would significantly reduce the processing time for applications, from approximately

six (6) months to about two (2) months, based on a successful pilot project. He also mentioned that ILMU shall be monitoring the applications in the FWTA to ensure timely processing and urge the relevant government agencies for faster action, should delay occurs.

The FWTA system comprises five (5) key modules developed by a Sarawakian technology firm, SOCOE Sdn Bhd. These are JobSarawak, Sarawakian and Non-Sarawakian Online Labour System (SANSOLS), Sarawak Foreigners Health Information System (SAFHIS), FWID and the Enforcement Tracking System. These modules, accessible via https://links.sarawakforeignworkers.com/ are designed to reduce waiting times, improve service delivery through online applications, and ensure transparency with comprehensive audit trails. Additional modules for expatriates and domestic helpers are set to be launched in 2026, further expanding the system's capabilities.

In the question and answer sessions following the briefings, Ms. Annie Ting, Chief Executive Officer of STA, has been advocating for a grace period of 6 months to 1 year, during which no fees should be collected from the industry. This transition period would allow industries to fully adapt to the new system while giving the Government and stakeholders time to evaluate the associated fees, address potential challenges and implement necessary adjustments. By ensuring a smooth integration process, this approach aims to minimise financial burdens on businesses and promote long-term industry sustainability. Participants raised concerns about issues such as the quota matrix for approval in principle, the nonrefundable but transferable elektronik Visa Dengan Rujukan (eVDR), the ability to manage multiple companies under one account, and the process for biometric data collection for FWID. Other issues discussed included mobile services for workers aged over 60, payment methods, file uploading capacity in SANSOLS, and data modifications in SANSOLS.

On 15 January 2025, STA issued a media statement expressing its concerns over the implementation of the FWTA system and urged the Premier of Sarawak to intervene and initiate meaningful discussions with stakeholders to ensure a balanced approach that considers the needs of businesses while achieving regulatory objectives.

Media Statement

Hefty FWTA Charges: STA Calls for Action to Alleviate the Burden on Industry

STA is taken aback by the implementation of the Foreign Workers Transformation Approach (FWTA) system, which is owned by the Sarawak Government. The system took effect on 15 January 2025, coinciding with the first briefing session organised by the Immigration and Labour Management Unit (ILMU) in Sibu.

This session, along with the subsequent briefing sessions scheduled for Bintulu and Kuching on 17 and 22 January respectively, only marks the beginning of the State-wide consultation with industrial stakeholders. While these sessions are intended to provide a platform for learning about the new system and offering feedback, implementing the system concurrently has not only left stakeholders with no viable options but also provided limited opportunity to prepare adequately or address critical concerns and potential shortcomings of the new system.

The introduction of the RM1,854.00 per worker charges has a drastic impact on the business environment. This sudden imposition, coupled with inadequate prior notice, consultation and transition period, has sparked widespread concerns across various industries in Sarawak.

This additional cost, unique to Sarawak (not applicable to Sabah and Peninsular Malaysia), poses a significant threat to the industry's competitiveness in the national, regional and international markets, particularly as industries are already burdened by charges imposed by the Federal Government. The collection of RM1,854.00 per worker could hinder industry's ability to remain sustainable in an increasingly challenging economic environment.

For the industry to remain sustainable, there is an urgent need for a regulatory environment that supports long-term growth and fosters a conducive atmosphere for development. In light of this, STA appeals to the Premier to intervene and urges the Sarawak government to defer the implementation of the FWTA charges until meaningful consultations with stakeholders, including STA, are conducted and their concerns are fully addressed.

SARAWAK TIMBER ASSOCIATION 15 January 2025

Kerajaan Sarawak telah melancarkan sistem Pendekatan Transformasi Pekerja Asing (FWTA) pada 15 Januari 2025 untuk menyelaraskan pengambilan pekerja asing. Taklimat yang berlangsung di seluruh Sarawak telah memberi maklumat terkini kepada pihak berkepentingan mengenai pelaksanaannya serta menekankan bahawa sistem tersebut mengurangkan tempoh pemprosesan daripada enam bulan kepada dua bulan. Selain itu, bayaran sebanyak RM1,854 yang dikenakan meliputi pembangunan infrastruktur, pendigitalan, pengeluaran permit, kad pengenalan pekerja asing serta perkhidmatan majikan yang lain. Susulan pelancaran sistem tersebut, STA telah mengeluarkan kenyataan media menyuarakan kebimbangan terhadap kesan yuran itu dan menggesa Premier Sarawak untuk campur tangan.

砂拉越州政府于2025年1月15日推出外籍员工 转型方法(FWTA)系统,旨在简化外籍员工的 招聘程序。州内各地举行的简报会向利益相关 者通报该系统的实施情况,并强调该系统将处 理时间从六个月缩短至两个月,且马币1,854 令吉的费用涵盖基础设施建设、数字化、许可 证发放、外籍员工身份证及其他雇主服务。在 系统推出后,本会发布媒体声明,表达对该费 用影响的担忧,并呼吁砂总理介入处理。

Stakeholder Engagement on Sarawak **Net Zero Strategy and Carbon Plan**

On 24 January 2025, PwC Malaysia engaged with STA to discuss climate goals and industry development ambitions, contributing to the formulation of Sarawak's Net Zero Strategy and Carbon Plan under the Ministry of Energy and Environmental Sustainability. Held at Wisma STA, the meeting followed an earlier online engagement session that introduced the initiative.

Currently in its early stages, the initiative focuses on data collection across key sectors, including "Forestry and Land Use" to establish a comprehensive emissions baseline. This baseline will be essential for setting realistic decarbonisation targets and tracking progress toward Sarawak's net-zero goals. Accurate greenhouse gas emissions estimates derived from this data will also strengthen Sarawak's climate strategy.

The engagement marks an important step in ensuring that the forestry sector's contributions and challenges are well understood and effectively integrated into Sarawak's broader climate framework. By actively participating in this initiative, the industry can align itself with global sustainability trends while ensuring the continued viability of Sarawak's forestry sector.

Pada 24 Januari 2025, PwC Malaysia mengadakan sesi penglibatan dengan STA untuk membincangkan Strategi Sifar Bersih dan Pelan Karbon Sarawak. Inisiatif itu, pada peringkat awalnya memberi tumpuan kepada pengumpulan data merentas sektor utama termasuk perhutanan untuk mewujudkan garis dasar pelepasan dan menetapkan sasaran penyahkarbonan.

2025年1月24日,普华永道马来西亚(PwC Malaysia)与本会交流并讨论砂拉 越的净零策略和碳计划。该举措处于初期阶段,重点在于收集包括林业在 内的关键行业的数据,以建立排放基准并设定脱碳目标。

Meeting on Sarawak Engineered **Wood Product Blueprint** 2030

The Sarawak Engineered Wood Products (EWP) Industry Development Blueprint 2030, launched on 27 November 2024 outlines a comprehensive plan to foster a sustainable, innovative, and globally competitive EWP sector, aligned with modern construction demands, economic growth, and environmental conservation.

In order to carry out few identified strategies outlined in the Blueprint, STA Secretariat team lead by Ms Annie Ting, Chief Executive Officer attended an engagement session called by the Sarawak Timber Industry Development Corporation (STIDC) on 9 January 2025 at STIDC Head Office, Petra Jaya. STIDC Advisor, Datu Haji Hashim bin Haji Bojet stressed the importance of involvement and collaboration between STIDC and the timber industry to develop EWP industry sustainably especially during this transition period.

Ms Ting acknowledged that the EWP sector is a key growth area for the timber industry. However, she emphasised that several critical issues need to be addressed for its success, particularly

the escalating operational costs. She also highlighted the challenge posed by the lack of secured timber licence tenures, even in areas with sustainable forest management certification. Another concern raised was the Foreign Workers Transformation Approach (FWTA) system, a centralised system designed at streamlining the recruitment process. While the system enhances efficiency, it also introduces an a new fee of RM1,854 per worker, which could place further strain on already tight operational budgets.

STA also highlighted the need for strong government support to propel the EWP industry's growth. The introduction of the State Sales Tax (SST) and the closure of primary timber product mills contributed to a decline in timber export values last year. In light of these challenges, STA called for government assistance in the form of cost-reducing incentives and fee waivers to mitigate these challenges.

Malaysian Timber Association (MTA) Executive Committee **Meeting No. 1/2025**

Nine (9) members and two (2) executive advisors of the Malaysian Timber Association (MTA) attended the Executive Committee Meeting No 1/2025 chaired by its President, Mr George Yap on 13 January 2025 at Menara PGRM Kuala Lumpur.

The Committee were informed of the outcome of meetings and discussions on several key issues, including the publication of articles for the timber industry in The Edge, Malaysia's continued role as Chairman of the European Union Deforestation-free Regulation Coalition for another year until 31 December 2025, and the Malaysian Timber Industry 10-Year Roadmap, with a focus on the proposed national policy for Industrial Tree Plantation (ITP). Other topics included updates on the MTA website and more.

The Committee also discussed and deliberated on urgent matters requiring immediate response, such as employers bearing the EPF contributions for foreign workers; the implementation of the Bureau of Indian Standards by India; the listing of ITP suppliers for potential supply of raw materials and training programmes offered by the Wood Industry Skills Development Centre.

"KetekSaja" Application – Briefing & Launching

On 23 January 2025, Mr Augustine Chin Lee Hin. Chairman of the Sarawak Federation (SBF) Business Foreign Worker Liaison Task Force, conducted a comprehensive online briefing KetekSaja, a mobile recruitment application (app). The session, attended by 50 from member participants companies of STA, provided in-depth understanding of the app's functionality in streamlining foreign worker recruitment while ensuring transparency and efficiency.

During the briefing, Mr Chin explained the Indonesian costing for job orders, the endorsement fee structure at a cost of RM1,620 per worker and the process of uploading job order information onto KetekSaja. Participants were guided on maintaining accurate data to ensure compliance with regulatory standards. The session also served as a platform for discussion, addressing specific concerns and exchanging best practices for effective app usage.

The following day, on 24 January 2025, the SBF officially launched *KetekSaja* at the Sarawak Club Kuching. The launch was officiated by Dato Sri Abang Haji Abdul Karim bin Tun Abang Haji Openg, President of the SBF, in the presence of dignitaries such as Datu Buckland Bangik, Deputy Sarawak State Secretary (Adminstration) and Mr

Augustine Wong Chung Ho, Chairman of the Sarawak Housing and Real Estate Developers' Association, along with other SBF members, invited associations and industry stakeholders including STA.

Dato Sri Abang Haji Abdul Karim in his officiating speech highlighted the app's role in addressing manpower shortages that have been hampering Sarawak's industrial progress. He also shared that *KetekSaja*, developed in collaboration with the Sarawak Information System (SAINS) in 2022, features a real-time database that updates employers immediately when a candidate is hired. This prevents duplicate hiring efforts and enables business to focus on other available candidates, ensuring a seamless recruitment process.

Mr Chin added that *KetekSaja* eliminates outdated recruitment practices, such as agents providing only passport copies without proper verification. He noted that employers requesting 50 workers may receive up to 500 applications from different regions, allowing greater flexibility and choice. The app also addresses logistical challenges, such as verifying the validity of medical examinations.

To ensure the app meets the diverse needs of various industries, SBF is collaborating with key industry associations, including the Sarawak Oil Palm Plantation Owners Association and the Sarawak Marine Industry Association. *KetekSaja* is available for free at www.keteksaja.com and has established offices in Kuching, Sibu, Bintulu and Miri to support employers and job seekers across Sarawak.

Meeting of MEF East Malaysia Region Members No. 1/2025 – Minimum Wages Order

The Malaysian Employers Federation (MEF) East Malaysia (Sarawak) Region convened its first meeting of the year on 20 January 2025, presided over by Ms Dayang Jamillah binti Tun Abang Muhd Salahuddin, the Consultant-Industrial Relations of MEF Sarawak. The meeting featured a session on the Minimum Wages Order (MWO) led by Mr Abdul Rahim bin Abdul Razak, Deputy Secretary of the National Wages Consultative Council (NWCC) Putrajaya, who addressed key aspects of the updated Minimum Wage (MW) policies.

The session aimed to clarify the MWO and its impact on both employers and employees. Mr Abdul Rahim shared that the national MW has increased from RM1,500 to RM1,700 under the 2024 policy. He emphasised that the MW is designed to meet workers' basic needs, improve social protection, reduce reliance on low-skilled foreign labour, and align with global standards. Key factors in determining the MW include the poverty line income, median wage, labour productivity, changes in the consumer price index and adjusted unemployment rate.

He added that starting 1 February 2025, employees paid by the hour must earn at least RM8.72 per hour to comply with the updated MW. Non-compliance penalties may range from RM10,000 and RM50,000. Companies with fewer than five (5) employees must adhere to MW regulations by 1 August 2025, with no extensions allowed.

The meeting also addressed the relationship between the Progressive Wage Policy (PWP) and MW. The PWP enables employees earning above the MW to progress through structured wage increments based on their skills and experience. Additionally, the Wage Council is considering regional adjustments to the MW, particularly between Sarawak and Peninsular Malaysia.

The meeting concluded with the election of a new Chairman for MEF Sarawak, where Mdm Norhayati binti Johari of Senari Synergy Sdn Bhd was re-elected to serve as Chairman for MEF Sarawak in 2025.










EXPORT VALUE OF LAMINATED BOARD / FLOORING BY DESTINATION FROM SARAWAK






EXPORT VALUE OF MEDIUM DENSITY FIBREBOARD BY **DESTINATION FROM** SARAWAK






EXPORT VALUE OF DOORSKIN BY **DESTINATION FROM** SARAWAK






EXPORT VALUE OF PARTICLEBOARD BY **DESTINATION FROM SARAWAK**






EXPORT VALUE OF DOOR PANELS & FRAME BY **DESTINATION FROM** SARAWAK








EXPORT VALUE OF CHARCOAL & BRIQUETTE BY DESTINATION FROM SARAWAK






