STA Forest Plantation Committee: Strategic Meetings, Site Visits and Engagements

On 23 July 2024, seven (7) members of the STA Forest Plantation Committee visited the research laboratory at Universiti Malaysia Sarawak (UNIMAS) and the Kelampayan trial plot at Sejingkat to assess the growth of tissue-culture clones of Kelampayan, developed through STA-funded research and development (R&D) projects. The visit also included a review of the assets procured under these projects and a discussion with the project leader to evaluate progress and plan future steps for the Kelampayan tree improvement projects.

Following the site visit, the Committee convened the STA Forest Plantation Committee Meeting No.3/2024 at Wisma STA, Kuching. The agenda included updates on the royalty and assessment methods for planted logs, as well as progress reports on various R&D projects conducted in collaboration with UNIMAS, member companies and other agencies. Additionally, the meeting discussed the training course on log extraction for forest plantations, and preparation for the upcoming Engagement Session with the Forest Department Sarawak (FDS).

The following day, the Committee members attended an engagement session with the FDS at their headquarters in Petra Jaya. Dr. Affendi Bin Suhaili, Assistant Director of Forests, provided insights into technological advancements for managing and monitoring forests across Sarawak. He briefed the Committee on integrated web-based systems, including the Enterprise Forest Information Management System, the Sarawak Logs Tracking & Forest Revenue System, and the Licensee Portal.

A demonstration was given on operating these systems to monitor forest area conversion dates and collect geo-coordinates, ensuring compliance with relevant regulations such as the European Union Deforestation-free Regulation.

Dr. Affendi also updated the Committee on the mechanised tree planting project and elaborated on the use of Light Detection and Ranging (LiDAR) and satellite imagery to measure the productivity of industrial forest plantations, highlighting both the benefits and limitations of these methods.

The Category Meeting discussed activities for the annual budget allocation for the year 2024, including participation in the upcoming 24th Tri-Nations Joint Plywood Meeting to be held on 17 September 2024 in Tokyo, Japan. Additionally, the Meeting was updated on real-time market news and agreed to continue the efforts to lobby the Government to act against anti-dumping duties imposed on Malaysian plywood exported to Korea.

During the Committee Meeting, members discussed the current log production and supply situation in Sarawak, including the promotion of bamboo plantations by the Sarawak government.

They also proposed an outreach programme with plywood manufacturers who are not STA members to gain new ideas. The Committee emphasised engagement with the Singapore Green Building Council and relevant authorities to explore the future of engineered wood production and export, as well as to address building and fire codes.

Technical Committee Meeting No.2/2024 on Product Development Using Plantation Timber

The Product Development using Plantation Timber (PDPT) project, a collaborative initiative between the Malaysian Timber Council and the Malaysian Wood Moulding and Joinery Council, aims to systematically evaluate the viability of utilising plantation timber as a raw material in the timber industry.

On 5 July 2024, the Technical Committee of PDPT convened its second meeting, chaired by Mr Chong Yu Khang, the project leader, in a hybrid format. STA, as one of the Technical Committee members, attended the meeting and discussed on sourcing of plantation timber, planned tests, and the type of products

Visit by Capital Markets Malaysia

Capital Markets Malaysia (CMM), established by the Securities Commission Malaysia in 2012 to promote Malaysia's capital market in Malaysia, collaborates mostly with listed companies and recently, with the small and medium enterprises (SMEs). Their initiatives focus on preparing SMEs for growth and potential listing, with a significant emphasis on advancing sustainable practices and environmental, social and governance (ESG) compliance among SMEs engaged with larger entities.

On 9 July 2024, Ms Navina Balasingam, General Manager of CMM, accompanied by Mr Muhammad Al Fadzriq, Head of Stakeholder Engagement, visited STA during their trip to Kuching to engage with Sarawak's broader business community. The STA Secretariat, led by its CEO, Ms

to be developed. Budget allocations were deliberated to ensure efficient resource management. Furthermore, updates were provided regarding ongoing negotiations with research institute to optimise testing costs. The committee also proposed extending the project duration to allow for a comprehensive study within adequate time. Annie Ting, welcomed the CMM representatives and facilitated a fruitful discussion on initiatives that could benefit the timber industry in Sarawak.

Ms Navina highlighted several key CMM initiatives and discussed the Simplified ESG Disclosure Guide (SEDG) for SMEs, launched in October 2023. While it is not compulsory for SMEs to disclose ESG information, these guidelines support SMEs in navigating increasing demand for ESG disclosures, crucial for maintaining business relationships with larger companies. She also shared CMM's commitment to supporting SMEs through nationwide workshops, including an upcoming SEDG Adopter Workshop for SMEs at Hilton Kuching on 20 August 2024. STA members are encouraged to participate, ensuring they benefit from guidance to navigate evolving market expectations.

Strengthening Green Building Ties: Malaysian Timber Industry Explores Sustainability in Singapore

To promote Malaysian timber products in Singapore, a delegation of 12 industry leaders from the Malaysian Timber Association (MTA), supported by the Malaysian Timber Council (MTC), visited Singapore from 10 to 12 July 2024. Led by MTA President Mr George Yap, the visit aimed to explore Singapore's green building initiatives and sustainability practices, as well as to forge partnerships with key stakeholders, including the Singapore Green Building Council (SGBC), the Building and Construction Authority (BCA), and JTC Corporation (formerly known as Jurong Town Corporation). The delegation was also joined by STA's Chief Executive Officer, Ms Annie Ting, who serves as the Honorary Treasurer of MTA.

During the visit, the Malaysian delegation attended the Green Real Estate Trends Conference hosted by SGBC on 11 July 2024, at Singapore Management University (SMU), with about 200 participants in attendance. At the conference, Mr Yap delivered a presentation on "Sustainability Transformation in the Malaysian Timber Industry" where he highlighted the robust trade partnership between Singapore and Malaysia. He emphasised Malaysia's readiness for research and development collaboration in green building materials and mass timber architecture, stressing the importance of innovative cooperation between the two (2) nations. Mr Yap also outlined Malaysia's significant advancements in timber industry sustainability and its commitment to becoming a leading global timber supply chain.

The conference featured ten (10) papers that addressed the latest developments in sustainability within the built environment. It brought together industry leaders, sustainability experts, and key stakeholders to explore trends and innovations in green real estate, sustainable building materials, green certifications, regulatory frameworks, and the evolving industry landscape.

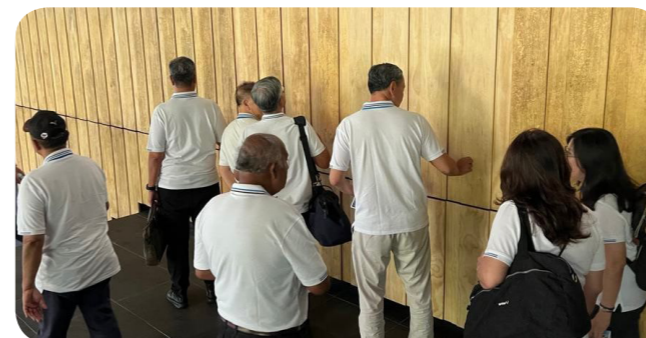
In conjunction with the visit, the Malaysian delegation participated in engagements and site visits. The engagements with Singaporean stakeholders, including SGBC, BCA and JTC Corporation, provided valuable insights into Singapore's advanced sustainability practices. These included stringent green building regulations, innovative timber applications such as cross-laminated timber (CLT) and glulam, and the strong market demand for sustainable, high-quality timber products.

The delegation also discussed challenges faced by the timber industry, such as regulatory differences, technological adaptation, and market acceptance. Despite these challenges, significant opportunities were identified, including the adoption of advanced construction techniques, the enhancement of certification standards, and the potential for collaborations with Singaporean counterparts to develop sustainable building solutions.

The Malaysian delegates also visited timber buildings at the Built Environment Innovation Hub and SMU Connexion, where they observed innovative timber applications and their role in Singapore's green building initiatives. They recommended engaging in collaborative research with Singaporean counterparts to address challenges such as humidity, fungal attacks, termite management, and fire safety in timber construction. Both parties acknowledged that sharing knowledge and best practices would be advantageous in overcoming these issues. Additionally, the Singapore Fire Code was acknowledged as a valuable reference for Malaysia to improve its fire safety standards.

Study on Integrated River Basin Management Plan for Batang Rajang Basin – Presentation of Interim I Report

The Department of Irrigation and Drainage, Malaysia (DID Malaysia) commissioned consultant, KTA (Sarawak) Sdn Bhd to develop a holistic Integrated River Basin Management (IRBM) Plan for Batang Rajang Basin, Sarawak to ensure the basin's water resources remain plentiful and clean, reduce flood risk and improve environmental conservation. A study for the plan commenced in September 2023 and on 18 July 2024, DID Malaysia gathered stakeholders at the Grand Margherita Hotel, Kuching for the presentation of the Interim I Report.

The team of consultants provided a comprehensive analysis of the collected data and identified key issues within the basin, covering land use and socio-economic, engineering as well as scientific and environmental aspects. It was shared that as of January 2024, a strong focus on sustainable practices demonstrated by the 17 Forest Management Units and 2 Forest Plantation Management Units in the Batang Rajang Basin covering an area of 1,442,805 hectares and 24,654 hectares respectively is crucial for ensuring long-term ecological balance.

The development of the IRBM Plan represents a critical step towards achieving a balanced and sustainable management framework for the Batang Rajang Basin. As the project progresses, the continued collaboration among various stakeholders will be pivotal in overcoming the challenges and safeguarding the basin for the benefit of all communities involved.

Aligning PEFC ST 1003 with EU Deforestation-free Regulation: Stakeholder Consultation on Proposed Modifications

The Programme for the Endorsement of Forest Certification (PEFC) organised a public consultation for the alignment of its generic forest management standard (ST 1003) to the definitions and provisions of the European Union Deforestation-free Regulation (EUDR) and ensure compatibility of its system with the regulation. To achieve alignment with the EUDR, the PEFC has established working groups on Sustainable Forest Management (SFM), Chain of Custody, and a Task Force on data.

The working group on SFM has proposed 41 modifications to ensure that PEFC-certified materials from certified forests comply with the requirements of the EUDR. These modifications encompassed the EUDR forest categorisation structure, geolocation information, and addressing forest degradation. PEFC's public

consultation aimed to gather feedback on the proposed amendments to the ST 1003 in order to ensure that the updated standard addresses stakeholder concerns.

To enhance understanding among stakeholders in Malaysia on the 41 proposed modifications to the ST 1003, the Malaysian Timber Certification Council (MTCC) organised a stakeholder session on 2 July 2024. The session was held to clarify and explain the 41 proposed modifications and was attended by officials from ministries, government agencies, State forestry departments, and industry players.

Dr Farrah Shameen Mohamad Ashray, Chief Executive Officer of MTCC outlined the details of PEFC's public consultation and the objective of the session, which include disseminating

information on the EUDR and defining the Malaysian context for the proposed modifications to ST 1003; providing a platform for Malaysian stakeholders to seek clarification, offer feedback, and engage in discussions on the EUDR and the proposed modifications; and empowering Malaysian stakeholders to contribute valuable inputs, feedback, and perspectives through an online form.

Dr Agkillah Maniam, Director (Forest Management) of MTCC, delivered a comprehensive briefing on the proposed modifications and their implications for the Malaysian context. All stakeholders were encouraged to submit their feedback and views via online by 13 July 2024.

Virtual Launch - FSC Aligned for EUDR

On 7 July 2024, the Forest Stewardship Council (FSC) unveiled its latest initiative aimed at bolstering sustainability efforts across European supply chains; the FSC Aligned Certification for European Union Deforestation-free Regulation (EUDR). This new certification marks a significant step forward in meeting the stringent regulatory expectations set forth by the EUDR, which is scheduled to come into effect for most companies by 30 December 2024.

Over the past 18 months, the FSC has been diligently crafting tools to aid certificate holders in aligning with the EUDR requirements. The FSC Aligned Certification for EUDR acts as an add-on module to the existing FSC certifications, enhancing them with specific measures around risk assessment, due diligence, and transparency within supply chains. This initiative encompasses the FSC Regulatory Module and the FSC Risk Assessment Framework, designed to ensure compliance with regulatory expectations while maintaining the FSC's rigorous standards in responsible forestry practices.

During the launch event, key figures from the FSC including Mr Marc Jessel, Chief System Integrity Officer, Ms Xenia Marx, Programme Manager Business Marketing, Ms Jannicka Murphy, Policy Outreach Manager,



and Mr Trevor Armel, Director of Marketing, presented the details of the new certification. They highlighted how the FSC Aligned Certification for EUDR, particularly through its Regulatory Module, provides essential guidance for Forest Management, Chain of Custody, and Controlled Wood Certification processes, simplifying the path to compliance for companies seeking to navigate the complexities of the EUDR.

Moreover, the FSC emphasised its proactive support for businesses, with over 20 companies already benefiting from its Early Adopters Onboarding Programme for the FSC Aligned Certification. This initiative aims to facilitate a smooth transition for businesses by offering practical tools and guidance well ahead of the regulatory deadline.

One of the key components of the new certification is the FSC Trace platform, which promises to revolutionise verification and data transparency within supply chains. By leveraging advanced technology and robust data collection mechanisms, FSC Trace aims to provide end-to-end traceability of FSC-certified products, thereby enhancing accountability and compliance under the EUDR.

Meeting No.1/2024 of the Technical Committee on Plywood Certification Standard

The Malaysian Timber Industry Board (MTIB) Certification Body (CB) convened the Technical Committee on Plywood Certification Standard Meeting No 1/2024 in Bintulu on 2 – 3 July 2024. The 2-day meeting was chaired by Dr Paridah Md Tahir from the Institute of Tropical Forestry and Forest Product, Universiti Putra Malaysia (UPM).

The committee continued its review and revisions of the MTIB-CB-PS-01:2024 – Plywood Certification Standard, following the previous meeting held on 14 – 15 November 2023 in Kuala Lumpur. MTIB-CB-PS-01:2024 specifies the requirements for plywood panels to be granted with Product Certification Standard by MTIB under Sub-section 12 (2)(k) of the Malaysian Timber Industry Board (Incorporation) Act 973 (Act 105). This standard is developed in conformity to the ISO/IEC 17067 Scheme Type 5, providing certification and recognition for the timber quality assurance scheme.

During the 2-day meeting, the technical committee members reviewed various sections of the MTIB-CB-PS-01:2024, including the committee representation listing, scope, normative references, terms and definitions, product specification, sampling, requirements for Product Certification Scheme for the company as well as the Annexures A to D. These annexures cover surface appearance grading, methods for determining moisture content, bonding quality, bending strength and Modules of Elasticity. The meeting also received lab test findings comparing

bending testing methods between the European Standard (EN) 310 and the Japanese Agriculture Standard (JAS).

To provide the committee with practical insights into operational parameters, scope and standards used in Sarawak's plywood factories, a visit to Tai Ming Timber at Kemena Industrial Estate Bintulu was organised on 1 July 2024. The 15-member team was welcomed by Mr Wong Sing Kui, Managing Director of Tai Ming Timber. The visit aimed to ensure that the plywood certification standard document aligns with industry best practices and meets current requirements.

Workshop for the National Industrial Harmony Index Study 2024

The Department of Industrial Relations Malaysia (DIRM) and UPM Consultancy & Services Sdn Bhd jointly hosted a workshop on 29 July 2024, at Raia Hotel & Convention Centre Kuching for the National Industrial Harmony Index (IHI) Study 2024, conducted biannually under the 12th Malaysia Plan, to assess national industrial harmony through the National IHI Score. Over 100 human resources professionals from various companies and agencies attended the event.



Ms. Noorlia Binti Mahlee, Assistant Director of the Sarawak Industrial Relations Department, delivered her presentation

Ms Noorlia Binti Mahlee, Assistant Director of the Sarawak Industrial Relations Department highlighted in her presentation that the primary mission of the industrial relations department is to foster and maintain harmonious relationships between employees, employers and trade unions. She also discussed the department's role in offering advisory services, conducting harmony visits, engaging in social dialogue and organising symposiums to prevent industrial disputes.

Mr Azmi A/L Harun, Assistant Director of the Planning & Policy Research Division at DIRM, encouraged employers to use the IHI Self-Assessment (IHI SA) to help assess and improve employee-employer relationships. He provided an overview of the IHI programme's evolution, which includes several phases and reiterated that the initiative is part of a broader effort to enhance industry harmony and effectiveness. Ms Amira Syaban Binti Rosli, Senior Assistant Director of

the Planning & Policy Research Division at DIRM informed participants that the National IHI from years 2017 to 2022 showed an upward trend from 75.9% to 78.9%, reflecting harmony levels, which could potentially exceed 90% in the future. She also highlighted that maintaining strong employee relations boosts productivity, attracts investors and contributes to gross domestic products growth and competitive rankings.

Dr. Suriani Binti Ismail, Senior Lecturer of the Faculty of Educational Studies at Universiti Putra Malaysia explained how Industrial Relations Information System 2023-2025 (IRIS) functions. Before registering via IRIS, employers must first appoint an Employer IHI Manager (Pengurus IHI Majikan, PIM) to manage the IHI survey, notify employees about IHI and disseminate survey link to employees for their response. She added that IRIS provides employers access to their accounts to review their company's performance score and receive improvement recommendations based on the IHI Score.

Starting 1 June 2024, employers can register their companies with IRIS, which will then automatically generate each company's IHI Score, contributing to the National IHI Score 2024. This score is assessed across five (5) dimensions namely Nurturing Relationship, Connectedness, Mutual Cooperation, Mutual Peacemaking and Being Responsible. Companies using the IHI SA will gain four (4) benefits such as Company IHI Score, IHI Report Card, Harmony Company Rating Certificate, and Harmony Company 2024 Recognition.

Briefing on Non-Employment Related Injury Scheme

The Social Security Organization (SOCSO) provides various types of injury claims under the Employment Injury Scheme (EIS). This EIS covers medical benefits for injuries sustained in the course of employment, during commuting, or while performing duties related to work. Injuries that occur outside of these work-related contexts, such as during personal time or unrelated activities, are not eligible for claims under the EIS.

During an engagement session with employers' representatives on 29 July 2024 at Pullman Hotel Kuching, Mr Borhan bin Osman, Chief Legal Officer of the Legal and Prosecution Division of SOCSO Head Office, highlighted a significant statistic from year 2012. He noted that 34,306 cases submitted to SOCSO were rejected after investigation because the injuries did not occur during employment. This issue is further compounded by the fact that 42% of the national working population lacks personal accident coverage. To bridge this gap, SOCSO proposed *Skim Kemalangan Bukan Bencana Kerja* (SKBBK) or Non-Employment Related Injury Scheme as an enhancement to the existing EIS.

Mr Borhan explained that the proposed SKBBK aims to extend coverage to claims for injuries sustained outside of employment, offering protection 24 hours a day, seven days a week, similar to the existing Invalidity Scheme provided by SOCSO. Under the proposed SKBBK, contributions are mandatory for employees registered and contributing under the

Employees' Social Security Act 1969 (SOCSCO Act) but employers will not incur any financial obligations as employees will solely fund this with contributions deducted from their salaries. The proposed contribution rates are 0.75% for the first and second years, 1.0% for the third, fourth and fifth years, and 1.25% from the sixth year onwards. These escalating contribution rates are based on the year of enforcement of the amended SOCSO Act, not the employee's year of service.

SOCSCO is currently preparing the implementation mechanism and amending the SOCSO Act, which will be presented in the forthcoming Parliament session. SOCSO will also organise engagements with employee representatives, with another round of engagement scheduled with stakeholders before the proposed SKBBK's anticipated effective date next year.

SOCSCO Employer Circular No.2/2024 on Extension of the Invalidity Scheme Coverage to Foreign Workers under the Employees' Social Security Act 1969

The Group Chief Executive Officer of Social Security Organisation (SOCSCO) issued an Employer Circular No.2/2024 dated 1 July 2024 on the extension of the Invalidity Scheme coverage to foreign workers under the Employees' Social Security Act 1969.

The circular was circulated to STA members on 10 July 2024.

The following are highlights of the extension:

Scheme: Invalidity scheme

Effective date: 1 July 2024

Scope of application: All employers employing foreign workers with a valid pass or permit issued by the Director General of Immigration.

Contribution: Employers shall make the payment on the contribution rate as in the Third Schedule of the Employees' Social Security Act 1969 (Act 4).

Method of payment and submission of records: Payment can be made online either via the ASSIST PORTAL or Internet Banking. Please take note that the contribution must be paid not later than the 15th of each succeeding month. The contribution shall be stated on the pay slip and given to the foreign worker.

Submission of the foreign worker's records for contribution payment shall be done online via ASSIST PORTAL or Internet Banking using the Foreign Workers Social Security Number.

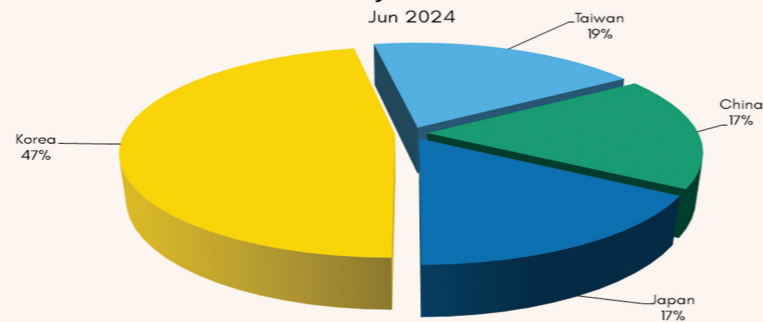
EXPORT VALUE OF VENEER BY DESTINATION FROM SARAWAK

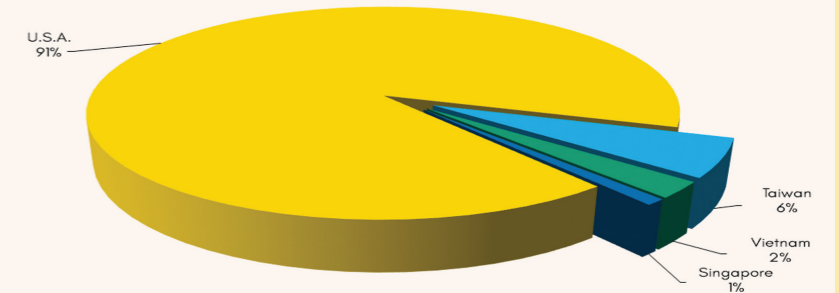
EXPORT VALUE OF LAMINATED BOARD / FLOORING BY DESTINATION FROM SARAWAK

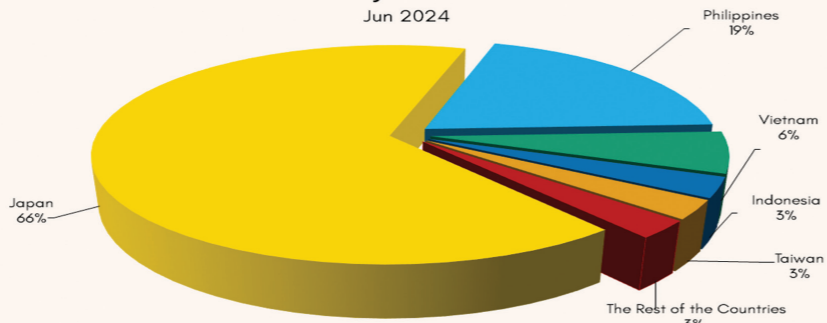
EXPORT VALUE OF MEDIUM DENSITY FIBREBOARD BY DESTINATION FROM SARAWAK

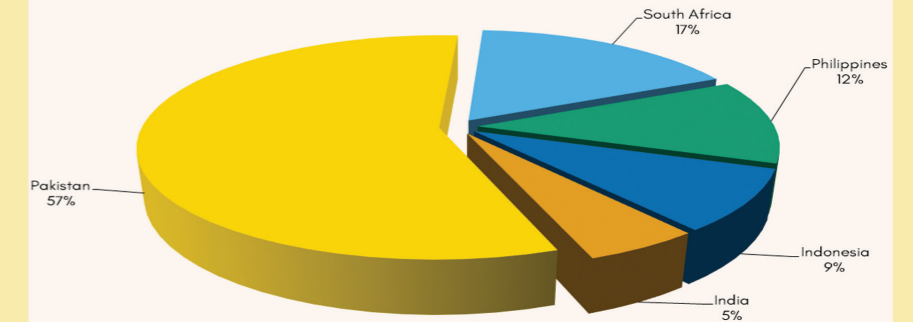
EXPORT VALUE OF DOORSKIN BY DESTINATION FROM SARAWAK

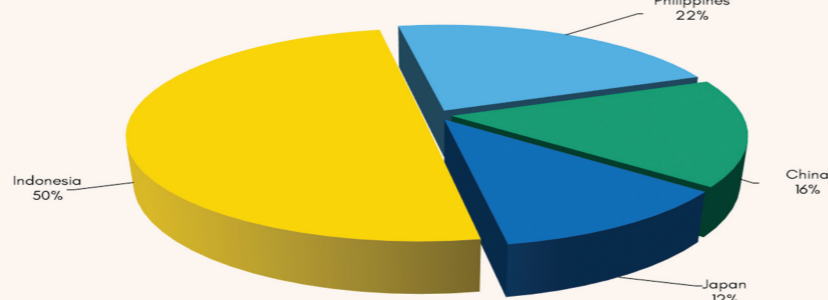
EXPORT VALUE OF PARTICLEBOARD BY DESTINATION FROM SARAWAK

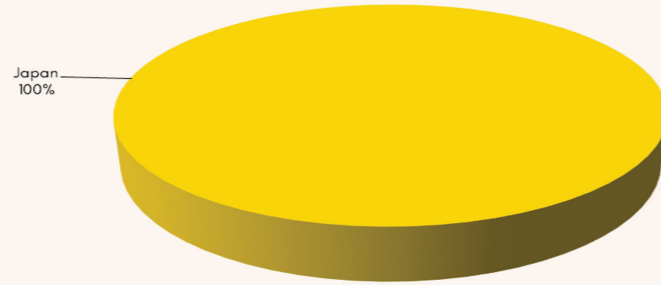

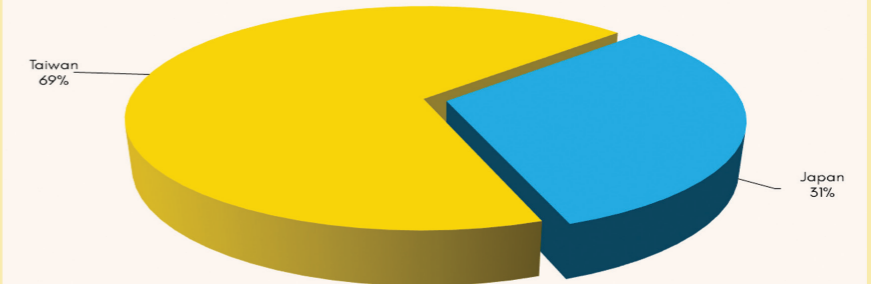

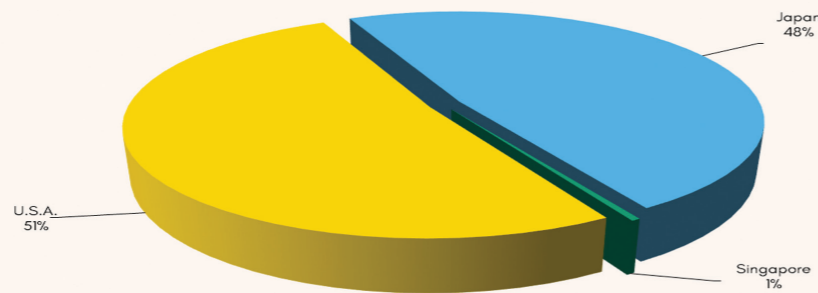

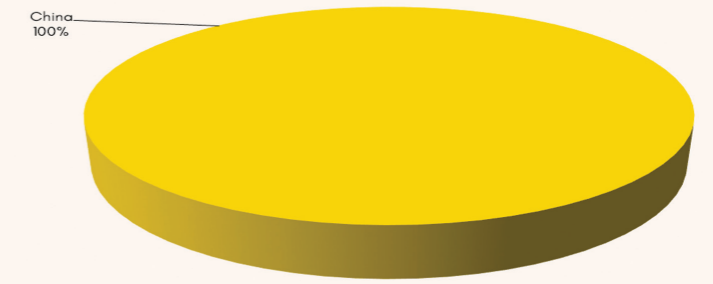

Under Section 51 of the Forests Ordinance 2015, forest workmen are required to receive training from a training provider and demonstrate their competence through assessment. STA Training Sdn Bhd (STAT) is the appointed training provider by Forest Department Sarawak to provide skills training for the five (5) prescribed forestry activities (PFAs) as listed in Schedule 1 The Forests (Trained Workmen) Rules, 2015.
