STA Council Meeting No. 1/2025

On 4 March 2025, the STA Council convened its first meeting of the year virtually. The meeting was presided over by Dato Henry Lau Lee Kong, STA Chairman, and attended by 24 Council members

The Council began by expressing its heartfelt condolences on the passing of Mr Wong Ting Chung, STA Honorary Secretary, a valued member of the Association. The Council formally recorded its appreciation for his invaluable contributions and dedicated service.


In line with the mandatory requirement to appoint a new Honorary Secretary, Dato' Sri Patrick Wong graciously stepped down from his role as Vice Chairman to take on the responsibilities of Honorary Secretary for the remainder of the term. Following this transition, Mr David Tiong was appointed as the new Vice Chairman. Additionally, the Council member post under the Hill Logging category, previously held by the late Mr Wong Ting Chung, will remain vacant until the next Council election in 2026.

During the previous Council meeting, the Annual General Meeting (AGM) was scheduled for 27 March 2025. However, after careful consideration, the Council decided to postpone the AGM by one day to 28 March 2025 to better accommodate logistical arrangements.

The Council reviewed reports from the various Category Committees and Working Committees. Key topics discussed include the Foreign Workers Transformation Approach, the conduct of the Timber Legality Assurance System Strengthening Study Project, and development of Electronic Removal Pass which will undergo a one-month trial run. The Council noted that the Seminar on STA-funded research and development projects has been scheduled on 8 April 2025.

In addition, the Council discussed administrative matters of the Association as well as its three subsidiary companies, namely STA Training Sdn Bhd, STA Mutual Sdn Bhd and STA Enterprises Sdn Bhd.

The Sarawak Timber Association (STA) successfully held its Annual General Meeting (AGM) 2025 on 28 March 2025 at Wisma STA. The AGM was chaired by Dato Henry Lau, Chairman, with the support of all the Office Bearers in attendance. The event was honoured by the presence of two esteemed Advisors, whose expertise plays a crucial role in the development of Sarawak's forestry and timber industry.

The AGM commenced with Dato Henry Lau presenting a report on the workings of STA. An excerpt of the report is provided on pages 6 to 9. Amongst other things, he expressed strong concern over the financial burden imposed by the Sarawak Government's Foreign Workers Transformation Approach (FWTA), which adds RM1,854 per worker. When combined with the recent increase in the minimum wage to RM1,700 and the upcoming mandatory EPF contributions for foreign workers, businesses are facing significant financial strain. While STA supports the streamlining efforts, the Association called for justification of the high fees.

Dato Henry Lau also highlighted the European Commission's consultation process to list seven (7) genera, namely the *Anthoshorea, Doona, Pentacme, Neohopea, Richetia, Rubroshorea*, and *Shorea* under Appendix II of the Convention

on International Trade in Endangered Species of Wild Fauna and Flora (CITES). He warned that this move could severely impact Malaysia's timber trade and called for greater consideration of the economic consequences. STA will continue to work with relevant authorities to address these issues to ensure the sustainability and growth of Sarawak's timber industry.

Additionally, Dato Henry Lau called for the Right Honourable Premier, Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari bin Tun Datuk Abang Haji Openg to provide visionary initiatives on green and renewable energy to protect and propel the principle of productive forest resources for future generations. He expressed confidence about the future of the timber industry under the leadership of the Right Honourable Premier. STA is optimistic that continued collaboration and supportive policies will ensure a resilient and sustainable future for both Sarawak's forests and the communities that depend on them.

Mr Semilan anak Ripot, Deputy Director of Forests, attended on behalf of STA Advisor Datu Haji Hamden bin Haji Mohamad, Director of Forests. In his address, Tuan Semilan highlighted the critical importance of collaboration among all stakeholders including STA. He underscored ongoing efforts to advance sustainable forest

management and stressed the need for collective action to meet global sustainability standards.

Mr Semilan also outlined key initiatives where STA has been actively involved, including the development of Reduced Impact Logging (RIL) guidelines, capacity-building programmes, and the joint organisation of international conferences that promote global knowledge-sharing. He emphasised that the collaboration between the Forest Department Sarawak and STA is instrumental in driving innovation, improving forestry practices, and positioning Sarawak as a responsible and sustainable timber producer.

Following Mr Semilan's address. another STA Advisor, Haji Zainal Abidin bin Abdullah, General Manager of the Sarawak Timber Industry Development Corporation, in his speech, recognised the challenges facing the timber industry. These included securing sufficient raw materials for processing and navigating shifting market dynamics. Haji Zainal stressed the importance of reducing dependency on natural forests in line with Sarawak's Green Policy. He also outlined strategic initiatives to address these challenges, such as promoting alternative raw material sources like rubberwood and bamboo, as well as establishing mills within Licensed Planted Forests (LPF) to enhance operational efficiency and reduce transportation costs. These steps are aimed at boosting the sustainability of the industry and meeting the increasing demand for responsibly sourced timber.

The meeting also featured discussions on Sarawak's continued commitment to sustainable forest management, with a focus on forest certification, forest carbon initiatives, and technological advancements. Both Advisors' insights and collaborative efforts were central to reinforcing the shared vision for Sarawak's timber industry and ensuring its long-term sustainability.

Chairman's Speech Annual General Meeting 2025

Good morning and a very warm welcome to the STA Annual General Meeting.

Before we begin, let us take a moment to honour the late Mr Wong Ting Chung, who sadly passed away on 19 January 2025. Mr Wong served as the Honorary Secretary of STA from 2020, demonstrating unwavering dedication and conscientious leadership throughout his tenure.

We also extend our gratitude to Dato' Sri Patrick Wong, who has graciously stepped down as Vice Chairman to assume the responsibilities of Honorary Secretary for the remainder of the term, and welcome Mr David Tiong as the new Vice Chairman.

Foreign Workers Transformation Approach & Other Labour Matters

Over the past year, the global timber trade faced several challenges, with the economic environment putting pressure on Malaysia's competitiveness. Geopolitical tensions in Eastern Europe and the Middle East, coupled with trade disputes between major economies, disrupted supply chains and raised costs. On top of that, new global regulations on deforestation and carbon emissions have led to higher operational costs for our industry.

On 15 January 2025, the Sarawak Government introduced the Foreign Workers Transformation Approach (FWTA) system. While designed to enhance efficiency, the FWTA system imposes a substantial financial burden on businesses. With a fee of RM1,854 per worker, companies will incur an additional RM2 million in labour costs for every 1,000 foreign workers. Based on 100,000 foreign workers in Sarawak, this would amount to more than RM100 million fees. While we support the streamlining efforts, we urge the Sarawak Government to justify the high fees and clarify who will benefit from these charges.

In addition, when coupled with the minimum wage increase to RM1,700 now in effect and the upcoming mandatory Employees Provident Fund contributions for foreign workers, these costs are placing significant strain on businesses. This could severely undermine our competitiveness, particularly in the export market, where cost efficiency is paramount.

On a related matter, the government is currently looking into the idea of setting a minimum salary for entry-level graduates. STA does not agree with applying a fixed salary for all graduates. Graduates are not all the same; they have different educational backgrounds, skill levels, and needs depending on the industry. Wages vary across industries, and the demand for specific skills can differ too. A one-size-fits-all salary might not suit the different needs of the job market and could lead to mismatches between what graduates are qualified for and what employers need. Therefore, instead of government intervention, graduate salaries should be determined by market forces, allowing demand and supply, industry needs, and job functions to naturally regulate wages.

STA will continue to engage with Sarawak agencies and industry stakeholders to find balanced solutions that align with the Government's goals while ensuring the sustainability and growth of our businesses. We hope the Government will endorse STA's role in advocating for the betterment of the timber industry in Sarawak.

Concerns Regarding Anthoshorea, Richetia, Rubroshorea and Shorea Genera Listing in CITES

I would also like to bring attention to a critical concern that has recently emerged. The European Commission has initiated a consultation process to list the *Anthoshorea*, *Richetia*, *Rubroshorea* and *Shorea* genera under Appendix II of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES). This move is particularly worrying, as these genera, which includes key species like Meranti and Selangan Batu, makes up a significant portion of Malaysia's forest cover and are vital to our timber trade.

It is important to note that Sarawak has made significant strides in forest conservation through initiatives such as increasing the establishment of Totally Protected Areas (TPAs), strict certification policies, and enrichment planting programme, all of which demonstrate our commitment to sustainable forest management (SFM) practices. These efforts are aimed at both conserving biodiversity and ensuring that our timber resources are harvested responsibly. The European Union's arbitrary proposal to list *Anthoshorea, Richetia*,

Rubroshorea and Shorea genera based solely on a declines in production or perceived threats surely is an irrational reasoning as well as a foolish excuse.

Should these genera be listed under CITES, it could have severe consequences for Malaysia's economy, potentially restricting access to both domestic and international markets. Such a move would threaten the very survival of the industry and put the livelihoods of many workers at risk, including workers in the consumer countries, not to mention that this will invariably put the listed trees as of no value and therefore risk of being replaced.

STA's efforts

Despite the challenges, STA remains committed to advocating for a sustainable, thriving timber industry. From 6 to 7 March 2024, STA organised the International Conference on the Sustainable Management of Tropical Forests, jointly organised with Forest Department Sarawak (FDS) and WWF-Malaysia with the support from the International Tropical Timber Organization (ITTO). The event brought together industry experts, leaders, and stakeholders from around the world, providing a valuable platform in fostering a rich exchange of diverse perspectives, ideas, research, and best practices that led to innovative solutions and enhanced knowledge on critical issues.

From the conference, one key takeaway was the need for forests to provide economic value to remain protected. If forests cannot offer long-term economic returns, they risk being converted for more immediate financial gain. This principle underscores the importance of ensuring SFM practices that meet both environmental and economic needs.

Sustainable Forest Management

Building on the outcomes of the conference, we have worked closely with the FDS and Sarawak Forestry Corporation (SFC) to strengthen capacity-building initiatives in SFM. This includes organising training workshops, such as the Biodiversity Observation for Ecosystem Health (BOLEH) Workshop and Training, Training on Forest Management Plans and Reduced Impact Logging, and Honorary Wildlife Ranger Training. These programmes help equip industry stakeholders with the tools and knowledge necessary to improve forest practices.

STA Training Sdn Bhd

STA also continues to actively support the Environmental Compliance Audit (ECA) under the Natural Resources and Environment (Audit) Rules, 2008 for the forestry sector in Sarawak, with STA Training Sdn Bhd (STAT) being appointed as the official training provider starting 1 July 2024.

In 2024, STAT has successfully conducted two Environmental Quality Monitoring and three ECA training sessions to meet the growing demands of the industry.

These ongoing efforts are vital in ensuring that our members are equipped with the necessary knowledge to maintain compliance and drive sustainability within the industry.

Forest workmen certificates

An important area of focus has been improving the skills of forest workmen. All forest workmen are required under the Forests (Trained Workmen) Rules, 2015 to complete the required training and obtain Forest Workmen Certificates so as to ensure that only properly trained workmen are able to carry out their roles and responsibilities in SFM.

The Director of Forests has made these certificates mandatory for the renewal of licences and approval for the Permit to Enter Coupe for all licence holders and contractors.

We encourage all members to expedite their workmen's training and ensure they obtain the necessary certificates. Since the skills sets offered by STAT are registered with the HRD Corp, we recommend that members take full advantage of STAT's training provider status and seek reimbursement of expenses incurred through the HRD levy.

Looking ahead, we expect STAT to expand its training programmes significantly in the coming years, offering additional opportunities for skill development to meet evolving industry standards and regulatory requirements.

Need for stability of forest management policies

While capacity-building efforts are crucial, the timber industry's future also hinges on the stability of the policies governing forest management. Long-term tenure security and financial incentives are necessary to foster investment in the timber industry and to prevent the conversion of forests to alternative uses.

STA is concerned by the decline in the number of certified FMUs in Sarawak. Five FMUs were not recertified due to several reasons, including the non-renewal of forest timber licences although promised by the Sarawak Government of 60 years timber licence, increased costs as well as issues involving local communities. Our members are entitled to understand the justification for the non-renewal and to know who the government has granted licences for the same area to.

The lack of long-term tenure security is a major issue that has left many licence holders questioning the sustainability of their investments. When FMUs invest substantial resources into certification, an intricate and costly process, they expect assurance that their efforts will not be undermined by arbitrary policy decisions or shifts in governance.

The non-renewal of timber licences for certified FMUs, despite having met the rigorous standards of certification, reflects a misalignment between the goals of SFM and the practical challenges faced by FMUs. These disruptions create an atmosphere of uncertainty, which undermines the trust of industry players in government assurances of long-term tenure.

This situation highlights the urgent need for clear and consistent policies that will restore the industry's confidence. The government must prioritise creating a stable, predictable environment that rewards companies for their commitment to sustainability.

Ensuring long-term tenure security, providing financial incentives, and addressing issues with local communities will be essential in securing the industry's future and maintaining Sarawak's leadership in responsible forest management.

Development of carbon credit markets

STA recognises the multi-faceted value of forests, which go beyond timber production to include crucial ecosystem services such as biodiversity conservation, water regulation, and carbon sequestration. Understanding that forests are integral to both the environment and the economy, STA is involved in advocating for policies that reflect these diverse roles.

We are actively engaged in the national discourse on carbon, promoting policies that recognise tropical forests not only as sources of timber but also as carbon sinks. To address carbon-specific issues, STA has formed a dedicated Carbon Committee to guide and support these efforts.

We support the development of carbon credit markets, offering licensees the opportunity to earn compensation for the carbon sequestered in well-managed forests. This additional revenue stream reinforces the long-term sustainability of forest resources by aligning economic incentives with environmental goals.

Expanding downstream activities

The timber industry in Sarawak is facing a significant challenge in continuing let alone expanding downstream activities, such as the manufacturing of value-added products like engineered wood and biomass fuel. Despite the Government's efforts to promote these initiatives, the industry remains reluctant to invest in value-added production, primarily due to challenging market conditions, the ongoing shortage of timber resources, rising production costs and lack of proactive supporting policies from the Government.

Although the Government has introduced several blueprints, such as the Engineered Wood Products Blueprint and Bamboo Blueprint, there remains a lack of clear and affirmative committed road map to encourage the industry to invest in the required machinery, human and financial resources.

A particular focus also needs to be placed on ensuring a sustainable supply of timber, which is essential to guaranteeing that mills and downstream operations have a reliable source of raw materials. Again, without security and adequate licence tenure, it is very difficult to attract investments, particularly local investors.

We are in dire need of the Honourable Premier's visionary initiatives on green and renewable energy to protect and propel the principle of the productive forest resources for the present and future undertakings.

Addressing disparity

While Peninsular Malaysia offers financial incentives such as subsidies on machinery and freight charges through the Malaysian Timber Council (MTC), Sarawak currently lacks similar mechanisms. To address this disparity, we urge policymakers to consider introducing equivalent incentives in Sarawak to stimulate growth, encourage innovation, and help the downstream sector capitalise on the potential of value-added products.

We further propose that the Sarawak Government reinvest the sales tax collected from timber product exports back into the industry. Such reinvestment could fund initiatives including financial support for automation, digitalisation of business processes, and incentives for adopting sustainable practices, mirroring the approach taken by MTC in Peninsular Malaysia.

Mills in industrial tree plantations

On a positive note, FDS has confirmed that the policy allowing establishment of mills in industrial tree plantations has been approved by the Premier of Sarawak, subject to specific conditions. These include conducting royalty assessments based on standing tree volume and maintaining active tree planting.

After years of advocacy, this development is welcomed, as it will reduce costs, improve operational efficiency, and align with sustainable practices by minimising the environmental footprint associated with transporting raw materials over long distances.

These mills also provide local employment opportunities, contribute to rural economic development, and ensure a steady supply chain for the production of timber and value-added products. Furthermore, their proximity to plantations facilitates better resource utilisation and strengthens the industry's competitiveness.

Research and Development

To further support industrial tree plantations, STA funded four research and development (R&D) projects: three focused on Kelampayan under Universiti Malaysia Sarawak, and one on Batai under GP Pusaka Sdn Bhd. A webinar is being organised on 8 April 2025 to disseminate the findings from these R&D projects funded by STA.

The R&D on Kelampayan successfully developed an optimised protocol for propagating the species using the Temporary Immersion Bioreactor (TIB). This method has demonstrated a high survival rate for seedlings during acclimatisation and proven effective for scaling up shoot multiplication.

The planting materials developed are currently undergoing trial planting in Kanowit, Tubau, Similajau, and Sejingkat, where field performance being evaluated.

Conclusion

In conclusion, while challenges remain, with the visionary leadership of the Right Honourable Premier, Datuk Patinggi Tan Sri (Dr) Abang Haji Abdul Rahman Zohari bin Tun Datuk Abang Haji Openg, we are optimistic and confident about the future of SFM in Sarawak. By continuing to collaborate, invest in training, and advocate for supportive policies, we will ensure a resilient and sustainable future for both our forests and the communities that depend on them.

I would like to express my sincere gratitude to STA Advisors, Datu Haji Hamden bin Haji Mohammad, Director of Forests, and Tuan Haji Zainal Abidin bin Haji Abdullah, General Manager of the Sarawak Timber Industry Development Corporation, as well as the officers from various ministries and agencies within the Sarawak Government for their unwavering support of STA.

My thanks also go to all the members and Council Members for their steadfast commitment to the Association, and to all members at the Secretariat for their dedication and hard work.

The Sarawak Government, through Immigration and Labour Management Unit (ILMU), organised the "Industry Update 2.0 Programme" on 5 and 6 March 2025 at the Pullman Miri Waterfront Hotel. The two-day event, which also featured booths and counters by key agencies such as the Sarawak Labour Department (JTKS), Sarawak Immigration Department (JIMS), Sarawak State Health Department (JKNS), Social Security Organisation (PERKESO) and the Foreign Workers Transformation Approach (FWTA) Team, updated stakeholders on critical developments, particularly the recent amendments to the Sarawak Labour Ordinance (SLO) 2025 and the introduction of the FWTA System.

The event was officiated by Datuk Gerawat Gala, Deputy Minister in the Premier's Department, who emphasised the significance of the SLO amendments in ensuring compliance with International Labour Organization (ILO) standards. Datuk Gerawat also highlighted that the Sarawak government aims for all employers to fully adopt the FWTA system, which has reduced the processing time for non-resident workers from 190 days to 61 days.

Industrial Relations Officer (IRO) at JTKS, Mr Phang Pin, provided a detailed breakdown of the amendments to the SLO, which will now apply to all employees, regardless of their wages or types of work. Key changes include a reduction in the maximum weekly working hours from 48 hours to 45 hours, eligibility for overtime

claims on rest days and public holidays extended to workers earning up to RM4,000 (previously RM2,001), an increase in maternity leave from 60 days to 98 days, and the inclusion of Hari Malaysia and Sarawak Independence Day as mandatory public holidays. The amendments also introduce a 7-day paternity leave, set the minimum employment age for child workers at 13 years, outline specific works prohibited for children and young persons, and impose stricter penalties up to RM50,000 for non-compliance. Additionally, the newly amended SLO incorporates provisions for flexible working arrangements, housing and amenities standards, as well as regulations on sexual harassment, discrimination, and forced labour.

Elaborating on non-resident worker regulations, Mr Ewiim @ Ewiin anak Michael Sinar, IRO at JTKS, discussed draft Labour Regulations that include licensing through the Sarawakian and Non-Sarawakian Online Labour System (SANSOLS). Employers must adhere to set validity periods, complete mandatory renewal 60 days before expiration, and rectify errors within 30 days.

The highlight on worker benefits continued with Mr Paul Terry B. John Felix Narang, Head of the Benefits Unit at PERKESO Miri Office. He explained that PERKSEO is now the official term for Malaysia's Social Security Organisation, replacing SOCSO. Additionally, he highlighted key protections, including an employer-funded occupational accident scheme for workers aged 60 and above and equal accident protection for both foreign and local employees.

Ms Nur Hazirah binti Anyut, Executive Officer at the PERKESO Miri Office, introduced MyFutureJobs, a digital employment service that utilises artificial intelligence-powered job matching and real-time data analytics to bridge skill gaps. A shift in foreign worker recruitment and management was also discussed by Mr Muhammadie Izwan bin Mohamad

Ibrahim, Deputy Assistant Director of JIMS, who detailed the transition of the Temporary Work Visit Pass from a manual to a digital system.

Health safetv and considerations were also underscored by Dr Ivan Vun Jan Shui. Public Health Medicine Specialist at JKNS. He emphasised the importance of

comprehensive health screenings in preventing the spread of contagious diseases. Key points included the implementation of the Sarawak Foreign Workers Health Information System (SAFHIS) in 2025, ensuring all foreign workers undergo pre-arrival health screenings; evaluation of specific medical conditions based on job requirements; and ongoing efforts to digitally integrate health assessments with the FWTA system.

The FWTA Team then took the stage to demonstrate the system's capabilities in foreign worker management. User registration, digital tracking, hiring reports, e-Visa applications, medical screenings and government integration were among the key features highlighted. Employers were encouraged to register for one-on-one briefings via the SANSOLS portal at https://sansols.sarawak.gov.my/info/reg-briefing.

Wrapping up the event, Mr Richard Lon, Director of ILMU, underlined the importance of human resource professionals in understanding FWTA's five (5) core modules: JobSarawak, SANSOLS, SAFHIS, Identity Card for Foreigners and the Enforcement Tracking System. He also discussed a proposal to reduce job advertisement posting periods from 30 to 14 days, establishing new one-stop centers in remote areas and committing to resolving industry feedback within 60 days. In his closing remarks, he expressed gratitude to STA, plantation associations and industry partners for their continued contributions.

To ensure STA members who missed the event stay informed, the STA Secretariat is organising an online FWTA demonstration session with SOCOE Sdn Bhd, tentatively scheduled for 10 April 2025. This virtual session will encourage more participation by providing in-depth guidance on the FWTA system, addressing key concerns related to foreign worker recruitment and management as well as featuring insights from key stakeholders like JTKS and JIMS.

Survey on the Proposed Minimum Salary for Entrylevel Graduates

The STA Manpower Working Group held an online discussion on 21 March 2025, facilitated by Ms Annie Ting, Chief Executive Officer of STA.

A key topic discussed was the survey conducted by the Ministry of Human Resources (KESUMA) on perceptions of a minimum salary for entrylevel graduates. The group expressed concerns that the survey findings could lead to mandatory salary laws for employers, rather than serving as general guidelines.

On 27 March 2025, STA formally conveyed to KESUMA its disagreement with the proposal to set a minimum salary for entry-level graduates. The main concern was that STA members operate across diverse industries, such as palm oil, construction, and shipping, each with its own salary structures and employment practices. This makes a standardised salary policy difficult to apply fairly and effectively.

Moreover, graduate qualifications vary significantly between universities, both in quality and relevance to specific industries. This further complicates the establishment of a uniform salary benchmark that accurately reflects the skills and readiness of entry-level graduates. Starting salaries are also influenced by factors such as education, experience, industry, company size, location, and cost of living. A rigid policy could disrupt the job market, limit opportunities, and impose unnecessary burdens on businesses.

Helmeted Hornbill Project in Greater Usun Apau – Stakeholders' Meeting

The Malaysian Nature Society (MNS) Kuching held a stakeholders' meeting on 14 March 2025 via video conference to review the Year 3 progress for the project, "Securing a safe haven for the Helmeted Hornbills in the Greater Usun Apau". The session, moderated by Ms Rose Au, Chairperson of MNS Kuching Branch, was attended by representatives from Sarawak Forestry Corporation (Miri Regional Office), Samling Group of Companies, Kedaya Telang Usan, Telang Usan District Office and STA Secretariat.

Ms Patricia Awing, Project Officer at MNS Kuching, shared that while the project initially focused on Usun Apau National Park (UANP), its scope has since expanded beyond the park's boundaries to

strengthen conservation efforts for this critically endangered species. This broader approach aims to enhance habitat protection and ensure a more comprehensive conservation strategy.

She also highlighted key findings from Phase 1 activities conducted between October 2021 and September 2024. Surveys, expeditions and community interviews, combined with line transects and camera trapping, led to the identification of over 100 bird species, including six (6) hornbill species – most notably the Helmeted and Rhinoceros Hornbills.

She further explained that Helmeted Hornbills face significant threats due to habitat loss, as lowland areas below 1,000m in UANP are limited. Additionally, the helmeted hornbills are targeted by outside poachers, while their parts are used by local communities for cultural purposes, incorporating them into traditional beliefs and practices.

Phase 2 of the project will focus on further research and conservation initiatives. Planned activities include training programmes,

ecological surveys and community interviews to deepen the understanding of hornbill population dynamics and habitat requirements.

During the discussion that followed, Mr Mark Sagan, Project Officer at MNS Kuching shared insights from Phase 1 community interviews, which revealed the cultural significance of hornbill feathers, particularly tail feathers. Recognising this deep-rooted tradition, MNS aims to promote the use of artificial alternatives, ensuring that cultural practices are preserved while supporting the conservation of the Helmeted Hornbills.

Second meeting of the Malaysian Timber Certification Council Project Appendix 3 Malaysia Working Group

The Malaysian Timber Certification Council (MTCC) convened the second meeting of the Malaysian Timber Certification Council Project Appendix 3 Malaysia Working Group on 24 March 2025 at its office in Kuala Lumpur to follow up on the information gathered from a recent MTCC survey on plantation forests and gather additional insights to strengthen Malaysia's position in the development of Appendix 3.

Chaired by Dr Farrah Shameen, Chief Executive Officer of MTCC, the meeting

together brought working members, forest group licensees plantation and contractors. Discussions focused on plantation forests established between 2010 and 2020. Additionally, the group discussed Trees Outside Forests, specifically in the context of agricultural plantations, and proposed safeguards to ensure responsible and sustainable practices moving forward.

Sarawak Forestry and Timber Industry Strongly Opposes to the Proposed CITES Listing for *Shorea* spp. by the EU and Apitong (Keruing) by the US

In November last year, the European Commission (EC) initiated a consultation process to propose the listing of the *Anthoshorea, Doona, Pentacme, Neohopea, Richetia, Rubroshorea* and *Shorea* genera under Appendix II of the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES). In addition to that, a letter dated 27 January 2025 from the Hardwood Federation urged the U.S. Fish and Wildlife Service to include Apitong (Keruing) in CITES under Appendix I.

Under CITES, Appendix I comprises species at the greatest risk of extinction, where international trade is severely restricted, if not prohibited. Appendix II lists species that are not necessarily threatened with extinction now but may become so unless trade is strictly regulated.

If these unjust proposals are adopted, the implications for Malaysia's timber industry could be severe, posing a direct threat to the industry's viability and putting at risk the livelihoods of thousands who depend on it, both domestically and in consumer market abroad. In addressing this critical issue, the Ministry of Natural Resources and Environmental Sustainability (NRES), as Malaysia's national focal point for

CITES Management Authorities (MA), has taken the lead in formulating a national response to the EC's consultation paper, through the coordinated input from all three (3) regions in Malaysia.

In Sarawak, an Inter-Agency Committee (IAC) comprising the Ministry of Natural Resources and Urban Development, Forest Department Sarawak, Sarawak Timber Industry Development Corporation, Harwood Timber Sdn Bhd, and STA worked diligently through four (4) strategic meetings on 11, 18, 25 and 27 March 2025 at Wisma STA, Kuching to develop a strong, evidence-based response. These meetings involved active participation from the Sarawak Forestry Corporation (SFC), which represents Sarawak in Malaysia's CITES MA, thereby ensuring that Sarawak's interests are clearly and accurately communicated at the national level.

The STA Certification Committee also convened on 21 March 2025 to deliberate on the proposed listings and to coordinate the collection of essential data and technical inputs required to support the IAC's position.

This collaborative and well-coordinated effort culminated in the submission of Sarawak's final

response paper to NRES through SFC on 28 March 2025.

It is important to highlight that Sarawak has made significant progress in forest conservation through initiatives such as expanding Totally Protected Areas, enforcing strict certification policies, implementing enrichment planting and executing various conservation programmes. These efforts underscore Sarawak's commitment to Sustainable Forest Management, aiming to conserve biodiversity while ensuring responsible timber harvesting.

The European Union cannot arbitrarily propose to list the Shorea genus under CITES based solely on a decline in production or perceived threats without full and fair consideration of the conservation measures already in place. The reduction in Shorea production volume in recent years is not indicative of unsustainable practices, but rather the result of deliberate and strategic decisions. Specifically, this decline stems from two (2) key factors: (i) ongoing land development in Sarawak involving the conversion of natural forests for various developmental purposes to support planned socio-economic growth, and (ii) a proactive policy shift aimed at easing pressure on natural forests by transitioning timber production from natural forests to sustainably managed forest plantations.

In addition, STA collaborated with the Malaysian Timber Association (MTA) and its members, exchanging critical updates and engaging in discussions about the proposed listing. These efforts were further reinforced through direct engagement with key ministries, relevant government agencies, and influential international organisations, including the European Timber Trade Federation and the Indonesian Wood Panel

Association. These strategic dialogues have been crucial in building a united front and strongly advocating against the proposal to safeguard the future of the timber industry.

At the same time, STA has been with MTA to coordinate and International Wood Products Association to counter the proposal to list Apitong (Keruing) in CITES under Appendix I. This move is seen not as a conservation effort, but as an unfair trade strategy aimed at shielding the U.S. market from competition, particularly with red oak.

STA remains fully committed to working in close collaboration with all relevant authorities to address these challenges and will continue to advocate for responsible forest governance, ensuring that Sarawak's forestry and timber sector remains resilient, sustainable and viable for generations to come.

Meeting with Minister of Natural Resources and Environmental Sustainability Malaysia on CITES

A meeting with Mr Nik Nazmi Nik Ahmad, the Minister of Natural Resources and Environmental Sustainability (NRES) Malaysia, was held on 24 March 2025 to discuss the potential listing of *Shorea* and Keruing under the Convention on International Trade in Endangered Species of Wild Fauna and Flora (CITES).

The meeting which took place at Wisma JUPEM, Kuala Lumpur, was attended by key representatives from the Malaysian Timber Industry Board, the Malaysian Timber Council, the Malaysian Timber Certification Council, and members of the Malaysian Timber Association.

The discussion focused on critical strategies for advancing the matter, highlighting the urgency of the issue and the necessity for immediate action. It was emphasised that proactive engagement with other countries is necessary to ensure a collaborative and effective approach moving forward.

Meeting on Timber Legality Assurance System Strengthening Study Project

To enhance the existing Timber Legality Assurance System (TLAS) framework and ensure its alignment with international trade requirements, the Ministry of Plantations and Commodities, through the Malaysian Timber Industry Board, has commissioned a study titled "Timber Legality Assurance System (TLAS) Strengthening Study Project". The project, which runs from 1 February to 31 August 2025, is part of the initiative under the Timber Industry International Trade Law Compliance Mitigation Sub-Committee.

To support the study and provide relevant insights, STA and Forest Department Sarawak coordinated an online meeting with 27 Advisory Sdn Bhd, the appointed consultant for the study, on 11 March 2025. The session was also attended by representatives from the Ministry of Natural Resources and Urban Development, Sarawak

Timber Industry Development Corporation, and Harwood Timber Sdn Bhd.

During the meeting, the consultant outlined the study's key objectives, which include assessing the various TLAS systems implemented across Malaysia, analysing current implementation and improvement strategies, identifying areas for further enhancement, and formulating a comprehensive action plan for the post-study phase.

During the meeting, the Sarawak group gave a detailed clarification on the Sarawak Timber Legality Verification System (STLVS), particularly its processes, auditing framework, and related procedures, providing the consultant a better understanding of its implementation on the ground.

Meeting in progress

NSC 22/TC 1/WG 3 Meeting No. 1/2025

In the meeting of the Working Group 3 of Technical Committee 1, formed under the National Standards Committee on Timber, Timber Products, and Timber Structures (NSC 22/TC 1/WG 3) at the office of The Department of Standards Malaysia (DSM) at Cyberjaya on 3 February 2025, it was resolved for the WG 3 to review the outdated Malaysian Standard MS1714:2003 — Specification for Visual Strength Grading of Tropical Hardwood Timber.

With that, a standard development workshop was organised by DSM at Hotel Le Meridien Putrajaya from 12 to 13 March 2025. Members of the WG consists of representatives from Malaysian Timber Industry Board (MTIB), Department of Standards Malaysia (being Secretariat), Forest Research Institute Malaysia (FRIM), Jabatan Kerja Raya Malaysia, Malaysian Timber Council, Sarawak Timber Industry Development Corporation, Pertubuhan

Akitek Malaysia, Universiti Sains Malaysia, Universiti Teknologi MARA, The Timber Exporters' Association of Malaysia, Malaysian Wood Industries Association, Sarawak Timber Association, and individual experts.

MS1714 applies to tropical hardwood timber graded both in Malaysia and abroad for seasoned timber either rough sawn or dressed, preservative treated or untreated. Hardwood timber imported from abroad shall be regraded in accordance with this Malaysian Standard (MS) before it is allowed to be used for structural application.

WG discussed on the major modifications in the standard, mainly the update of foreword, normative references, terms and definitions, clauses and tables as well as the bibliography; including incorporation of introduction in the standard; revised the scope and redrawn figures in the standard.

During the revision process, the timber industry requested MTIB to review the planted species to be incorporated into the standard. In response, MTIB

stated that research funding has been requested in the 13th Malaysia Plan for FRIM to conduct relevant research projects. Furthermore, the timber industry emphasised that all laboratories involved in such research should be accredited by an internationally recognised body.

Dalam mesyuaratnya pada 3 Februari 2025, NSC 22/TC 1/WG 3 telah memutuskan untuk menyemak semula MS1714:2003 berkaitan penggredan kekuatan visual kayu keras tropika. Satu bengkel telah diadakan pada bulan Mac di mana ahliahli Kumpulan Kerja telah meneliti kemas kini utama dan membincangkan tentang kemasukan spesies yang ditanam, dengan Lembaga Perindustrian Kayu Malaysia mencari dana penyelidikan dan pihak industri menekankan keperluan makmal yang diakreditasi.

Project on Promoting Sustainable Wood Use for the Domestic Market in Malaysia

The International Tropical Timber Organization (ITTO) has funded "Promoting Sustainable Wood Use for the Domestic Market in Malaysia" project, with the goal to enhance, diversify and promote sustainable wood use in Malaysia's domestic market. The project, commonly referred to as SWU Project, is an 18-month initiative that commenced on 1 October 2024 and is scheduled to run until 31 March 2026. As the Executing Agency appointed by the Ministry of Plantation and Commodities, the Malaysian Timber Certification Council (MTCC) organised a stakeholder consultation and sharing session on 14 March 2025 at its office in Kuala Lumpur, to garner inputs and discuss issues related to consumption of wood and wood products in order to further enhance SWU project.

Dr Farrah Shameen Mohamad Ashray, Chief Executive Officer of MTCC expressed hoped that the timber industry players could identify the unique aspects of this study. The stakeholders are represented by Mr Leonard Chew of The Timber Exporters' Association of Malaysia (TEAM) and Mr Lim Yi Syuen of Malaysian Wood Industries Association (MWIA), both from Peninsular Malaysia together with Mr Rahman Khan and Ms Brenda Wong of Sabah Timber Industries Association (STIA) and Ms Annie Ting, Chief Executive Officer of STA. Dr Farrah emphasised the importance of an open and frank discussions, beyond just desktop review, for the benefit of the project.

SWU Project coordinator, UPM Consultancy & Services (UPMCS) updated the industry and MTCC on the implementation of the SWU Project, particularly the achievement of the specified objectives. Prof Dr Mohd Shahwahid Haji Othman outlined the main focus areas of the project and their outcomes, which include a study on the wood demand and supply in Malaysia, a study

of existing policies and initiatives for the promotion of sustainable wood use, an analysis of the effectiveness of each policies and initiatives and a proposal for best practice policies that could be introduced in wood-producing countries.

The timber industry players provided inputs on how to further promote sustainable wood use Malaysia's domestic within Key suggestions market. included the Government to set an example by using value added wood products such as Laminated Veneer Lumber and Cross-Laminated Timber which are renewable and sustainable. Ms Annie also highlighted the success of Singapore and Japan in promoting green building practices by offering incentives for using timber, particularly local timber and wood from the industrial tree plantation.

There was also a call to revisit the community planting policy to understand the reasons behind slow tree planting rates, the

> preference for oil palm and how to improve tree planting practices with a focus sustainability, considering factors such as soil, terrain and species suitability. industry suggested providing incentives for mill manufacturers to adopt Carbon Capture, Utilization,

and Storage (CCUS) technology to capture and reduce carbon dioxide (CO₂) emissions from their operations, as well as promoting awareness and education about the benefits of using timber over less sustainable materials like steel and concrete.

The industry has expressed its willingness to explore the domestic market, provided there is a strong demand for wood products. Additionally, industry stakeholders have called on the Government to offer incentives and implement friendly policies that support the sustainable use of timber. Furthermore, there is a push for conducting study on CCUS in the timber sector, aligning with Environmental, Social and Governance (ESG) principles and the circular economy to ensure long-term sustainability and growth.

Pihak berkepentingan industri menggesa agar kerajaan menyediakan insentif, melaksanakan dasar kelestarian dan memperkenalkan inisiatif bangunan hijau.

Engagement with Chainparency

On 11 March 2025, the Forest Department Sarawak (FDS) hosted an online engagement session in collaboration with Chainparency, a platform that uses blockchain technology to enhance transparency and traceability in timber supply chains. The session was attended by members and secretariat from both the STA and the Sabah Timber Industry Association (STIA).

The event kicked off with a welcoming address from Datu Haji Hamden bin Haji Mohammad, the Director of Forests at FDS. He emphasised the significant role technology plays in expanding product sales in the market, expressing his hope that the technology shared during the session would be beneficial to Sarawak's forestry sector.

Ms Annie Ting, Chief Executive Officer (CEO) of STA, also expressed her gratitude for the opportunity to participate in the session and introduced members of STA and STIA to Mr Henry Ines, the CEO and founder of Chainparency, who was the main speaker of the session.

In his presentation, Mr Ines explained how Chainparency offers real-time traceability to transform forestry supply chains, using its blockchain-powered platform to ensure global regulatory compliance and enhance accountability. The platform streamlines operations, reduces risks, and supports businesses in achieving greater transparency, efficiency and sustainability.

The discussion during the session focused on several key topics such as data accuracy and security, applications in Environmental, Social, and Governance reporting, fee structures, data storage solutions.

MEF East Malaysia (Sarawak) Regional Meeting No. 3/2025

The Malaysian Employers Federation (MEF) East Malaysia (Sarawak) Region convened its third meeting of the year on 18 March 2025, presided by Ms Dayang Jamillah binti Tun Abang Muhd Salahuddin, Consultant-Industrial Relations of MEF Sarawak.

In his welcoming remark, Mr Sheikh Farouk Sheikh Mohamed Al-Bajrai, Chief Executive of MEF provided updates on MEF's activities. These included a visit to the International Labour Organization (ILO) Malaysia to discuss advancements in employment relations, an Employees Provident Fund session on Budget 2024 initiatives and a workshop focused on challenges in Environmental, Social, and Governance practices. He also highlighted the technical meeting at ILO Geneva on promoting decent work in the food and beverage industry and emphasised the outcomes of the National Tripartite Workshop, which aimed to strengthen collaboration between the government, employers, and workers in promoting responsible business practices.

The meeting also featured a brief demonstration on the Foreign Workers Transformation Approach (FWTA) system by the FWTA Team. This fully digitalised system, designed to streamline the management of foreign workers in Sarawak, is integrated with the JobSarawak portal. It enables real-time updates and traceability in the recruitment process, including features such as the hiring report. Currently

supporting both local and foreign worker registration, the system will soon be expanded to include expatriates.

The FWTA system is also aligned with Sarawak's government processes, including job postings, application processing, and labour license issuance. Employers are required to adhere to salary guidelines and post job vacancies through JobSarawak, subject to approval from Social

Security Organization (SOCSO). The system includes the e-Visa with Reference (e-VDR) feature and tracks workers' health status via the Sarawak Foreigners Health Information System (SAFHIS), ensuring real-time updates on medical screenings and fitness certifications.

In addition, the meeting introduced the Identity Card for Foreigner (FID) which includes biometric data and complies with ISO 2007 standards. The FID enhances identity verification and ensures that worker information remains up-to-date. For additional support, employers can request on-site services from the Sarawakian and Non-Sarawakian Online Labour System (SANSOLS) team for further support.


Grants Seminar:

Unlock Grants & Incentives to Grow Your Business

The Ministry of International Trade, Industry and Investment Sarawak (MINTRED), in collaboration with Invest Sarawak, hosted the "Grants Seminar: Unlock Grants & Incentives to Grow Your Business" from 17 to 18 March 2025, at Harbour View Hotel, Kuching. The seminar provided valuable insights into investment incentives, export grants, trade compliance, and strategies for international market expansion.

In his opening remarks, Mr Jona anak Kerani from the Malaysian Investment Development Authority (MIDA) highlighted MIDA's role in promoting investments and industrial growth in Malaysia. MIDA facilitates investments in manufacturing and selected services through business-friendly policies, including 100% foreign equity ownership, expatriate employment, and flexible income repatriation. Incentives such as tax exemptions, allowances, custom duty exemptions and funding for high-impact projects aim to attract both foreign and domestic investors, particularly in renewable energy, Industry 4.0 and high-value manufacturing.

He introduced the Domestic Investment Accelerator Fund (DIAF) – Environmental, Social and Governance (ESG) Adoption, which supports Malaysian-owned short and medium enterprises and mid-tier companies in adopting ESG practices. The matching grant, offered at either 50:50 or 70:30 provides up to RM500,000 per company per carbon emission tracking, green certification, ESG-compliant business practices, and sustainable supply chain technologies. This aligns with Malaysia's Net Zero Carbon roadmap and enhances business competitiveness.



Domestic Investment Accelerator Fund (DIAF) - ESG highlighted by Mr Jona anak Kerani

Mr Suwady Abd Shukor from the Malaysia External Trade Development Corporation (MATRADE) discussed financial support for global market expansion through the Market Development Grant (MDG) and the Services Export Fund (SEF). These grants assist Malaysian-owned SMEs and professional service providers in covering costs for international trade fairs, investment missions, and certifications. SEF, a reimbursable grant, supports Malaysian Service Providers except those in Tourism, Real Estate, Banking, and Insurance.

He also introduced the Export Readiness Assessment Tool, an online self-assessment system for evaluating export potential, as well as MATRADE's 12 Steps of Exporting. He concluded with Trade & Export Compliance, highlighting tariff classification, Incoterms which is short for "International Commercial Terms", export licensing, and the growing importance of ESG in global trade, focusing on sustainable sourcing, carbon emissions, labour rights, and ethical leadership.








EXPORT VALUE OF VENEER BY DESTINATION FROM **SARAWAK**








EXPORT VALUE OF MEDIUM DENSITY FIBREBOARD BY **DESTINATION FROM SARAWAK**



EXPORT VALUE OF DOORSKIN BY **DESTINATION FROM** SARAWAK








EXPORT VALUE OF DOOR PANELS & FRAME BY DESTINATION FROM SARAWAK



EXPORT VALUE OF MOULDINGS BY DESTINATION FROM SARAWAK







EXPORT VALUE OF WOOD PELLETS BY DESTINATION FROM SARAWAK


