# STA Council Meeting No. 4/2024

The STA Council held its Meeting No. 4/2024 on 25 November 2024 at Wisma Kuching, chaired by Dato Henry Lau Lee Kong, the STA Chairman. The meeting was attended by Honorary Treasurer Mr Philip Choo and fifteen (15) members of the Council.

During the meeting, the Council received reports from various Category Committees and Working Committees, as well as updates on the progress of the industrial tree plantation research projects funded by STA. One notable development is the completion of the Scale-Up Production of Kelampayan Research Project on 30 June 2024. The project successfully developed optimised protocols for propagating Kelampayan using the Temporary Immersion Bioreactor. In addition to Kelampayan, STA also funded a research project on Batai. A one-day workshop shall be organised soon to share the findings from these research projects.

In addition, four (4) downstream categories, Furniture & Other Woodworking, Moulding, Sawmilling, and Timber Products Marketing, are set to conduct a joint study trip to Peninsular Malaysia from 9 to 11 December 2024. The purpose of this trip is to explore potential collaborative projects with counterparts in Peninsular Malaysia and engage with relevant research institutions.

In light of Malaysia's numerous initiatives and efforts to transition towards a low-carbon economy, the Council approved the formation of a Special Committee on Carbon. This new Committee will

address the regulatory requirements surrounding carbon and position the forestry sector to take advantage of emerging carbon opportunities.

The Council also plans to commemorate the first anniversary of the late Tun Pehin Sri Haji Abdul Taib bin Mahmud's passing on 21 February 2025. A portrait and a coffee table book celebrating his life and contributions to STA will be launched in his honor. Tun Pehin Sri Haji Abdul Taib played a pivotal role in uniting the timber industry under STA and driving the development of the timber sector in Sarawak.

In recognition of STA's ongoing transformation and the importance of maintaining stability during this period, the Council resolved to waive the annual subscription fees for all members until the transformation is complete.

The STA Council confirmed that the Annual General Meeting for the year 2025 will be held on 27 March 2025.

These meetings presided over by Dato Henry Lau Lee Kong, Chairman and conducted via video conferencing are summarised as follows:

#### **STAE**

The STAE BOD Meeting No. 3/2024 endorsed and deliberated various financial and administrative matters which related to building operation and maintenance as well as the tenancy of Wisma STA.

#### **STAM**

The seven (7) members of the BHA and five (5) members of the BOD took note of the award of STA Best Graduating Student and STA Best Final Year Project for 2024 to two (2) students each from the Faculty of Resource Science and Technology, Universiti Malaysia Sarawak on 6 November 2024 and Faculty of Forestry and Environment, Universiti Putra Malaysia on 2 December 2024.

The BOD deliberated and approved various items pertaining to the human resources, proposed Annual Budget 2025 and administrative matters of the company. The BOD were also updated that since the last BOD meeting in September 2024, the company had conducted two (2) external training courses namely Honorary Wild Life Ranger (Reappointment) and Environmental Compliance Audit, as well as trained 49 forest workmen in various skills sets.

The BOD was also informed on the DF Circular No.1/2024 issued by the Director of Forests mandating all holders of licence, contractors or employers to provide the Certificates awarded by the Training Provider to the workmen who have successfully completed training courses as specified in the First Schedule of The Forests (Trained Workmen) Rules, 2015 for all prescribed forestry activities in order to obtain licence renewal and the Permit to Enter Coupe (PEC) approval starting from 1 June 2025.

# Presentation of STA Prizes at Universiti Malaysia Sarawak

STA Mutual Sdn Bhd (STAM), a subsidiary of STA, has proudly recognised academic excellence since 2005 by presenting STA Prizes to final-year students at the Faculty of Forestry and Environment at Universiti Putra Malaysia, Serdang Campus and the Faculty of Resource Science and Technology at Universiti Malaysia Sarawak (UNIMAS). These prestigious awards are given in two categories: Best Graduating Student and Best Final Year Project Paper.

The Best Graduating Student award comes with a prize of RM1,000, while the winner of the Best Final Year Project Paper receives RM500. Both recipients are honoured with a plaque and a certificate. Selection is made from a list of recommended candidates provided by the respective faculties.

On 6 November 2024, during the 28<sup>th</sup> UNIMAS Convocation Ceremony, a special presentation took place at Dewan Tunku Abdul Rahman Putra to celebrate two exceptional students from UNIMAS. Ms Nur Mahirah Binti Rohaizan was awarded the title of Best Graduating Student, and Mr Malmstein Anak Stendy Jackson received

the Best Final Year Project Paper award for his research titled "Soil Carbon Stock Estimation at Selected Forest Landscape Restoration Site of Gunung Apeng National Park".

During the meeting, the Secretariat briefed members on DF Circular No. 1/2024, which mandates that, effective 1 June 2025, all licence holders, contractors, and employers in the forestry sector must ensure their workmen complete the training courses outlined in the First Schedule of the Forests (Trained Workmen) Rules, 2015. Failure to comply will result in an inability to renew forest licences and/or obtain Permit to Enter Coupe (PEC) approval.

The Secretariat also highlighted the other training opportunities provided by STA Training Sdn Bhd (STAT) besides skills training for forest workmen. Available courses include Environmental Compliance Audit, Environmental Quality Management and Honorary Wildlife Ranger. These courses are claimable under HRD Corp, making them accessible and cost-effective for stakeholders.

The meeting addressed the European Union Deforestation-free Regulation (EUDR), which affects key commodities such as cattle, cocoa, wood, coffee, oil palm, rubber, and soya. Under this regulation, suppliers must certify that their goods are not sourced from forests converted for agricultural use or plantations after 31 December 2020. The regulation will come into effect on 30 December 2025.

Members were updated on the development of an Environment, Social, and Governance Framework, tailored specifically for the Malaysian timber industry. This framework, created by the Malaysia Timber Association in collaboration with Control Union Malaysia, reflects the industry's growing focus on sustainability and responsible governance practices.

Recognising the increasing importance of carbon markets in Sarawak, the members agreed to recommend to Council to establish a Special Committee on Carbon. This committee will focus on addressing emerging opportunities and regulatory requirements related to carbon trading, positioning members to benefit from the expanding carbon market.

**STA Forest Plantation** Committee Meeting No. 4/2024



Meeting in progress

The STA Forest Plantation Committee convened its fourth meeting of 2024 virtually on 18 November 2024 to review the progress of the Batai and Kelampayan projects funded by STA. The discussion focused on evaluating the projects' milestones and ensuring disbursement align with achievements. Emphasis was placed on the ongoing monitoring and evaluation of the research trial plots to ensure their continuity and success.

The Committee also outlined key activities and budget planned for 2025 and received updates on the ongoing studies conducted in collaboration with the Forest Department Sarawak, including the weight-to-volume conversion factor study for planted Gmelina, and the standing tree volume study for industrial forest plantations in Sarawak.

Additionally, the Committee discussed the Malaysian Timber Certification Council (MTCC) Project Appendix 3 Malaysia Working Group, established to provide input for the technical documentation requested by the Programme for the Endorsement of Forest Certification, which will define specific requirements for plantation forests and Trees outside Forests (TOF) established through forest conversion between 2010 and 2020.

# MTCC Project Appendix 3 **Malaysia Working Group Meeting**

The Programme for the Endorsement of Forest Certification (PEFC) Board has directed the PEFC Secretariat and the Sustainable Forest Management (SFM) Working Group to develop complementary technical documentation outlining specific requirements for plantation forests and Trees outside Forests (TOF) established through forest conversion between 2010 and 2020.

In response to this directive, the Malaysian Timber Certification Council (MTCC) established the Malaysia Working Group (MY WG), which convened its inaugural meeting on 12 November 2024 at Menara PGRM, Kuala Lumpur. The meeting was chaired by Dr Farrah Shameen Mohamad Ashray, Chief Executive Officer of MTCC, and attended by representatives from the Forest Department of Peninsular Malaysia, Sabah and Sarawak, Malaysian Timber Industry Board, Malaysian Timber Council, Institute of Tropical Forestry and Forest Products -Universiti Putra Malaysia, as well as various timber industry associations, including STA.

The MY WG was formed to support MTCC's participation in the upcoming PEFC Project Appendix 3 Task Force (PEFC PA3 TF) meeting, scheduled for 20 November 2024. Project Appendix 3 serves as a safeguards framework, addressing the potential revision of the current cut-off date for the PEFC SFM ST 1003 standard from 31 December 2010 to 31 December 2020, in alignment with the European Union Deforestation-free Regulation.

During the meeting, participants developed key insights and recommendations, which will be presented by MTCC at the PEFC PA3 TF meeting.

Majlis Persijilan Kayu Malaysia (MTCC) telah menubuhkan Kumpulan Kerja Malaysia (MY WG) untuk membincangkan semakan Lampiran 3 Projek Program Pengiktirafan Persijilan Hutan (PEFC). Semakan ini mencadangkan perubahan pada tarikh akhir penukaran hutan. Dalam mesyuarat pada 12 November 2024, MY WG telah merangka cadangan yang akan dibentangkan dalam mesyuarat Pasukan Petugas PEFC akan datang, selaras dengan peraturan Bebas Penyahutanan Kesatuan Eropah.

# Forest Department Sarawak Partners with Samling and STA for **Gmelina** Conversion Factor Study

The Forest Department Sarawak (FDS), in collaboration with Samling Reforestation (Bintulu) Sdn Bhd and the STA, has conducted a study to establish a weight-to-volume conversion factor for planted Gmelina in Sarawak.

The study, conducted on 5 November 2024 in Tebanyi, Miri, aimed to assess the relationship between the weight and volume of Gmelina trees and develop a reliable conversion factor. This conversion factor is crucial for ensuring a fair and transparent timber royalty assessment for the species.

During the fieldwork, the research team gathered essential data, including log length, weight, and diameter measurements at various points along the logs. In addition to these field measurements, wood samples were extracted from selected *Gmelina* logs for further laboratory analysis. The samples will undergo tests to determine key wood properties such as density and moisture content. The findings from both the field measurements and laboratory analyses will be combined to create a scientifically reliable weight-to-volume conversion factor for Gmelina, supporting more precise industrial tree plantation management practices and royalty calculations for this species.

Jabatan Hutan Sarawak, Samling Reforestation dan STA telah menjalankan kajian pada 5 November 2024 untuk membangunkan faktor penukaran berat kepada isipadu bagi spesies Gmelina yang ditanam. Data lapangan dan makmal digunakan dalam membangunkan faktor penukaran ini bagi memastikan penilaian royalti kayu yang tepat dan adil dapat diwujudkan untuk spesies tersebut.

砂森林局、三林集团与本会于2024年11月5日开展研究,以制定人工种植 云南石梓的重量与体积转换系数。该转换系数的制定基于实地和实验室的 数据,以确保为该树种建立准确和公平的木材税费评估。

# **Meetings of STA Downstream Categories**

Three (3) downstream categories of STA recently convened their respective category meetings via online platform. During these sessions, members elected their committee members for the 2024 - 2025 terms and discussed various key issues concerning the timber industry in Sarawak.

Topics covered included the Sarawak Government's aspiration to achieve an annual export value of RM8 billion by 2030, as outlined in the Sarawak Post COVID-19 Development Strategy 2030. Other subjects included the utilisation of biomass products from timber and bamboo to increase the value added downstream processing activities, incentive provided under automation and mechanism initiatives, as well as nationwide timber product certification schemes set to be introduced. The respective categories also deliberated and resolved to actively participate in the stakeholders' engagement lab organised by the Sarawak Timber Industry Development Corporation to develop a blueprint for SMEs in the furniture-making industry as well as study trip to Peninsular Malaysia in December 2024.

Ahli-ahli turut membincangkan penggunaan biojisim, insentif automasi, pensijilan produk kayu serta bersetuju untuk menyertai makmal pelan tindakan Perusahaan Kecil dan Sederhana perabot STIDC dan lawatan kajian ke Semenanjung Malaysia pada Disember 2024.

本会的三个下游小组近日举行线上会议, 以选出 2024至2025年度的委员会,并讨论砂拉越力争在 2030年前实现80亿令吉出口目标、生物质利用、 自动化激励措施以及木材产品认证等议题。会员还 一致同意参加由砂拉越木材工业发展机构(STIDC) 主办的家具中小企业蓝图工作坊,并计划于2024 年12月前往马来西亚半岛进行实地考察。

# **Technical Workshop and Training on Biodiversity Observation for Land and Ecosystem Health (BOLEH)**

STA, in collaboration with the Forest Department Sarawak (FDS), successfully organised the Technical Workshop and Training on Biodiversity Observation for Land and Ecosystem Health (BOLEH) from 21 to 24 November 2024. The workshop and training was conducted by a team of researchers from Japan's National Institute for Environmental Studies (NIES) and Kyoto University, namely Dr. Ryuichi Takeshige, Dr. Yayoi Takeuchi, and Dr. Ryota Aoyagi, led by Professor Kanehiro Kitayama. The technical workshop was held at Nu Hotel, Bintulu, followed by training at the Anap Muput Forest Management Unit (FMU).

In her welcoming remarks at the Technical Workshop, Ms Annie Ting, Chief Executive Officer of STA acknowledged the participation of STA Council Members and high-level management at the Workshop, emphasising their commitment to adopting innovative methodologies like BOLEH. She expressed her gratitude to the FDS and the team of researchers for their dedicated efforts.

Representing the Director of Forests Sarawak, Datu Haji Hamden bin Haji Mohammad, Madam Runi anak Sylvester Pungga, Head of the Research & Development Division at FDS highlighted the workshop's significance. She framed it as a milestone under the Memorandum of Agreement signed between the FDS and NIES last year, underscoring their shared commitment to science-based forest management strategies. She also underscored the alignment of BOLEH with

global initiatives like Reducing Emission from Deforestation and Forest Degradation (REDD+) and forest certification systems.

Professor Kanehiro introduced the BOLEH methodology, explaining its focus on assessing the impacts of forest management on biodiversity and carbon storage in tropical production forests. Drawing on lessons from its application in Deramakot FMU, Sabah, he demonstrated how reduced-impact logging practices enhanced ecosystem services by maintaining biodiversity and carbon storage compared to conventional logging methods.

The methodology utilises "forest intactness" as a cost-effective indicator, comparing tree species compositions in managed forests to pristine baselines. Supporting tools such as stratum maps, generated using Google Earth Engine was also demonstrated and participants also received copies of the BOLEH manual for future reference.

The versatility of BOLEH as a compliance verifier was also highlighted, particularly for the Malaysian Criteria and Indicators (MC&I) for Sustainable Forest Management and the Forest Stewardship Council's Ecosystem Service Certification.

On the second day, about 20 representatives from STA member companies, including surveyors, forest managers and SFM coordinators

embarked to Anap Muput FMU for hands-on training. They were trained in the establishment of circular plots for biodiversity assessments and the classification of forests into five (5) classes, ranging from Class 1 (intact forest) to Class 5 (forest with few pioneer trees with large open areas). Once the plot has been established and classified, trees within the plot with a diameter at breast height of 10cm and more were measured and identified.

The training concluded with participants reflecting on the practical and theoretical knowledge gained from the training and their hope for more focused training in data analysis. mapping and GIS. FDS assured participants that plan for more capacity building in these area are already in progress for the coming

# Presentation of Financial Contributions from STA Mutual Sdn Bhd to Underprivileged Schools Across Sarawak

STA Mutual Sdn Bhd (STAM), in collaboration with the Sarawak Timber Industry Development Corporation (STIDC), continued its initiative to support underprivileged schools Sarawak. The 2024 financial contributions were presented at a series of ceremonies throughout Sarawak, beginning with the Central Region on 1 November 2024 at RH Hotel, Sibu, followed the Northern Region at Meritz Hotel, Miri on 22 November 2024, and concluding in the Southern Region at Wisma Sumber Alam, Kuching on 29 November 2024.

Since its start in 2012, this initiative has seen STAM provide funding, while STIDC has handled the distribution of the funds to schools in need. The goal has always been to offer practical support to schools in underserved areas, helping ensure that students have access to essential educational resources.

With the assistance of the District Education Offices, a total of 158 underprivileged schools across Sarawak were identified. These schools, classified as scale 7 (underprivileged), received a total of RM182,000 in financial assistance. The funds will be used to support the needs of 134 primary schools and 24 secondary schools.

Representatives from the District Education Offices were present at each ceremony to receive the contributions on behalf of the respective schools. The funds will help these schools address their basic educational needs, such as improving infrastructure, acquiring classroom resources, and supporting extracurricular activities.

# Technical Working Group for Forest Carbon Offset

Members of the Technical Working Group (TWG) for Forest Carbon Offset (FCO) convened its second meeting at Tamu Hotel, Kuala Lumpur from 4 to 5 November 2024. The meeting was called by Malaysia Forest Fund (MFF), the agency tasked by the Ministry of Natural Resources and Environmental Sustainability to spearhead the development of FCO as Malaysia's own national crediting system.

Madam Suhaini Haron, MFF's Senior Director (Corporate Development & Strategy) welcomed the 52 TWG members who attended in person and online and acknowledged their contributions of over 300 feedbacks on the draft guideline for FCO. These guidelines were prepared by MFF following comparative analysis of carbon crediting system used in other countries, which showcased the diverse approaches taken by countries to highlight their unique strategy in emissions reduction. She emphasised that MFF is committed to localising these insights within Malaysia's FCO framework and providing a localised alternative to international standards such as Verified Carbon Standard and Gold Standard, potentially reducing costs for developers in Malaysia.

Over the 2-day TWG meeting, representatives from STA, alongside experts from government agencies, the private sector, civil society, NGOs, and academia, worked together to review each chapter, ensuring that local context and Malaysian perspectives were effectively integrated.

Discussions within the TWG centred on striking a balance between practical implementation and the ambition to establish a credible, nationally recognised system for FCOs. Most of the TWG members advocated for the FCO to be formalised as a standard to meet market trust and certification

requirements. They also highlighted the importance of having an accredited and verified process, given that carbon credits are recognised as financial instruments, and that such measures would be crucial for building market credibility both domestically and internationally.

MFF informed that the subsidiary guidelines would be shared with TWG members in December for review and feedback, with a follow-up meeting scheduled for January 2025 to consolidate the input received.

# Visit to Terengganu Forestry Training Centre

The Forest Department Sarawak (FDS) and its appointed training provider, STA Training Sdn Bhd (STAT) visited the Terengganu Forestry Training Centre (TFTC) on 28 November 2024. The visit aimed to understand the training courses provided by the TFTC and to explore potential collaboration opportunities between STAT and TFTC. The delegation from FDS was led by Madam Judy George Wan, Head of Corporate & Service Modernisation Unit of FDS, while the delegation from STAT was led by its Manager, Ms Annie Ting.

Mr Mohd Tarmizi bin Ahmad, Principal of the TFTC welcomed the delegation and introduced the TFTC. The TFTC was established in 1973 with objectives to provide skills training in forestry sector for forest workers in Peninsular Malaysia, to produce competent forest workers, and to impart forest workers with knowledge on occupational safety and health (OSH), sustainable production and environment conservation. Amongst the training courses conducted by TFTC are directional tree felling, chainsaw maintenance, operating heavy wheel and track machinery and forest inventory. Certificate of Competency with five (5) years validity are issued to forest workers that are found to be competent in respective training courses.

Mr Wong How Chu, Assistant Manager of STAT presented the background and training courses conducted by STAT in Sarawak. As an appointed training provider by FDS, STAT conducts skills training in forestry sector as prescribed under the Section 51(1) of the Forests Ordinance 2015, with objectives to impart forest workmen with both practical skill and knowledge on OSH, environmental compliance, wildlife conservation and sustainable forest management. Besides that,

STAT is also supporting implementation of the *Natural* Resources and Environment (Audit) Rules, 2008 enforced by the Natural Resources and Environment Board (NREB) through the conduct of environmental compliance audit and environmental quality monitoring

During the visit, both TFTC and STAT also shared experiences in conducting training courses, including registration with the Human Resource Development (HRD) Corporation for offering HRD claimable courses and enhancement of training participation from industry. STAT registered its interest to participate in the log extraction using modified excavator and forest surveyor courses conducted by TFTC.

# **Conservation Workshop on Critically Endangered Trees in Malaysia**

From 11 to 15 November 2024, Botanical Gardens Conservation International (BGCI), in collaboration with the Sabah Forestry Department (SFD), organised the Workshop on Conservation Planning for the Critically Endangered Trees of Malaysia at the Rainforest Discovery Centre in Sepilok, Sabah. The workshop was made possible with funding from Fondation Franklinia and facilitation by the **IUCN SSC Conservation Planning Specialist** Group.

With support from the Ministry of Natural Resources and Environmental Sustainability of Malaysia, the event gathered 50 participants from more than 25 institutions, spanning government agencies, non-governmental organisations, universities, and associations from across Peninsular Malaysia, Sabah, and Sarawak including STA.

Datuk Frederick Kugan, Chief Conservator of Forests, in his opening speech delivered by Dr Arthur Chung, Deputy Chief Conservator of Forests (Research and Development) emphasised the significance of ongoing conservation efforts throughout Malaysia. He noted that the Sabah Government is committed to protecting 30% of its landmass as Totally Protected Areas by 2025 and highlighted the importance of the conservation action plan developed during the workshop, to serve as a comprehensive framework for guiding future conservation efforts. Dr. Chung pointed out that a multispecies approach to conservation is crucial, as it enables a more coordinated

and impactful response to the challenges facing Malaysia's threatened tree species.

The workshop's five-day agenda, led by BGCI Officer Conservation Ms Yvette Harveydesigned Brown, was to foster collaborative development of

integrated conservation plan for the country's endangered tree species. By bringing together a broad range of stakeholders, the workshop pooled expertise and resources to address key threats, establish effective strategies, and identify actionable steps to improve the future status of critically endangered tree species in Malaysia.

In addition to the workshop sessions, participants were given the opportunity to visit key conservation sites, including the Sepilok Orangutan Rehabilitation Centre, the Bornean Sun Bear Conservation Centre, and the Forest Research Centre's research facilities. These visits provided valuable insight into ongoing conservation efforts in the region and underscored the importance of on-the-ground action in complementing strategic planning.

The outcomes of this collaborative workshop will serve as an essential resource for scaling up conservation efforts for Malaysia's critically endangered tree species, helping to ensure a more sustainable future for these vital components of the country's rich biodiversity.

In conjunction with the 2024 National Integrity Month celebration, Forest Department Sarawak (FDS) celebrated the FDS Integrity Day 2024, with the theme "Integrity in Forest Management: Our Forest, Our Responsibility" at Penview Convention Centre on 6 November 2024.

The FDS Integrity Day 2024 event was officiated by Datu Hii Chang Kee, Deputy State Secretary of Sarawak (Operations) in the presence of other dignitaries namely Hajah Hairani binti Mohamad Ismail, Acting Permanent Secretary of the Ministry of Natural Resources and Urban Development, Haji Happysupina bin Sait, Deputy Director of Forest (Forest Conservation and Development), Mr Semilan anak Ripot, Deputy Director of Forest (Forest Development); and Mr Wan Hipni bin Wan Mohamad, Chief Assistant Director of the Sarawak Integrity and Ombudsman Unit. The event was also attended by staff from FDS, STA and representatives from forest licence holders.

The event featured speakers from the Malaysian Anti-Corruption Commission (MACC) Sarawak Branch, the National Anti-Drug Agency (AADK) Sarawak Branch, and the Human Resources Management and Development Unit of the Sarawak Premier Department. Exhibition booths were also set up by the MACC Sarawak Branch, AADK Sarawak Branch, alongside FDS' Prevention & Enforcement Division, and Technology & Geospatial Division.

Eight (8) representatives from forest licences i.e Samling Group, Shin Yang Group, Ta Ann Holding Bhd, Jaya Tiasa Holding Sdn Bhd, WTK Holding Sdn Bhd, Agriteck Sdn Bhd, Yiihin Resources Sdn Bhd, and Focus Titanium Sdn Bhd signed the anti-corruption commitment which is the FDS's Corporate Integrity Pledge.

# Launch of the Asian Grey Timber Analysis

The U.S. Agency for International Development (USAID) Bureau for Asia officially launched the Asian Grey Timber Analysis (AGTA) Report in a webinar on 21 November 2024.

The event, attended by about 55 participants from around the world, heard from Mr Kauri Sparff, the lead analyst and principal author of the AGTA Report. The comprehensive study examines intraregional timber trade across ten (10) Asia-Pacfic countries including Indonesia, Vietnam, Papua New Guinea, Laos, Thailand, Solomon Islands, Philippines, Myammar, Malaysia and Cambodia, focusing on the years 2021 and 2022. Its key objectivs include updating data on the scale and complexity of illegal and grey timber flows, identifying strategic interventions to improve forest governance, and offering actionable recommendations to enhance the region's legality and sustainability in forest product supply chains.

Mr Sparff shared that illegal timber trade results in significant global financial losses, estimated at US\$6 to 9 billion annually. In 2022 alone, Indo-Pacific countries exported approximately US\$18 billion worth of primary wood products. He also addressed challenges in the Asia-Pacific timber trade, such as discrepancies in definitions, conflicting legal frameworks, and inconsistent data quality and availability.

The webinar not only served as a platform to disseminate the report's findings but also fostered dialogue and collaboration among stakeholders to strengthen forest governance across the region. USAID informed that the AGTA report is currently in its final stages of editing and will be available soon

# Engagement Session on the Gig Workers Act 2024: Strengthening Protections for Malaysia's Growing Gig Economy

The Labour Department Sarawak organised an engagement session between the Ministry of Human Resources (KESUMA) with stakeholders and industry players to discuss the Gig Workers Act 2024 Draft on 11 November 2024 at Raia Hotel & Convention Centre, Kuching.

In his welcoming speech, Mr Awang Raduan bin Awang Omar, Director of the Labour Department Sarawak, acknowledged the rapid growth of the gig economy and its ability to offer flexibility and new opportunities for workers and businesses alike. However, he highlighted that gig workers often face a lack of essential protections, such as job security and benefits, which can jeopardise the financial stability and well-being. In response to these challenges, KESUMA has drafted the Gig Workers Act 2024, which aims to safeguard the welfare of gig workers in Malaysia. The Act is expected to be tabled in the Parliament by December 2024.

Dato' Hajah Norison binti Ramli, Deputy Secretary General (Policy & International) of KESUMA outlined the key objectives of the Gig Workers Act 2024 in her presentation. The draft legislation seeks to clarify the definition of gig workers, establish minimum wage standards, provide protections such as insurance, and introduce mechanisms for resolving grievances. These measures are designed to ensure that the rights of gig workers are protected in the rapidly evolving gig economy.

One of the major initiatives highlighted by Dato' Hajah Norison is the enforcement of Social Security Organisation (SOCSO) contributions for gig workers, under the Self-Employment Social Security Act 2017. The Self-Employment Social Scheme (SESS), which

covers medical and disability benefits, has been expanded to include gig workers in sectors such as goods and food delivery. This scheme provides crucial protections, including medical benefits, disability coverage and funeral benefits in the event of work-related accidents. While the scheme is partly subsidised by the Government, there are plans to reduce the subsidy from 90% to 70% under the new legislation.

The session also featured a discussion among stakeholders and industry players. Key topics included the need for clearer legal protections for gig workers, the importance of collaboration between unions, employers and policymakers and the proactive registration of gig workers with SOCSO. These discussions are essential in shaping the future of gig workers and ensuring their inclusion in Malaysia's growing gig economy. Similar engagement sessions were held in Peninsular Malaysia and Sabah.

# Seminar on Engineered Wood Product 2024

The Seminar on Engineered Wood Products 2024, themed "Timber Structure – Potentials and Perspectives", was held on 27 November 2024, at the Grand Margherita Hotel in Kuching. Organised by the Sarawak Timber Industry Development Corporation (STIDC), the event brought together industry leaders, experts, and stakeholders to explore the transformative potential of mass engineered timber in advancing sustainable building construction practices.

In his welcoming address, Haji Zainal Abidin bin Haji Abdullah, General Manager of STIDC emphasised the seminar's goal of raising awareness about the legal and regulatory frameworks governing timber design and construction at both local and international levels. He stressed the importance of aligning Sarawak's timber practices with global standards to ensure safety, quality, and environmental sustainability. Highlighting STIDC's commitment to eco-friendly initiatives, such as tree planting and bamboo industry support, he also shared the use of Belian glulam in the renovation of STIDC's office as an example of how engineered wood can address environmental challenges.

A total of six (6) papers were presented by local and international experts during the seminar, offering valuable insights into various aspects of sustainable timber. Topics included Sarawak's sustainable timber resources, mass engineered timber buildings across Asia, fire resistance in timber construction, and compliance with the Sarawak Building Ordinance 1994 and Eurocode 5 for timber building design and construction. In addition, the usage of bamboo materials in construction was also highlighted in the seminar.

Closing the seminar, Datuk Haji Len Talif Salleh, Deputy Minister for Urban Planning, Land Administration and Environment, underscored the vital role of engineered wood in Sarawak's economic, environmental, and social progress. He highlighted its ability to generate jobs, attract investments, and boost local businesses, particularly in rural areas, while fostering social inclusion and improving livelihoods. Environmentally, engineered wood provides a renewable alternative to materials like steel and concrete, significantly

reducing carbon emissions and conserving natural resources. Its use, he explained, helps combat climate change by storing carbon and reducing reliance on non-renewable materials.

Datuk Len also noted Sarawak's efforts to meet international timber export standards, particularly in structural requirements, through collaboration with research groups and adoption of innovative practices. This transition reflects a commitment to sustainable forestry, resource efficiency, and circular economy principles, ensuring the long-term viability of Sarawak's timber industry. He outlined the state's ambition to establish itself as a global leader in sustainable timber building materials through innovation, strategic partnerships, and adherence to international standards.

As part of the event, STIDC launched its upgraded Timber Portal, offering easy access to resources and updates on the timber industry. Furthermore, the Blueprint for Engineered Wood Products Industry in Sarawak developed by STIDC was also unveiled during the seminar.

# **Engagement Session on the Proposed Amendments to Environmental Quality (Clean Air) Regulations 2014**

The Department of Environment (DoE) organised an engagement session with stakeholders on 29 November 2024 to discuss the proposed amendments to the Environmental Quality (Clean Air) Regulations 2014 (CAR 2014). The session was held at the Environment Institute of Malaysia, Universiti Kebangsaan Malaysia Campus, Bangi Selangor.

In his welcoming remark, Haji Shafe'ee bin Yasin, Deputy Director General (Development) of DoE highlighted that CAR 2014, which came into effect on 5 June 2014, was designed to regulate pollutant emissions by mandating the installation and performance monitoring of Air Pollution Control System (APCS). In 2019, industries that did not manage to improve their APCS were allowed to apply contravention licence to ensure they comply with CAR 2014.

However, despite these measures to address compliance challenges, he noted that the air pollution violation by industries remain prevalent. As a result, the Ministry of Natural Resources and Environmental Sustainability has proposed amendments to CAR 2014. These amendments aim to introduce an *Environment Charge*, which will complement existing regulations and is expected to be tabled at the next Cabinet meeting for implementation in 2025.

The proposed changes focused on Regulation 25 (Licence Required to Contravene Acceptable Conditions for Emitting Emissions into the Atmosphere) and Regulation 27 (Fees).

#### Key amendments include:

- i. Empowering the Director General to reject the Contravention Licence applications.
- ii. Revising the contravention license fee, currently set at RM1,000 per application per annum, to include an additional *Environment Charge* as specified in the 7<sup>th</sup> Schedule of CAR 2014.

To support compliance, the DoE will provide a spreadsheet calculator and detailed guidelines for calculating the *Environment Charge*. These resources will be made available on the DoE's website once the amendments are gazetted. Additionally, it was emphasised that all fees, including the *Environment Charge*, will not be eligible for discounts. The DoE reiterated its expectation for industries to comply with the revised Regulations and remain committed to improving their APCS.

# STIDC Industry Updates on

### Potential of Biomass Utilisation for Value-Added Products

The Sarawak Timber Industry Development Corporation (STIDC) hosted an industry update on the potential of biomass utilisation for valueadded products on 6 November 2024 at the Promenade Hotel in Bintulu. The event was attended by approximately 80 participants from the timber industry, higher education institution and government agencies.

In his keynote address, Haji Zainal Abidin bin Haji Abdullah, General Manager of STIDC emphasised Sarawak's vast potential in utilising oil palm by-products, agricultural residues and wood waste as sustainable alternatives to fossil fuels. He stressed the need for a robust framework to support biomass research, which he identified as a key driver for expanding Sarawak's renewable energy market.

He also highlighted findings from a collaborative research between STIDC and the Forest Research Institute of Malaysia (FRIM). The research revealed that Sarawak's biomass possesses excellent properties for producing energy pellets, with further enhancements achievable through advanced processing techniques.

The event featured the presentation of four (4) papers by distinguished speakers from FRIM. These presentations offered valuable insights, sharing ideas, knowledge and best practices with industry players, local communities and academia. They also explored strategies to overcome challenges and outlined a path forward for the development of Sarawak's biomass industry.

In his closing remarks, Haji Zainal urged industry players to take advantage of the opportunities in the biomass sector, emphasising its potential to drive economic growth while contributing to global sustainability efforts. He reaffirmed the importance of reducing environmental impact and addressing climate change through innovative and eco-friendly

# **Engagement Session with Malaysia Productivity Corporation**

The Malaysia Productivity Corporation (MPC) hosted an online engagement session on 12 November 2024 as part of its follow-up to the Industry Continuous Professional Development Series 5 outreach initiative, held in October 2024. The session focused on fostering collaboration and exploring synergies to enhance national productivity and talent development, with the goal of shaping effective policies and programmes that address the evolving needs of industries.

A key focus of the discussion was the governmentfunded Academy in Industry (Akademi dalam Industri, or Adi) initiative, which is designed to upskill local talent within the timber industry. The session highlighted key challenges, including the ongoing shortage of skilled workers and the industry's heavy reliance on foreign workers, issues that have become more pronounced in the post-COVID era.

The Adi initiative offers professional certification pathways through the Malaysian Skills Certificate and diploma programmes, providing structured training to strengthen workforce resilience. The programme adopts a blended approach, with 80% on-the-job training and 20% theoretical training, and is fully funded by the government.

Companies participating in the programme can enrol both new hires and existing employees without certifications, with financial incentives ranging from RM1,500 to RM2,000 per participant. Beyond skill development, the initiative is also aimed at boosting workforce retention and improving productivity within the timber sector. The engagement session underscored the importance of such initiatives in addressing the pressing needs of the industry and fostering a more sustainable and competitive workforce for the future.

In his opening remarks, Mr Elaiyaraj Retnam, Vice President of the HRD Corp's Training Department, highlighted that this session was part of a nationwide initiative aimed at gathering insights from industry leaders and employers. The goal is to better understand the needs of Sarawak's workforce and shape Malaysia's future workforce development. He emphasised that the insights gathered would play a crucial role in informing policy decisions and guiding the implementation of future initiatives.

The session was led by certified trainers, Ms Kathleen M. Fernandaz and Ms Bawani Periasamy, who facilitated collaborative discussions with trainers, training providers, and employers. The focus was on shaping Sarawak's learning landscape over the next two (2) years by addressing key concerns. setting goals, and aligning training programmes with the evolving workforce needs. Participants also engaged in group discussions, sharing valuable insights and providing feedback to support the development of workforce initiatives in the region.

The event was officiated by Dato Sri Dr Stephen Rundi anak Utom, Minister for Food Industry, Commodity



& Regional Development Sarawak. The newly launched book outlines comprehensive import conditions for compliance by importers with the primary aim to safeguard Sarawak's plant biosecurity and agricultural integrity.

compliance with agricultural guidelines and foster sustainable practices, ultimately enhancing Sarawak's agriculture sector and economy.

Prior to the engagement session with importers and exporters of plant / plant products, Mr Paddy Jiob, Assistant Agriculture Officer from the Plant Biosecurity and Quarantine Division (PBQD), DoA highlighted the critical activities of Sarawak's plant biosecurity programme. These efforts aim to prevent and manage the introduction, establishment, and spread of harmful plant pests such as insects, fungi, bacteria, viruses, nematodes and invasive weeds. Such measures are essential to protect the environment, economy, and human health. He also emphasised PBQD's role in facilitating the export of plant materials and agricultural produce, ensuring compliance with the guarantine and phytosanitary requirements of importing countries.

The engagement session, moderated by Ts Hajah Asmah binti Salowi, Senior Assistant Director (Research Officer) of PBQD provided a platform for stakeholders, government agencies and industry players to enhance their understanding of the latest import and export requirements for plants and plant products in Sarawak. Key topics discussed included food security and safety, compliance with regulations, capacity building to develop technical expertise and enforcement efforts at immigration checkpoints.

The engagement session concluded with an informative session led by the Crop Research and Development Division of DoA, focusing on pest surveillance of durian and coconut in Sarawak.

# Fostering a Resilient Economy through Inclusive Growth

On 13 November 2024, PricewaterhouseCoopers (PwC) Malaysia hosted a seminar at the Borneo Culture Museum Auditorium, Kuching offering detailed insights into the 2025 Budget's key tax proposals, Malaysia's tax audit and investigation trends, workforce considerations, and sustainability reporting frameworks.

PwC's Tax Partner, Mr Keegan Ong and Tax Director, Ms Cynthia Ng, outlined major tax proposals for Budget 2025. Key measures discussed included the implementation of dividend tax, extended personal income tax reliefs, and the adoption of a stamp duty self-assessment system. They also addressed capital gains tax policies targeting corporate-level transactions and updated corporate tax incentives designed to enhance economic competitiveness.

Mr Chris Tay, Director and Mr Gabriel Chan, Senior Manager of PwC's Tax Dispute Resolution, explored Malaysia's evolving tax

audit and investigation landscape. They illustrated current practices of the Inland Revenue Board Malaysia through actual case studies; shedding light on the authority's increasing focus on compliance and emerging enforcement trends.

Ms Lee Shuk Yee, Workforce Director of PwC discussed strategies for navigating the future of work, including rethinking reward systems and preparing for the operational impact of e-invoicing. She also introduced "Work Smartly", PwC's integrated human resource management platform. This tool aims to streamline compliance, bolster

data security and provide flexible solutions tailored to dynamic business needs.

Ms Farhana Jabir, Director of Sustainability & Climate Change at PwC provided practical guidance on preparing sustainability reports aligned with the National Sustainability Reporting Framework. She emphasised compliance with the International Financial Reporting Standard (IFRS) Sustainability Disclosure Standards, positioning businesses for long-term accountability and transparency.

In a session led by Mr Richard Baker, Director of Sustainability & Climate Change at PwC, participants gained a clearer understanding of the Carbon Boarder Adjustment Mechanism, carbon tax introduction, and the suite of Environmental, Social & Governance incentives available. These include the Green Investment Tax Allowance, Energy Audit Conditional Grant and access to preferential green financing options.

The Seminar provided participants with actionable insights into the implications of Budget 2025 and emerging trends in tax, workforce and sustainability, equipping them to navigate the challenges ahead with confidence.

# **Community Tree Farming and Industrial Tree Plantation**

The Malaysian Timber Council (MTC) organised a two-day lab session on the "Framework for Community Tree Farming (CTF) and Industrial Tree Plantation (ITP)" from 28 to 29 November 2024 at Le Méridien Hotel, Putrajaya. The event brought together approximately 60 participants, including representatives from government agencies, associations, and timber industry stakeholders from Peninsular Malaysia, Sabah, and Sarawak.

The session aimed to develop a detailed and actionable guideline for stakeholders such as planters, suppliers, manufacturers, local communities, and government agencies to enhance the planning, implementation and management of CTF and ITP projects in Malaysia. Additionally, the lab also sought to strengthen Malaysia's timber industry while promoting sustainability and inclusivity.

The session began with insightful presentations by industry experts. Mr Rahman Khan, Chief Executive Officer and Executive Director of Jawala Plantation Industries Sdn Bhd, provided insights into the current status, challenges, and opportunities in forest plantations. Mr Kevin Pang

from the Sabah Forestry Department discussed strategies to promote tree planting among smallholders and local communities as a vital source of timber for the industry.

Participants were then divided into three (3) groups to delve deeper into critical topics, namely policy, financing and silviculture practices. These discussions provided a platform for stakeholders to share expertise, explore solutions and propose actionable strategies to strengthen the CTF and ITP framework at the national level, ensuring a sustainable and inclusive approach to timber production in Malaysia.








#### EXPORT VALUE OF MEDIUM DENSITY FIBREBOARD BY DESTINATION FROM SARAWAK










# EXPORT VALUE OF DOOR PANELS & FRAME BY DESTINATION FROM SARAWAK













Under Section 51 of the Forests Ordinance 2015, forest workmen are required to receive training from a training provider and demonstrate their competence through assessment. STA Training Sdn Bhd (STAT) is the appointed training provider by Forest Department Sarawak to provide skills training for the five (5) prescribed forestry activities (PFAs) as listed in Schedule 1 The Forests (Trained Workmen) Rules, 2015.
