Members: Law Hui Chau Salfa Kamazura A Workshop on Kelampayan Tree Improvement was organised by Sarawak Forestry Corporation (SFC) in collaboration with Sarawak Timber Association (STA) on 19 September 2011 at Level 12, Wisma STA. The workshop successfully convened with over 50 participants from the timber industry, licensed planted forest operators as well as staff of SFC and STA.

The objectives of the Workshop were aimed to (i) impart the concept and knowledge in tree breeding to all participants, (ii) gather feedbacks from the discussion on problems faced and also (iii) formulate a future tree improvement programme for the State.

SFC's CEO and Managing Director, Datu Len Talif Salleh quoted the FAO World Bank Development report where the global demand for wood products was projected to increase from 3.5 billion m3 in 1990 to 6.4 billion m³ in 2020. He added that the demand on environmental services of the forest is also projected to increased whereby more natural forests would be excluded from wood production. The increasing wood demand was also highly driven by the recent advancement in converting biomass (wood chips and pallets) to bioenery, he said in the text of his speech read out by SFC Applied Forest Science and Industry Development (AFSID) Division Acting Deputy General Manager, Ms Lucy Chong.

Datu Len said that Sarawak has been establishing planted forest through smart partnership with private sector in realizing the state's aspiration to plant one million hectares of planted forest by 2020.

Did you also know that....

The first delivery of PEFC-certified timber products from Malaysia arrived in Germany in April 2011. Between then and August 2011, more than 535 m³ of goods, including Dark Red Meranti scantling and sawn timber, have arrived and are available at large tropical wood importers, such as Holz-Henkel, Kurz and Adolf Münchiger Holz-Import-Export. Further deliveries are expected in the coming months. Experts are estimating a significant demand for PEFC-certified window scantling.

This is to ensure sustainable supply of raw materials for local processing as well as to mitigate over dependency on raw materials from natural forests. He added that without access to good genetic stock, there is no possibility to optimize timber production, regardless of the quality of subsequent silvicultural management.

The workshop was divided into two sessions in which Session 1 focused on the current status of tree improvement Programme. Six papers were presented in this session. The papers presented were:

- 1. Introduction to Tree Improvement by *Dr Sim*Soon Liang, Fellow of Academic of Science
 Malaysia
- 2. Seed Production Area by *Ms Sabrina Aslan Joe*, *SFC*
- 3. Provenance Trial by Ms Evelyn Jugi

- 4. Silviculture Practices by *Ms Rohanie Bohan, SFC*
- 5. Pest Management by Encik Marfaizal Marzuki, SFC
- 6. Biotechnology Approach by *Dr Pang Shek Ling, SFC*

The second session focused on future improvement Programme where participants were divided into 5 groups to discuss current problems in planting of Kelampayan which would enable SFC to formulate the future tree improvement programme and its directions in research and development.

In his closing remarks, Mr Peter Ling Kwong Hung, STA Forest Plantation Category Chairman urged all members of STA Forest Plantation members to work closely with SFC as the 1.3 million hectares of forest plantations were expected to provide about 10 to 15 million m³ of wood for the timber industry by the year 2020.

Workshop on Development of the Guidelines for the Implementation of the Natural Resources and Environment (Audit) Rules, 2008

The needs for Environmental Audit is provided under Section 5 (o) of the Natural Resources and Environment Ordinance, 1993 which states that the functions and power of the Board shall be to direct any body or person to carry out environmental audit of any prescribed activity undertaken by him and provide a report to the Board. However, this Section neither provide a detailed mechanism to appoint auditors nor does it provide procedures for audit report evaluation, etc. Therefore, the Natural Resources and Environment (Audit) Rules, 2008 has been gazetted on 31st December 2008 to take the above provisions into account.

The Natural Resources and Environment Board (NREB) organised a Workshop on Development of the Guidelines for the Implementation of the Natural Resources and Environment (Audit) Rules, 2008 on 26 – 27 September 2011 in Grand Margherita Hotel, Kuching.

The objectives of the Workshop are to seek inputs and comments in order to finalise the draft Guidelines for Environmental Audit in Sarawak and Guideline for Registration of Environmental Auditors

in Sarawak; and to set-up the system and procedures required to implement and enforce the Natural Resources and Environment (Audit) Rules 2008.

The two-day Workshop was facilitated by Ir. Dr. Chong Hock Guan, CEO and principal of GMP Environmental Consultants and was attended by participants from the environment consultants, academicians, timber industry and officers from NREB.

The Workshop was divided into 4 sessions. The first session was to fine-tune the draft Guidelines for Environmental Audit in Sarawak. The main intent of this Guidelines is to provide explanations and clarifications to all the requirements mentioned in the Rules. The second session was to fine-tune the draft Guidelines for Registration of Environmental Auditors in Sarawak where this should be a good tool for applicants of environmental auditors in Sarawak and officers of NREB Sarawak in registering and administering the environmental audit and auditors to use. The third and fourth sessions were focus on the audit tools and documents for officers of NREB to use.
